Program Description

Overview

The purpose of the National Institute of Justice (NIJ) Research, Evaluation, and Development Project Grants program is to encourage and support research, development, and evaluation to improve criminal justice policy and practice in the United States. With this solicitation, NIJ seeks proposals to identify and assess the highest priority needs of criminal justice communities in order to enhance innovative criminal justice research and inform practitioners, policymakers, industry providers, federal agencies, as well as NIJ, of those needs and their potential solutions. Innovation also comes from within these criminal justice agencies, therefore NIJ is looking to continue supporting programs like Law Enforcement Advancing Data and Science (LEADS), an NIJ program designed to increase the in-house research capabilities of law enforcement officers and agencies.

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); the Homeland Security Act of 2002 (sections 231-233, 235); and 28 U.S.C. 530C.

Specific Information

The competitive FY2018 NIJ solicitation: Criminal Justice Requirements and Resources Consortium, under which this award was originally made, sought applications for funding for two distinct but complementary activities: 1.) identifying and assessing the highest priority needs of criminal justice communities (i.e., law enforcement, courts, and corrections), along with potential solutions to those needs; and 2.) the administration of activities that encourage practitioner-led research and evaluation that will improve criminal justice policy and practice, and will support the professional development of research-minded practitioners such as the Law Enforcement Advancing Data and Science (LEADS) programs.

Goals, Objectives, Deliverables, and Timeline

The goal of this solicitation is to continue to provide support for these activities. The consortium's activities will be developed collaboratively between the applicant and NIJ, with substantial involvement by NIJ.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Content of Application Submission.

Proposal Narrative

The proposal narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point Times New Roman font; have no less than 1-inch margins; and should not exceed 30 pages. Pages should be numbered and submitted as an attachment. If the proposal narrative fails to comply with these length restrictions, NIJ may negatively consider such noncompliance in final award decisions.

a. Description of the Issue OR Statement of the problem if research is involved

Describe why this project/ these proposed activities are necessary (significance/value) and/or address a need and include supporting information.

b. Project Design and Implementation

Describe the strategy to address the needs identified in the Description of the Issue/Statement of the Problem. List the proposed program activities and describe how they relate to the stated objectives. Activities are the specific actions to be undertaken to fulfill the program objectives and reach the program goal(s). Provide a detailed description of the method(s) to be used to carry out each activity. Provide a timetable indicating roughly when activities or program milestones are to be accomplished.

c. Capabilities and Competencies

Describe the capabilities and competencies to accomplish the goals and objectives of the project.

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the impact of the project. Describe the process to accurately report data.

Note: applicants are **not** required to submit performance data with the application. Rather, performance measures information is included as an alert that successful applicants will be required to submit performance data as part of the reporting requirements under an award.
