#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), National Institute of Justice (<u>NIJ</u>), seeking applications to design and test models to expedite judicial review for individuals awaiting revocation of their parole or probation for technical violations of their supervision. This project furthers the Department's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States.

This solicitation incorporates the <u>OJP Grant Application Resource Guide</u> by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications for funding to OJP. Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

To advance Executive Order 13929 Safe Policing for Safe Communities, as of October 28, 2020, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be allocated FY 2021 DOJ discretionary grant funding, as either a recipient or a subrecipient. All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

## **Program Description**

## Overview

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ requests proposals from accredited academic institutions to design and test models to expedite judicial review for individuals awaiting revocation of their parole or probation for technical violations of their supervision, while linking them to evidence-based services that address the root causes of recidivism. Applications from other than accredited academic institutions will not be accepted.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a strong letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through this project will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review the NACJD's policies and protections at (NACJD). If selected for award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2022. That formal agreement must include a provision to meet the data archiving requirements of the award.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients.

## **Statutory Authority**

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (Section 201 and 202).

## **Specific Information**

Prolonged incarceration of criminals can result from technical parole and probation violations, included failed drug tests, missed curfews, or the inability to pay fines and fees. Poor coordination within the criminal justice system, coupled with a lack of support systems for affected individuals, can result in unnecessary incarceration rates, create a heavy financial burden for States and localities, and impose employment losses and societal costs on the incarcerated and their friends and family.

There is a diversity in treatments and approaches to technical violations of supervision across the United States. For example, some jurisdictions do not allow revocations without a new crime. In 2017, almost a quarter of admissions to state prison were from technical violations. States are spending approximately \$2.8 billion a year to adjudicate and incarcerate for these violations.[1] The amount of probation and parole failures have led states to consider a wide array of reforms to address technical violations. These have largely focused on changing incentives for compliance, alternative responses to violations, and limiting incarceration for technical violations.[2]

While states are starting to rethink approaches to technical violations, there is little research on what practices of the array of reforms are most likely to ensure success on probation and parole. In light of this, NIJ seeks **proposals from accredited academic institutions** to design and test models to expedite judicial review for individuals awaiting revocation of their parole or probation for technical violations of their supervision, while linking them to evidence-based services that address the root causes of recidivism. NIJ strongly encourages applicants to propose randomized controlled trials as the evaluation method for assessing effectiveness. Successful applicants should work to produce and test models that can be replicated on a national scale. Ideally, NIJ seeks development of a single model that can be replicated on a national scale.

Successful applicants will submit comprehensive plans. These plans will include (but are not limited to):

- Identification of promising state and local policies and practices currently in place across the United States to address technical violations.
- · Development of promising models.
- · Test and evaluation of those models.

Models should be scalable to be implemented in a variety of locations, for example urban, rural, and institutional settings, and jails and prisons. The models should be robust; able to address multiple sources of violations, and incorporate the latest evidence on addressing criminogenic risk and needs associated with causes of prevalent or high frequency

Page 5 of 19 O-NIJ-2021-99001 violations. Model evaluation should be conducted independently, and should include process, outcome/impact, and cost studies. Successful proposals will include a discussion of how the independence of the evaluation of these models will be secured.

Successful applicants should expect to meet regularly with NIJ staff — either in-person or remotely — and provide periodic updates of evaluation progress, in addition to standard reporting requirements. These updates (frequency to be determined by NIJ staff in consultation with the successful applicant) may include information on programmatic services delivered, fidelity measures, current sample enrollment, and evaluation activities.

NIJ anticipates this to be a multi-year effort. Supplements may be made available later to successful research projects that are able to implement a longer-term follow-up (i.e., longer than 3 years), subject to the availability of appropriated funds, legal requirements, and other considerations.

#### New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the four (4) years prior to September 30, 2021.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows or Data Resources Program grantees.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that they are submitting a New Investigator/Early Career proposal on the title page of the application.

#### **Evaluation Research**

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that include evaluation research should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision-making.

Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be taken into account when selecting an evaluation design. In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed.

Goals, Objectives, Deliverables, and Timeline Goals

#### Objectives

The objective of this solicitation is to develop and evaluate models, which can be robustly replicated on a national scale, to expedite judicial review for individuals awaiting revocation of their parole or probation for technical violations of their supervision, while linking them to evidence-based services that address the root causes of recidivism. Ideally, NIJ seeks development of a single model that can be replicated on a national scale.

Findings from this research program will assist state, local, and tribal jurisdictions to promote successful reentry, and thus reduce violent crime and protect public safety personnel.

#### Deliverables

Interim Research Report. Any recipient of an award under this solicitation will be expected to submit an interim research report detailing initial study findings. The findings should include, but would not be limited to, 1-year post-release arrest rates.

<u>Final Research Report.</u> Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's webpage.

<u>Required Data Sets and Associated Files and Documentation.</u> Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products.

The Goals, Objectives, and Deliverables are directly related to the performance measures that demonstrate the results of the work completed, as discussed under Application and Submission Information.

#### **Priority Areas**

The Department of Justice is committed to advancing work that promotes civil rights, increases access to justice, supports crime victims, protects the public from crime and evolving threats, and builds trust between law enforcement and the community. In FY 2021, OJP will give priority consideration in award decisions to applications that demonstrate ways in which their projects will advance one or more of these areas.

To receive priority consideration for advancing one or more of the Department's priorities, the applicant must provide a sufficient narrative explanation as an attachment, that specifies how the project will advance the promotion of civil rights, access to justice, support to crime victims, protecting the public from crime and evolving threats, or building trust between law enforcement and the community.

In addition, OJP will give priority consideration, if applicable, to applicants that demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent-poverty counties.

To receive priority consideration under the poverty priority, the applicant must provide information to demonstrate that the individuals who are intended to benefit from the requested grant reside in high-poverty areas or persistent poverty counties. For purposes of this priority consideration, the term "high-poverty area" means any census tract with a poverty rate of at least 20 percent as measured by the 2013–2017 5-year data series available from the American Community Survey of the Census Bureau (applicants may search by census tract at <a href="https://www.census.gov/acs/www/data/data-tables-and-tools/narrative-profiles/2017/">https://www.census.gov/acs/www/data/data-tables-and-tools/narrative-profiles/2017/</a>) and the term "persistent poverty counties" means any county that has had 20 percent or more of its population living in poverty over the past 30 years, as measured by the 1990 and 2000 decennial censuses and the most recent Small Area Income and Poverty Estimates (applicants may search by county at <a href="https://www.census.gov/data/tables/time-series/dec/census-poverty.html">https://www.census.gov/data/tables/time-series/dec/census-poverty.html</a> and at <a href="https://www.census.gov/programs-surveys/saipe.html">https://www.census.gov/programs-surveys/saipe.html</a>.
