To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

NIJ is authorized to distribute funds to support projects designated for funding in the Consolidated Appropriations Act, 2022 (Public Law 117-103) that improve the functioning of the criminal justice system, prevent or combat juvenile delinquency, and assist victims of crime (other than compensation). NIJ's Research Assistantship Program (RAP) furthers the Department's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States. Through the RAP, NIJ helps train the next generation of scholars. By doing so, our research can become more relevant and useful to the field to ultimately reduce crime and enhance public safety.

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202).

Specific Information

One of NIJ's goals is to increase the number of scientists aware of and engaged in research to address the challenges of crime and justice. The Research Assistantship Program is one vehicle to accomplish this goal, as it provides opportunities for current doctoral students across the country to learn about the research NIJ funds and conducts.

NIJ's Research Assistantship Program (RAP) is designed to support criminal, tribal, and juvenile justice research. It also helps attract highly qualified doctoral students in the social and behavioral sciences (SBS) and science, technology, engineering, and mathematics (STEM). Under the RAP, NIJ provides financial support to participating universities for costs associated with research assistants enrolled in doctoral research degree programs who work with NIJ scientists and participate in NIJ's research activities.

NIJ has funded research assistants for more than twenty years. The RAP, which was originally targeted to students attending universities in the Washington, D.C. metropolitan area, was expanded nationwide in 2015 to provide students across the country this opportunity, and to partner with a range of universities and programs. The RAP has enabled students to learn and grow from the research they have engaged in at NIJ, and NIJ has received invaluable assistance from the RAs through a variety of products, beneficial to expand and enhance our research programs and translate findings into action. This grant will enable NIJ to provide financial support to an exemplary doctoral student from DePaul University.

Goals, Objectives, Deliverables, and Timeline

Goals

The goal of this solicitation is to develop knowledge to inform public policy interventions that: support the fair and impartial administration of justice for all Americans, restore trust in the Justice System, and support the reduction of crime and recidivism. It also seeks to attract highly qualified students from accredited universities that support graduate study leading to research-based doctoral degrees.

Objectives

This goal will be addressed by awarding a grant to support a doctoral student from DePaul University who will work with NIJ scientist through the Research Assistantship Program to develop such knowledge.

Deliverables

- Anticipated project deliverables may include, but are not limited to: Compiling, summarizing, or making use of complex, technical, or specialized literature.
- Assisting in research design strategies (such as developing and modifying research proposals, procedures, or instruments).

Extracting and compiling a range of data from written sources, individuals (through questionnaires or

interviews), or databases.

- Interpreting and summarizing data analyses.
- Conceptualizing and drafting publications (such as government reports, peer-reviewed journal articles, NIJ publications and trade magazine articles).
- Assisting with outreach activities that include research dissemination (such as meeting presentations, press releases, talking points, articles, and web pages).

d. Plan for Collecting the Data Required for this Solicitation's Performance Measures

Describe the process for measuring project performance. Identify who will collect the data; who is responsible for performance measurements; and how the information will be used to guide and evaluate the project's impact. Describe the process to accurately report data.
