### Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) seeks applications for funding to advance knowledge to inform and advance effective services for victims. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

City or township governments, County governments, For profit organizations other than small businesses, Independent school districts, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Public housing authorities/Indian housing authorities, Small businesses, Special district governments, State governments, Unrestricted (open to any type of entity above), subject to any clarification in text field entitled as Additional Information on Eligibility

An applicant entity may submit more than one application, if each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

NIJ will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the OJP Grant Application Resource Guide.

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

## Submission Information

**Registration:** Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

**Submission:** Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

**Step 1:** The applicant must submit by the Grants.gov deadline the required **Application for Federal Assistance standard form (SF-424)** and a **Disclosure of Lobbying Activities (SF-LLL)** form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

## Program Description

### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

In collaboration with the Office for Victims of Crime (OVC), NIJ seeks applications for rigorous research and evaluation projects in three topical areas: 1) evaluation of programs that provide services for victims of crime; 2) research on supporting victims of community violence; and 3) financial costs of crime victimization. Applicants must submit proposals that address one of the three topic areas.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review [NIJ's data archiving guidance](#). If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

### Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); 28 U.S.C. 530C.

### Specific Information

Victims of crime can experience a range of ongoing negative physical, emotional, and financial consequences. It is essential to understand the various needs of victims and, accordingly, how different types of victim services can most effectively support them. This is especially important regarding the needs of victims in underserved and hard-to-reach communities, including, but not limited to, rural, cultural or ethnic, tribal, and Indigenous populations. NIJ is particularly, but not exclusively, interested in projects that promote racial equity in access to and provision of victim services and compensation by enhancing the organizational and programmatic capacity of victim service organizations run by and for communities of color.

NIJ is collaborating with OVC to support rigorous research and evaluation projects in three topic areas under this solicitation:

1. Evaluation of programs that provide services for victims of crime.
2. Research on supporting victims of community violence.
3. Financial costs of crime victimization.

A description of the three topic areas appears below. Applications proposing research projects not addressing these three areas will not be considered. Applicants can propose to conduct research addressing more than one of these three topic areas, as long as a separate application is submitted for each topic area.

Across the three categories, priority questions of particular interest to NIJ and OVC are listed below. However, proposals eligible for consideration do not need to include these specific research questions:

- What are the long-term emotional, financial, and medical impacts of violent crime victimization on victims, especially for crimes such as robbery, assault, and carjacking, and how often are victims of these crimes provided meaningful access to victim assistance and compensation? Are outcomes and impacts different for victims from communities of color?
- How effective are victim service programs that are embedded in criminal justice agencies (e.g., law enforcement, prosecutors' offices) for different demographic victim populations? How do these programs compare to those that operate within the community, considering differences in objectives and potential limitations in services, access, protections, practices, policies, and other procedures across programs?
- What are effective services to support victims of online abuse and harassment, including technology facilitated gender-based abuse and violence, and how do these services and victims' needs differ from other types of victimizations?
- What are the financial costs associated with technology facilitated gender-based abuse and violence across diverse demographic groups and technology platforms?

Applicants should propose the most rigorous design appropriate for the research questions to be addressed. Although NIJ understands the value of various methodological designs, applicants are strongly encouraged to incorporate quantitative methods, including statistical modeling when feasible. Applicants may propose tapping into novel data sources (e.g., public databases) or utilizing existing data sources to develop models that analyze victims' needs or determine gaps and necessary improvements in service access and delivery across local, state, and regional levels. For example, applicants may develop a metric or set of metrics for assessing strength of service delivery or access equity across various communities. Applicants should consider and propose data collection methods that ensure representation across diverse demographic groups. Applicants are encouraged to refer to <https://nij.ojp.gov/funding/awards/list> (and use keywords/search criteria) for more information about previously and currently funded studies, so that they can consider novel areas of research, as well as potential ways to build on existing studies while necessarily avoiding duplication.

#### Topic Area 1: Evaluation of programs that provide services for victims of crime

NIJ seeks proposals for evaluations of programs that deliver services to victims of crime. NIJ is interested in evaluations of different types of victim service programming including, but not limited to, programs embedded in hospitals/trauma centers, umbrella/network organizations, culturally specific programs, one-stop victim services programs, and/or programs embedded in criminal justice agencies. Applicants are expected to use the most rigorous, feasible research methods in evaluating service delivery programs with preference given to those that employ or are clearly progressing toward employing experimental research designs. NIJ is seeking both applications for formative evaluations with evaluability assessments and outcome/impact evaluations, as described below.

Previous NIJ grant recipients who received funding in FY 2018 – FY 2021 to conduct phased evaluation projects may submit applications for the next phase of their evaluations; NIJ will give these applications higher priority consideration, but funding is not guaranteed. Applications must include all final deliverables from previous phase(s), and state clearly how they will build upon findings from the initial project(s) and how the proposed project will accomplish — or make significant strides towards accomplishing — a rigorous outcome evaluation of the victim service program.

#### a. Formative or process evaluations

NIJ recognizes that many victim service programs may not be ready to support rigorous outcome evaluations; as such, a phased approach may be appropriate. Applicants should plan to conduct a formative evaluation, as well as an evaluability assessment to determine whether an outcome evaluation of the program or model is possible.

Under a phased approach, an applicant may initially propose a range of formative and/or process evaluation activities such as:

- Descriptive research of victim service program(s) leading to the development of a logic model(s).
- Evaluability and research capacity assessments of programs to be studied, including but not limited to access to data and samples, consent procedures, and agency burdens.
- Development of an implementation guide for specific program(s).
- Development of instruments or measures to test the fidelity of program(s).
- Description of the process used to design and implement the program.
- Description of program operations, including any changes in the program.
- Identification and description of intervening events that may have affected implementation and outcomes.
- Structured observations, questionnaires, semi-structured interviews, focus groups, and logs.

Award recipients, if successful, may submit a subsequent application for funding of further evaluation research to build upon its findings from earlier phases; NIJ will give these applications higher priority consideration, but funding is not guaranteed. Subsequent phases may include outcome/impact evaluations of specified program (s) or model(s). Future evaluation opportunities out of the phased approach may also include support for replication studies of programs or models. The specifics of the additional phases will be dependent on the findings of the formative evaluation and evaluability assessment, as well as other factors, including, but not limited to, the availability of appropriations.

Note: Funding under this solicitation may only be used to cover costs associated with the evaluation, but may include reasonable costs incurred by program personnel to support activities directly and exclusively required for the execution of the evaluation (e.g., manual extraction of administrative records).

#### b. Outcome/Impact Evaluations

In cases where programs have achieved a suitable level of development, NIJ encourages applicants to propose rigorous outcome or impact evaluations, using randomized evaluation designs where it is possible and appropriate to do so. If that is not possible or appropriate, applicants should propose the most rigorous and appropriate design to produce high-quality causal evidence and provide justification for not proposing a more rigorous design. For these applications, NIJ will only fund projects that evaluate well-developed programs. Applications should include, and append, supplementary materials as necessary to describe the level of program development. Supplemental materials may include copies or links to logic models, program guides and materials, policies and procedures, manuals, prior evaluation findings, program staffing, and funding information. Applications should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision-making.

#### Topic Area 2: Research on supporting victims of community violence

NIJ is interested in research that builds knowledge and informs policy and practice on supporting victims of community violence to ultimately reduce the risk of future re-victimization. Applicants may address a range of potentially relevant topics, but NIJ is especially interested in studies that examine strategies and practices to best address the needs of victims of crimes involving firearms, such as street violence (e.g., robbery, home invasions, and carjacking), gang-related violence (e.g., retaliatory and drive-by shootings), and mass public shootings. In general, NIJ seeks applications for studies that have high potential informational value for practitioners, and for the design of intervention and prevention activities. Applicants are encouraged to use participatory methods that include meaningful engagement with the people with lived experience, particularly victims, in the study design, methods, and analysis.

Studies funded under this topic area will build knowledge about the context and factors that influence access to, and delivery of, victim services; long-term emotional, financial, and medical impacts of victimization; practical and ethical considerations about service delivery; and potential innovative practices that may have applicability across different types of victim services (e.g., programs embedded in criminal justice agencies, umbrella/network organizations, culturally specific programs). Applicants are encouraged to propose studies that consider numerous relevant local factors and examine similar types of services for crime victims in multiple localities for comparative purposes. Applicants should propose the most rigorous and appropriate design possible to produce knowledge with practical implications.

For studies that propose evaluations of programs for victims of community violence, applicants should refer to and submit under Topic Area 1. Potential applicants for funding of research activities that focus on domestic mass shootings (e.g., familicide) or Extreme Risk Protective Order Laws (also known as Red Flag Laws) should review NIJ's FY2023 "Research and Evaluation on Firearm Violence and Mass Shootings" and consider the relevance of its goals and objectives to the proposed research to determine which solicitation is most appropriate for which to apply.

### Topic Area 3: Financial costs of crime victimization

NIJ is interested in research to develop a more nuanced understanding of long- and short-term financial costs of victimization to better inform policy development. Applicants should develop proposals focused on research priorities identified in the recently published [Estimating the Financial Costs of Crime Victimization Final Report](#) of an NIJ-funded study. NIJ is particularly interested in proposals that address underrepresented and hard-to-reach subpopulations (e.g., older adults; racial or ethnic groups; rural communities); underrepresented, hard to classify, and emerging crime types, such as financial exploitation and multiple crimes (polyvictimization); and/or methodologies to improve the accuracy of victimization cost estimates and interpretation, such as developing standards to describe and quantify uncertainty around estimates, as well as developing tools for use by practitioners to create estimates and relevant data.

Studies funded under this topic area will build knowledge about costs involving a wide range of crime types and victim experiences; comprehensive representation of tangible and intangible costs for victims; methodologies that address long-term costs and improve the generation and interpretation of estimates; individual victim characteristics (e.g., victimization history, demographics) that have implications for costs; and costs and consequences of victim services. Applicants should propose the most rigorous and appropriate design possible to produce knowledge with practical implications. Applicants should also describe potential limitations around the proposed methodologies and data sources (e.g., representativeness, generalizability, access) and describe how they plan to address these issues.

### Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

### Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to



ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish> for further information on high-quality evaluation design elements.

#### **New Investigator/Early Career Opportunity**

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

#### **Goals, Objectives, and Deliverables**

##### **Goals**

The goal of this solicitation is to advance knowledge to inform and advance effective services for victims.

##### **Objectives**

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

This solicitation seeks to support projects that: (1) evaluate programs that provide services for victims of crime; (2) conduct research on the needs of victims of community violence; and (3) conduct research on the financial costs of victimization.

##### **Deliverables**

**Final Research Report.** Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#).

**Required Data Sets and Associated Files and Documentation.** Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result, in whole or in part, from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will address issues related to racial equity and the removal of barriers to access and opportunity, and/or contribute to greater access to services, for communities that have been historically underserved, marginalized, and adversely affected by inequality, and should also identify how the project design and implementation will specifically incorporate the input or participation of these communities.

### **How to Apply**

#### Statement of the Problem (understanding of the problem) (15%)

- Demonstrated understanding of the problem.
- Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- Demonstrated awareness of the state of current research.

#### Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of proposed project.
- Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- Feasibility of completing the deliverables noted in the solicitation.

#### Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (15%)

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

#### Potential Impact (20%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.

#### Budget (5%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

#### **Other Review Criteria/Factors**

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

#### **Review Process**

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.
