### Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) seeks applications for funding of rigorous research and evaluation projects targeted toward developing a better understanding of the domestic radicalization phenomenon, and advancing evidence-based strategies for effective intervention and prevention. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

An applicant entity may submit more than one application, if each application proposes a different

project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

NIJ will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

### Submission Information

**Registration:** Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

**Submission:** Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

**Step 1:** The applicant must submit by the Grants.gov deadline the required **Application for Federal Assistance standard form (SF-424)** and a **Disclosure of Lobbying Activities (SF-LLL)** form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline. If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.**

## Program Description

### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks proposals for rigorous research and evaluation projects targeted toward developing a better understanding of the domestic radicalization phenomenon and advancing evidence-based strategies for effective intervention and prevention.

NIJ seeks proposals in four topics as they relate to radicalization and violent extremism under this solicitation:

- Research to inform terrorism prevention efforts.
- Research on the role of communications in promoting and countering extremist content and information.
- Research on disengagement, deradicalization and the reintegration into society of individuals incarcerated for terrorism related offenses.
- Evaluations of programs and practices to prevent acts of terrorism.

NIJ is particularly interested in proposals that explore the radicalization of individuals within the United States to violent white supremacist extremism and anti-government extremism, and identify and advance evidence-based strategies for effective intervention and prevention.

NIJ will not fund applications that intentionally introduce, expose, or disseminate extremist materials and propaganda to study participants. Applications that do not include an explicit plan to anonymize data and personally identifiable information will not be funded. Further, NIJ will not fund applications that employ deceptive or non-privatized data collection practices nor will NIJ fund applications that provide identifiable research data to law enforcement or investigative agencies. Please see the "Important Considerations" and "What will not be funded" sections on pages 8 and 17 below for more information.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived, by the grant recipient, with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review [NIJ's data archiving guidance](#). If selected for an award, grantees will be expected to have a formal agreement

in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

### **Statutory Authority**

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); the Homeland Security Act of 2002 (sections 231-233); Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4533); and 28 U.S.C. 530C.

### **Specific Information**

#### Definitions and Scope:

For the purposes of this solicitation, "terrorism" is defined as ideologically motivated acts of violence to further political, social, or religious goals. The U.S. Code defines domestic terrorism as acts dangerous to human life, primarily within the territorial jurisdiction of the United States, that are a violation of the criminal laws of the United States or of any state, and appear to be intended to: 1) intimidate or coerce a civilian population, 2) influence the policy of a government by intimidation or coercion, or 3) affect the conduct of a government by mass destruction, assassination, or kidnapping (18 U.S.C. § 2331(5)). The U.S. Code further defines international terrorism in the same way as domestic terrorism, except that acts under the international terrorism definition occur primarily outside of the territorial jurisdiction of the United States, or transcend national boundaries in terms of the means by which they are accomplished, the persons they appear intended to intimidate or coerce, or the locale in which their perpetrators operate or seek asylum (18 U.S.C. § 2331(1)). The Federal Bureau of Investigation (FBI) further differentiates these two types of terrorism by their influence, with domestic terrorism defined as being inspired by domestic influences, and international terrorism defined as being inspired by or associated with foreign terrorist organizations or nations. [\[1\]](#)

Violent extremists are defined as those who advocate, encourage, condone, justify, or support the commission of a violent act to achieve terroristic goals.

"Radicalization to violent extremism" is defined as the process by which individuals increasingly adopt a violent extremist or terrorist ideology. Note: an individual may be radicalized and adopt an extremist ideology without engaging in any acts of violence or terrorism. The distinction between violent and non-violent radicalization is an important one, and applicants should demonstrate awareness of this distinction in their proposals.

Terrorism is one form of targeted violence. NIJ understands that offending behavior in terrorism and extremist violence can often overlap with other forms of targeted violence, such as hate crimes and mass shootings. Further, individuals who commit these offenses also share some common risk factors and motivations for inflicting violence on their target populations. However, with this



solicitation, NIJ invites applications for research focused specifically on terrorism and violent extremism. Applicants may propose projects focused on one or more particular form of grievance or ideology, however, NIJ's purpose is to build knowledge about violent extremism, terrorism, and radicalization, regardless of specific grievance or ideology. Although a portion of Congressionally mandated funds may be applied towards applications that propose the study of violent white nationalist supremacists, funds will be available and applications will be considered for all other forms of radicalization to violent extremism and terrorism. Applicants should include clearly stated definitions of key terms and concepts, as well as descriptions and examples of how they will operationalize the radicalization and terrorism related phenomena that they are proposing to study. Applicants should also ensure that the findings from the proposed research (if awarded) will have the potential for high external validity beyond the focus of the study itself.

Under this solicitation, applicants will be limited to focusing on the radicalization process as it occurs in the United States, regardless of the locale of any act of terrorism that may ensue from that process. Applicants are encouraged to use comparative approaches in their applications, where warranted, and these may draw on international comparisons. However, applicants must focus their research on the radicalization process as it occurs within the United States, or extremism/terrorism prevention activities within the United States.

NIJ has funded research on terrorism, violent extremism, and domestic radicalization since 2012. Applicants should familiarize themselves with prior NIJ-funded research and include knowledge of relevant research in their literature review. For a summary of NIJ-funded research projects on the subject of terrorism, see <https://nij.gov/topics/crime/terrorism/Pages/welcome.aspx>. To best target applications and to avoid duplication of efforts for the current funding cycle, potential applicants are encouraged to review the Fiscal Year 2023 Research and Evaluation on Hate Crimes<sup>[2]</sup> and Research and Evaluation on Firearms Violence and Mass Shootings<sup>[3]</sup> solicitations and determine where their application fits best. Additionally, applicants are strongly encouraged to familiarize themselves with research projects on this issue that are funded by other federal agencies (e.g., Department of Homeland Security, Department of Defense, etc.) and other sources within and outside of the United States.

#### Important Considerations:

- Applicants must design research and evaluation projects submitted to this solicitation with the protection of civil rights and liberties prioritized at the forefront of the research design.
- NIJ will not fund research that solely examines the conventional political views of individuals or groups, including their participation in non-violent forms of political activism. Accordingly, applicants should clearly indicate in their proposal how they intend to delineate and study radicalism, extremist views, or other forms of illegal political activity (e.g., direct action or violence) separately from lawful political conduct.
- As it regards the spectrum of political ideologies, NIJ is especially interested in applications that strive to better understand violent white supremacist extremism, one of the primary and most lethal threats faced by the U.S. today.<sup>[4]</sup> The presence of this radicalization in individuals within American institutions (e.g., military, law enforcement, and other government agencies), as well as its transnational nature, may also be explored. The focus on violent white supremacist extremism may be included in applications to any of the four Research Topics listed below. It should also be noted that, while this prioritization exists, NIJ will continue to fund research on radicalization to all forms of violent extremism, regardless of ideology.
- NIJ will not award funding to applications that intentionally introduce, expose, or disseminate

extremist materials and propaganda to study participants.

- NIJ will not fund applications that do not include an explicit plan to anonymize data and personally identifiable information. Further, NIJ will not fund applications that employ deceptive or non-privatized data collection practices, nor will NIJ fund applications that propose to share identifiable research data with law enforcement or investigative agencies.
- Any machine learning or artificial intelligence methodologies proposed in the research design must include thorough, sufficient explanation and expertise in the proposal and application package.

### **Research Topics:**

NIJ is interested in receiving applications that address the following four research topics listed below. Applicants must apply to one of these four topics. In their applications, applicants must explicitly state which Research Topic they are requesting funding consideration under. Multiple applications may be submitted to this solicitation, but each application must be submitted under only one of the four topic areas. Applications for other than one of these four topics will not be considered.

#### **Topic Area #1: Research to Inform Terrorism Prevention Efforts**

NIJ seeks applications that build and improve on existing research in the area of terrorism prevention, including research that improves program development, data sources, and methods. Specifically, NIJ encourages applicants to propose novel approaches to study risk and protective factors, behavioral indicators, and updated risk assessment tools as they relate to domestic radicalization and violent extremism within the evolving threat landscape in the United States. Although applications may cover a range of topics related to domestic radicalization and violent extremism, NIJ is particularly interested in:

- Better understanding of what makes domestic violent extremism in the U.S. unique and how to address the fluid and blended nature of domestic extremist ideologies. This may include subtopics related to the normalization of extremist rhetoric translating to mobilization to violence, the safeguarding of democratic principles from violent extremism (e.g., election-related violence), and the long-term drivers (e.g., grievances) of domestic radicalization. Effective prevention and intervention, particularly novel approaches specific to domestic violent extremism, should be at the forefront of the research proposals.
- The transnational and institutionalized nature of violent white supremacist ideologies (white supremacy across the globe and within and across American institutions (e.g., military, law enforcement, and other government agencies)). Specific areas of focus may include comparative international approaches, or studies on recruitment, training, and separation/retirement processes within and across various workforce settings.
- Research that actively engages with and empowers local communities to develop community-led, contextualized multidisciplinary prevention and intervention frameworks through deeper understandings of the local threat landscape, social and political contexts, prevalent ideologies or grievances, barriers to reporting, and mapping of local services and resources. Special attention should be given to bolstering resilience, providing trauma-informed care, improving data collection by frontline workers, and case management, as needed.

#### **Topic Area #2: Research on the Role of Communications in Promoting and Countering Extremist Content and Information**

NIJ seeks applications for research that aims to better understand the dynamic role of communications and media platforms in radicalization to violent extremist ideologies. NIJ recognizes that extremists' use of online platforms can be a vital mechanism for communication and recruitment to radicalization, especially in the context of the COVID-19 pandemic. Specifically, "internet-based communications platforms, including social media, online gaming platforms, file-upload sites, and end-to-end encrypted chat platforms" all serve as a breeding ground for recruitment to radical ideologies (including conspiracy theories) and mobilization to violent extremism.<sup>[5]</sup> This problem is exacerbated by the use of information that is false (i.e., mis-information), false and deliberately created to discredit an entity (i.e., dis-information), or based on reality but is used to ignite hatred or inflict harm (i.e., mal-information) both by violent extremist groups and foreign governments/entities. Therefore, NIJ encourages applicants to propose research that identifies strategies and best-practices to bolster resistance to such material in both the online and offline spaces. Further, NIJ encourages applications for research on effective technologies and tools for identification, moderation, and/or removal of extremist content. Research results from projects funded under this topic should have an end-goal of informing effective messaging and counternarrative campaigns, developing strategies to amplify credible voices, cultivating digital literacy and evidence-based digital programming, as well as bolstering efforts to limit the widespread availability of extremist content online.

It should be noted that NIJ expects applicants to ensure that strategies that are proposed respect constitutional protections for expression, free speech, and association. Further, an application's research focus may not rely solely on social media data and should be paired with another research component.

Other important considerations for applications under this research topic include:

- Acknowledging the increased role of graphics, images, and short videos (e.g. memes, GIFs, "reels") in online and digital communications versus conventional text and the implications of this on the research design.
- Research that enhances multi-source information availability and information sharing efforts (both to the public and within and across government/law enforcement agencies) regarding the full range of domestic terrorism threats is vital. The role of public messaging as a preventative measure, with the end goal of shifting sentiments and knowledge about domestic extremism, should be considered.
- This research topic is not limited to the online space; both social and mass media can be utilized to inform research topics under this area of focus.

### **Topic Area #3: Research on Disengagement, Deradicalization, and the Reintegration Into Society of Individuals Incarcerated for Terrorism Related Offenses**

NIJ seeks applications for research related to the effective and efficient reintegration of individuals incarcerated for terrorism-related offenses as they return to their communities. Specifically, NIJ seeks to build knowledge of pre-release and post-confinement characteristics of individuals who have committed terrorist acts that may inform reintegration policies, programs, and practices. This population is understudied. NIJ is seeking applications to conduct empirical assessments of those convicted of terrorism-related offenses: their sentences, their risks and needs, and how they compare to others in custody or released from custody. For example, what are their risks and needs when they return to the community with regards to issues like reengaging with family, finding employment, and finding housing? Additional issues pertaining to pre-release include, but are not limited to, factors that positively or negatively influence radicalization during confinement, factors

related to participation in correctional programs, and factors that influence length of stay and release. Additional post-confinement issues include, but are not limited to, life trajectories of individuals incarcerated for terrorism-related offenses following release, recidivism within this population, services provided to them post-release, and radicalization independent of further offending.

Further, NIJ is seeking applications for research to better understand the deradicalization and disengagement phenomena. NIJ is particularly interested in understanding factors that promote withdrawal and independence from extremist behaviors, as well as those factors that play a role in encouraging individuals to depart from radical ideologies (or at least shift away to less-extreme beliefs).

NIJ recognizes that this topic is seeking research projects involving a hard-to-reach population. Applicants should demonstrate that they are well-prepared to access research participants, gain and retain a sufficient sample size, access administrative data sets, and conduct research in correctional settings (as necessary) by including letters of support and other appropriate documentation (including all appropriate human subjects protection protocols).

#### **Topic Area #4: Evaluations of Programs and Practices to Prevent Terrorism**

NIJ seeks proposals for either: (1) formative evaluations and evaluability assessments, or (2) outcome evaluations of terrorism prevention programs. For both options, evaluations considering a diverse array of terrorism prevention approaches will be prioritized. NIJ encourages applicants to review and partner with federally-funded programs (e.g., DHS Center for Prevention Programs and Partnerships)<sup>[6]</sup>. NIJ is particularly interested in evaluations of community-based terrorism prevention programs and evaluations of programs to reintegrate individuals who were convicted for terrorism or terrorism related offenses (e.g., providing material support to terrorists).

Community-based programs often include efforts to: (1) provide local law enforcement and other practitioners with appropriate professional development opportunities to prepare them to engage in terrorism prevention; (2) engage with key community members and groups to build awareness and trust; (3) improve the likelihood of reporting by community members who may see warning signs; and (4) intervene, communicate, or deliver services as appropriate to prevent and reduce the likelihood of terrorism.

NIJ is also interested in evaluations of reentry programming for individuals convicted of terrorism related offenses. Programs may include new or existing rehabilitation programs in correctional settings (e.g., prisons) or community-based reentry programs.

Note: funding under this solicitation may only be used to cover costs associated with the evaluation but may include reasonable costs incurred by program personnel to support activities directly and exclusively required for the execution of the evaluation (e.g., manual extraction of administrative records).

**Topic 4 - Option 1:** Formative Evaluations and Evaluability Assessments. NIJ recognizes that not all terrorism prevention programs may be at the stage of outcome evaluation readiness; as such, a phased approach is needed. The phased evaluation approach is a multistep process that ultimately results in a rigorous outcome evaluation. In Option 1, applicants should plan to conduct a formative evaluation, as well as an evaluability assessment to determine whether an outcome evaluation of the program or model is possible.

If successfully completed (i.e., if a program has achieved a suitable level of development), awardees may apply for funding of additional phases to build on their findings in response to future solicitations (dependent on future funding). The specifics of the additional phases will be dependent on the

findings of the formative evaluation and evaluability assessment. Subsequent phases may include: (1) a process evaluation of the specified program(s) or model(s), or (2) an outcome/impact evaluation of specified program(s) or model(s). Future evaluation opportunities out of the phased approach may also include support for replication studies of programs or models.

Evaluation Designs should include:

- Descriptive research of terrorism prevention program(s) leading to the development of a logic model(s).
- Evaluability and research capacity assessments of programs to be studied, including but not limited to access to data and participant recruitment, consent procedures, and agency burden.
- Development of an implementation guide for specific program(s).
- Development of instruments or measures to test fidelity of program(s).

Applications should provide detailed information on how all tasks will be accomplished, include a multidisciplinary evaluation team, and demonstrate clear support from related partners by submitting letters of support.

**Topic 4 - Option 2:** Outcome Evaluation. In cases where programs have achieved a suitable level of development, NIJ encourages applicants to propose rigorous outcome evaluations using randomized evaluation designs, where it is possible and appropriate to do so. If that is not possible or appropriate, applicants should propose the most rigorous and appropriate design to produce high-quality causal evidence.

Under this option, NIJ will only fund projects that evaluate well-developed programs. Applications should include and append supplementary materials as necessary to describe the level of program development. Supplementary materials may include copies or links to logic models, program guides and materials, policies and procedures, manuals, prior evaluation findings, program staffing, and funding information.

#### **Coordination with Existing Studies**

Applicants are strongly encouraged to familiarize themselves with relevant research funded by other federal agencies, including but not limited to: the Department of Justice's Office of Community Oriented Policing Services, the Department of Homeland Security's Science and Technology Directorate, the National Counterterrorism Center, and the Department of Defense. NIJ will take into consideration how proposals build on existing or published research on topics described in this solicitation. NIJ will also coordinate with other federal agencies to ensure that awards are not made under this solicitation for research that duplicate existing studies.

#### **Additional Information**

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

## **Evaluation Research**

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish> for further information on high-quality evaluation design elements.

## **New Investigator/Early Career Opportunity**

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should

identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

### **Diversity of Perspectives**

NIJ is interested in increasing diversity and promoting greater inclusion in extremism research. NIJ encourages diversity of perspectives among applicants to add to the broader scientific understanding of radicalization to violent extremism. Applications are encouraged from researchers of all backgrounds, and research partnerships should demonstrate how the researchers and/or practitioners involved in any proposal promote inclusivity and opportunities to be more closely involved in the field of violent extremism prevention.

### **Goals, Objectives, and Deliverables**

#### **Goals**

The goal of this solicitation is to develop knowledge and evidence that has practical utility in developing evidence-based strategies to prevent radicalization to violent extremism and the commission of acts of terrorism.

#### **Objectives**

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables, and Timeline web-based form.

The objective of this solicitation is to fund rigorous research and evaluation projects that build upon the evidence-base to inform prevention and intervention of domestic radicalization to violent extremism efforts.

#### **Deliverables**

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

#### **Priority Areas**

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

#### 1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity **and** the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

1. Statement of the Problem

The statement of the problem should address the need for research in this area. Applicants should discuss current gaps in data, research, and knowledge, including those for particular justice sectors, for certain populations, and to answer questions relevant to current policy and practice needs and public interests. It is not uncommon for multiple problems to exist simultaneously (for example, there may be a criminal justice problem affecting public safety, a current technical challenge/need identified by forensic practitioners, as well as a scientific/technology gap between the current state of the art and a desired solution) and applicants should discuss each of these clearly and justify the importance of the separate issues. As part

of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

## 2. Project Design and Implementation

Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will address issues related to racial equity and the removal of barriers to access and opportunity, and/or contribute to greater access to services, for communities that have been historically underserved, marginalized, and adversely affected by inequality, and should also identify how the project design and implementation will specifically incorporate the input or participation of these communities.

## 3. Potential Impact

Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States. The applicant should include a discussion of the proposed dissemination plan to produce scholarly products and to make information available to broader interested audiences, such as criminal justice practitioners or policymakers.

## 4. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization, key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude.
