Overview

The U.S. Department of Justice (DOJ), Office of Justice Programs (OJP), National Institute of Justice (NIJ) seeks proposals for research and evaluation projects addressing the following topical areas: 1) research and evaluation on human trafficking victim assistance and service provision, 2) research on forced criminality, and 3) human trafficking prevalence estimation. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

In collaboration with the Office for Victims of Crime (OVC), NIJ seeks to build upon its research and evaluation efforts to better understand, prevent, and respond to trafficking in persons in the United States. Applicants should propose research and evaluation projects that — first and foremost — have clear implications for criminal justice policy and practice in the United States. NJJ seeks proposals for research and evaluation projects addressing the following topical areas: 1) research and evaluation on human trafficking victim assistance and service provision, 2) research on forced criminality, and 3) human trafficking prevalence estimation. Applications proposing projects other than in these three areas will not be considered.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that deidentified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review <u>NIJ's data archiving guidance</u>. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

Specific Information

Applicants should familiarize themselves with prior NIJ-funded research on the subject of human trafficking.[1]

Topic Area 1: Research and Evaluation on Service Provision for Victims of Human Trafficking

NIJ seeks proposals for rigorous evaluations of models of direct service provision specifically to aid victims of human trafficking.

There have been relatively few rigorous evaluations of programs, models, or interventions specific to providing services to victims of human trafficking. Much of the existing research has been focused on U.S. citizen minors who are victims of sex trafficking. NIJ is interested in testing various models of service provision to aid victims of human trafficking (both sex trafficking and labor trafficking), including those developed for other populations, such as victims of domestic violence or individuals experiencing homelessness. Services may include, but are not limited to, case management, housing, behavioral health services, employment services, and legal services. Models could include approaches like rapid rehousing, peer support, clinical interventions for post-traumatic stress disorder, and holistic, wraparound service. NIJ will prioritize applications that propose to:

- Use rigorous evaluation methodology and/or seek to build on past evaluative efforts to increase scientific rigor;
- Evaluate or test models involving services that include both sex and labor trafficking survivors;
- · Involve multiple locations and/or organizations; and/or
- · Focus on services for underserved populations

NIJ will consider applications for formative evaluations with evaluability assessments; however, priority will be given to outcome/impact evaluations that include a process evaluation.

For outcome/impact applications, NIJ will only fund projects that evaluate well-developed programs. Applications should provide a brief description of the program design and history, theory of change, program case flow, anticipated outcomes, sustainability of the program, and other relevant information. Appended supplemental materials may include copies of logic models, program guides and materials, policies and procedures, manuals, prior evaluation findings, program staffing, and funding information.

Applicants should propose the most rigorous, appropriate design possible. Specifically, applicants are expected to use the most rigorous, feasible research methods in evaluating service delivery programs with preference given to those that employ experimental or strong quasi-experimental research designs.

Outcome/impact evaluations must also include a process/implementation evaluation component.

Applications should consider the feasibility of including cost/benefit analysis.

Topic Area 2: Forced Criminality Research

NIJ seeks proposals for research focused on labor trafficking in illicit activities beyond commercial sex, including, but not limited to, drug production, distribution, and sale; theft; and fraudulent activities. Although there are growing data sets and initiatives on this form of human trafficking in other countries, such as the United Kingdom, information in the United States is very limited on how individuals use force, fraud, or coercion to compel others to engage in such illegal activities. Because these cases are rarely identified by the criminal justice system or by victim service providers as human trafficking, projects should consider the role of stakeholders in other sectors, such as juvenile justice, corrections, law enforcement responding to non-trafficking crimes, and others who may be interacting with individuals without identifying them as people who have perpetrated or experienced these forms of human

trafficking. Projects could focus on the occurrence of forced criminality among particular populations adjudicated for criminal activity (such as minors processed through drug courts) and should examine the unique barriers to identifying these individuals as victims of human trafficking, to providing them with victim services, to protecting them from prosecution for crimes they were coerced to commit, and to holding their traffickers criminally accountable.

Topic Area 3: Estimating Prevalence

NIJ seeks proposals for research that improves upon current methodologies used to produce estimates of the prevalence of human trafficking (sex and labor) within the United States. Specifically, NIJ seeks to fund research that develops methodologies for estimating prevalence and validating those estimates in defined, local geographic areas. Proposals should focus on generating a statistically sound estimate of trafficking prevalence of one or more trafficking types, sectors, industries (such as agricultural, janitorial, or meat processing), and/or geographic area(s). Applicants should propose data collection mechanisms that account for the race and ethnicity of victims of human trafficking. Applicants should demonstrate familiarity with other efforts to arrive at prevalence estimates, such as the U.S. State Department's Prevalence Reduction Innovation Forum[2] [3] and propose research complementary to these efforts.

Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/ or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must, at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this solicitation is to better understand, prevent, and respond to trafficking in persons in the United States and to provide federal, state, local, and tribal stakeholders with knowledge and tools to more effectively address trafficking in persons.

Objectives

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Overall, this solicitation seeks to support projects to:

- 1. Evaluate strategies to provide direct services to victims of human trafficking.
- Understand how individuals use force, fraud, or coercion to compel others to engage in illegal activities.
- 3. Develop better means for human trafficking prevalence estimation.

Deliverables

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's webpage.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend

the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity <u>and</u> the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).
