Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National</u> <u>Institute of Justice</u> (NIJ) seeks applications for funding to conduct research and evaluation on policing practices, accountability mechanisms, and alternatives. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource</u> <u>Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks rigorous, applied research and evaluation projects examining the impact of: (1) police accountability practices; (2) the shifting and sharing of police functions; (3) police training; and (4) police officer health and wellness programs on an array of police performance outcomes (e.g., officer intervening and reporting of misconduct, excessive or unnecessary use of force, civilian complaints, officer and civilian injuries, police accountability and transparency, public trust and confidence in the police, and quality of police-community relationships). Applicants are encouraged to review NIJ's <u>Policing Portfolio</u> and previous policing and safety, health and wellness research awards funded by NIJ.[1]

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review <u>NIJ's data archiving guidance</u>. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices

Page 7 of 41 O-NIJ-2023-171675 related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); 28 U.S.C. 530C.

Specific Information

With this solicitation, the National Institute of Justice (NIJ) seeks applications for funding to conduct research and evaluation on policing practices, accountability mechanisms, and alternatives.

<u>Police Accountability Policies and Practices</u>. Police accountability and transparency are viewed by members of the public as critical components to changing officer behavior, maintaining trust and confidence in the police, and strengthening police-community relationships. To build empirical knowledge on police accountability measures, NIJ seeks proposals that examine the implementation and impact of:

- Early intervention systems that accurately identify officers at a high risk of an adverse event and promote proactive interventions (e.g., supervisory coaching, therapy sessions, remedial training). Studies that solely examine the predictive validity of early intervention systems **will not** be considered.
- Duty to intervene, mandatory reporting, and active bystandership policies.
- Police accountability practices (e.g., internal organizational processes or external oversight, etc.).

NIJ is also interested in proposals that examine how body-worn camera footage and other innovative data sources may be used to enhance police accountability.

<u>Shifting and Sharing Police Functions</u>. Police are dispatched to handle a myriad of citizen calls for service, many of which do not involve a crime in progress or other situations warranting police intervention. Public debates have centered around the role and level to which the police should be involved in certain public safety services, particularly responses to people experiencing mental health, intellectual, developmental, substance use disorders, or others who are in crisis. Further research is needed to explore the benefits and unintended consequences of co-responder or alternative models to public

Page 8 of 41 O-NIJ-2023-171675 safety calls for service compared to traditional police responses.

At a foundational level, NIJ is interested in studies that examine the quality of data associated with public demand for police services and the ability of 911 and alternative hotline (e.g., 311 and 988) call-takers to discern the nature of the call and whether it merits a police or alternative response. Studies that evaluate innovations in data analysis and call-taking practices to guide more effective outcomes in case resolution (including safety of civilians and responders and non-law enforcement approaches) are particularly welcomed.

NIJ also invites proposals that evaluate how officers use their unassigned time in the context of informing and evaluating policies, incentives, and reward systems associated with officers' proactive community engagement and effective problem-solving partnerships.

<u>Co-responder Models</u>. Co-responder models are designed for situations involving individuals suffering from mental illness, substance abuse disorders, developmental disabilities, or others who are in crisis.[2] These models typically consist of partnerships between police officers and non-police personnel (e.g., psychologists, social workers, and mental health clinicians) trained to respond to and resolve certain situations where a public safety intervention is needed or has been requested. NIJ is interested in research that assesses outcomes of differing co-responder models related to responses to individuals suffering from mental illness, substance abuse disorders, developmental disabilities, or others who are in crisis on incident resolutions (e.g., calls for police back up; injuries to responders and civilians; treatment, health, and social service referrals; emergency department referrals; repeated police calls for service; etc.).

NIJ is explicitly interested in rigorous evaluations of co-responder models that explore outcomes in the field, such as safe and sufficient resolution of the call, uses of force, and officer and civilian injuries and fatalities. Proposals that solely examine changes in officer perceptions and attitudes <u>will not</u> be considered.

<u>Alternative Response Models</u>. Alternative models involve the practice of shifting police responses to situations involving individuals suffering from mental illness, substance abuse disorders, developmental disabilities, or others who are in crisis. Unlike corresponder models, "[t]his approach is designed to divert certain cases to experts who are better trained to respond to them," removing police from the response.[3] To address this issue, NIJ seeks to fund applications for research that examines the implementation and impact of alternative response models that divert or deflect calls-for-service dealing with these individuals to non-police practitioners. NIJ is interested in proposals that examine the impact of:

- Mobile crisis teams on alternatives to arrest and access to public services.
- Neighborhood safety offices on prioritizing community needs and providing access

• Civilian traffic enforcement on disparities involving secondary traffic infractions and public safety.

As applicable, proposed projects to explore these models should be designed to develop knowledge of: (1) the training and role of call-takers and dispatchers in directing calls to alternative responders; (2) the public demand for policing services (as represented by calls to 911 and alternative hotlines such as 311 and 988); (3) how data analysis can inform the offloading of police functions safely; and (4) the cases for which police involvement or response may still be warranted.

NIJ is explicitly interested in rigorous evaluations of the field outcomes of alternative models, such as safe and sufficient resolution of the call; community perceptions of and satisfaction with the response; treatment, health, and social service referrals; emergency department referrals; responder and civilian injuries and fatalities; calls for police back up; and repeated calls for service to both 911 and alternative hotlines.

<u>Police Training</u>. Over the past several decades, police duties and responsibilities have grown to manage increasingly diverse and complex public safety demands. Police agencies must identify and deliver effective training to support the expanding scope of police work, yet policing research offers few rigorous training program assessments. For example, prior studies have not regularly assessed behavioral impacts (e.g., officer performance versus attitudinal effects), nor have many examined how different training curricula and instructional designs impact learning and knowledge/skill retention. Further, research has yet to fully leverage data stemming from technological advances (e.g., body worn cameras, artificial intelligence) to assess police training outcomes or examine the use of new technologies as training tools. To address these issues, NIJ seeks proposals to examine police training outcomes, including, but not limited to, assessments of:

- Active bystandership training impacts on officer performance outcomes (e.g., use of force, civilian complaints, civilian and officer injuries).
- Diversity, communication (including intergroup contact mechanisms)[4], deescalation, or tactical training to reduce conflict and improve interactions among colleagues or between police personnel and community members.
- Training program design (e.g., curriculum content, instructor characteristics, training duration and frequency, instructional methods and settings) on police personnel knowledge retention, skill competencies, and behavioral outcomes.
- Field training innovations and impacts.
- Trainings tailored to front-line supervisors on changes in both supervisor attitudes and behaviors and officer performance outcomes such as use of force, civilian complaints, and civilian and officer injuries.

• Programs using emergent technologies (e.g., body worn cameras) as training tools to improve police personnel performance.

NIJ is explicitly interested in proposals for training that examine police performance outcomes. Proposals for training evaluations that solely examine changes in officers' knowledge, attitudes, and perceptions <u>will not</u> be considered.

<u>Police Officer Health and Wellness Programs</u>. Increased attention has been given to police officer exposure to acute traumatic events, chronic exposure to micro-trauma, and prolonged involvement in stressful environments and working conditions. It is well established that high stress can have precipitous negative effects on an individual's health (e.g., post-traumatic stress disorder (PTSD), depression, and/or anxiety). To address this issue, NIJ is interested in proposals that examine, but are not limited to:

- The impact of police officer health and wellness programs on reducing the effects of trauma and stress on officers' health and wellness.
- The impact of police officer health and wellness programs on improving officer resiliency.
- Agency efforts to reduce the stigma of seeking assistance.
- Agency efforts to promote peer mentoring and other support components.

Moreover, stress and stress-related disorders can cause problems with concentration, memory, and mood, which impacts workplace performance. Additionally, stress and exposure to traumatic events can negatively impact the delivery of policing services in communities. To that end, NIJ applicants may also explore the benefits and unintended consequences of efforts to improve officer health and wellness on:

- The use of procedurally just and constitutional policing practices in communities.
- The use of excessive or unnecessary force.
- Civilian perceptions of and satisfaction with their interactions with officers.
- Officer job satisfaction.
- Officer retention.

Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <u>https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish</u> for further information on high-quality evaluation design elements.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose

To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to build a body of knowledge on policing at the local level to inform the development of policy and practices to improve outcomes for communities and police personnel.

Objectives

The primary objective of this solicitation is to promote rigorous research and advance knowledge by examining the impact of: (1) police accountability practices; (2) the shifting and sharing of police functions; (3) police training; and (4) police officer health and wellness programs on an array of police performance outcomes.

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

<u>Required Data Sets and Associated Files and Documentation</u>. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts

by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity **and** the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also
