Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) seeks applications for funding to support the Law Enforcement Advancing Data and Science (LEADS) Scholars Program, an ongoing NIJ program designed to increase the in-house research capabilities of law enforcement agencies by building data and research skills of individuals employed by and engaged with these agencies. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks proposals to support the Law Enforcement Advancing Data and Science (LEADS) Scholars Program, an ongoing NIJ program designed to increase the in-house research capabilities of law enforcement agencies by building data and research skills of individuals employed by and engaged with these agencies. The LEADS Scholars Program advances evidence-based policing by supporting the development of research-minded law enforcement professionals and their academic partners through travel, training, research support, and partnership opportunities.

Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); 28 U.S.C. § 530C.

Specific Information

In 2014, NIJ established the Law Enforcement Advancing Data and Science (LEADS) Scholars Program to support research-minded, mid-career law enforcement officers working to integrate research into agency policy and practice. To further the reach and impact of the program, NIJ has since added two additional categories of scholars, LEADS Civilians and LEADS Academics. The program provides for three-year, merit-based scholarships that support travel and registration costs to attend an NIJ Summer Session in Washington, D.C., consisting of policing research-focused seminars and research support, professional development programming, and meetings with various DOJ subject matter experts and leadership. The program also supports travel costs to other conferences and workshops including the annual IACP Conference and Exposition, where participants partake in a variety of research-related events and sessions.

The LEADS Scholars program provides participants with research support in identifying current research evidence on priority issues and assisting in developing independent research. The LEADS Scholars take part in numerous activities to support their professional growth, such as attending virtual and in-person trainings, participating in an online community of practice, publishing in journals and trade magazines, presenting to law enforcement agencies at national conferences, and establishing leadership positions in evidence-based research groups.

LEADS Civilians was established in response to feedback from sworn law enforcement LEADS Scholars that strategic coordination with civilian staff members is essential for

understanding and using available data to best inform policies and procedures beyond standard reporting measures. LEADS Civilians are employed full-time by a law enforcement agency or government entity and have responsibilities relevant to integrating science, research, and data into policing policies and practices. Civilians encouraged to apply to the program include, but are not limited to, crime analysts, law enforcement planners, intelligence analysts, project managers, legal analysts, technology specialists, and trainers.

LEADS Academics was established in response to the fact that many doctoral programs do not require their students to conduct original research with practitioners, along with an interest in building the skills and experience of academics to conduct research with law enforcement agencies. The program aims to support the development of researchers who authentically collaborate and work in partnership with law enforcement practitioners.

Applicants responding to this solicitation are expected to provide technical assistance and training to all three types of NIJ LEADS Scholars, including assistance in defining program and research project objectives; assessing ongoing research and developing new projects; and finding relevant opportunities for collaboration. The applicant will provide general logistical support for meetings, conferences, and symposia to include registration, travel, and lodging.

The successful applicant will be expected to perform the following tasks, in collaboration with NIJ, to support the LEADS Scholar program:

- Support the annual application and peer-review process of new LEADS Scholars, including conducting widespread advertising of the application opportunity to encourage a demographically diverse applicant pool.
- Support the annual attendance of fifty (50) LEADS Scholars at the IACP Annual Conference and Exposition.
- Support a day-long NIJ LEADS meeting immediately prior to the IACP Annual Conference and Exposition each year.
- Support the annual attendance of fifty (50) LEADS Scholars at the two-day NIJ Summer Session held in the Washington, D.C. metropolitan area.
- Support of a LEADS Scholars' "showcase" panel at a minimum of four (4) policing-related conferences held within the U.S.
- Create and maintain a LEADS Community of Practice (CoP) online platform for LEADS Scholars to communicate and share ideas and experiences within and across cohorts.
- Create and implement a process and/or mechanism to offer ad hoc support to LEADS Scholars and alumni about the current state of research evidence; connect scholars with relevant subject matter experts in the field and to other scholars with similar interests; support their attendance at meetings or conferences that will assist their research; and consistently identify and share relevant learning and

collaboration opportunities with current LEADS scholars and LEADS alumni.

- Support LEADS Scholar research, both by providing expert guidance and feedback on methodology and data analysis and by funding ad hoc travel for site visits if necessary for scholar collaboration (up to 10 per year).
- Support professional development and training by connecting LEADS Scholars to existing training or developing new training as appropriate to meet the needs of the program.
- Create and maintain a searchable database of substantive interests and initiatives underway in the LEADS CoP.
- Elevate knowledge-production activities among members of the LEADS CoP, both within the scholar community and to a wider audience.

Proposals will be evaluated on the demonstrated skills and competencies of the applicant to do the work proposed, the soundness and innovation of the approach to accomplishing the work, and the feasibility of successfully conducting the proposed work based on proposed staff and budget. NIJ is particularly interested in the ways in which applicants propose to leverage related work with relevant communities of practice and how the applicant is already engaged with those communities. The program does not fund the research itself but rather is designed to develop sustainable researcher-practitioner and practitioner-practitioner partnerships that may result in opportunities to pursue funding elsewhere to support their research.

Applicants should describe their plan for the successful transition of the project between awards and account for a transition period in their project timeline and budget. A new applicant should anticipate that a transition may occur at the beginning and end of their project period. An incumbent applicant should anticipate that a transition may occur at the end of their project period.

NIJ will not consider proposals that fail to provide a plan to support the current LEADS activities and categories of scholars outlined in this solicitation.

Goals, Objectives, and Deliverables

Goals

NIJ's primary goal in releasing this solicitation is to enhance law enforcement professionals' capacities to collect and analyze data; enhance capacities to conduct research that answers key questions and produces evidence; and increase the utilization of research and evidence to better inform policies and practices.

Objectives

NIJ's primary objective in releasing this solicitation is to make an award to a qualified entity to continue supporting the Law Enforcement Advancing Data and Science (LEADS) Scholars Program.

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

Deliverables

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result, in whole or in part, from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

NIJ expects that the period of performance for any award from this solicitation will be five years, with only the first 12-months of effort funded initially. Subsequent funding, if any, will be determined by the results of the initial phase of work, the availability of funding, and agency priorities, among other factors.

Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

Notice regarding law enforcement agencies: State, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process to be eligible for FY 2023 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency’s use-of-force policies adhere to all applicable federal, state, and local laws, and (2) the agency’s use-of-force policies prohibit

chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. Proposal Abstract

A Proposal Abstract (no more than 400 words) summarizing the proposed project — including its purpose, primary activities, expected outcomes, the service area, intended beneficiaries, and subrecipients (if known) — must be completed in the JustGrants web-based form. This abstract should be in paragraph form without bullets or tables, written in the third person, and exclude personally identifiable information. Abstracts will be made publicly available on the OJP and USASpending.gov websites if the project is awarded. See the [OJP Grant Application Resource Guide](#) for an example of a proposal abstract.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point font; have no less than 1-inch margins; and should not exceed 30 numbered pages. If the Proposal Narrative fails to comply with these length restrictions, NIJ may consider such noncompliance in peer review and in the final award decision.

The Proposal Narrative should include the following sections:

a. Title Page (not counted against the proposal narrative page limit)

The title page should include:

Project title.

Submission date.

Funding opportunity number.

Principal Investigator (and any co-principal investigators).

Unique author identifier (e.g., ORCID, ResearcherID, Scopus Author ID), if available.

Key words, including science focus areas.

Contact information (that is, name, address, telephone number, and e-mail address) for both the applicant and the principal investigator.

b. Resubmit Response (if applicable) (not counted against the proposal narrative page limit.)

If an applicant is resubmitting an application presented previously to NIJ, but not funded, the applicant should indicate this. A statement should be provided, no more than two pages, addressing: (1) the title, submission date, and NIJ-assigned application number of the previous application, and (2) a brief summary of revisions to the application, including responses to previous feedback received from NIJ.

c. Table of Contents and Figures (not counted against the proposal narrative page limit)

d. Main Body

1. Statement of the Problem

The statement of the problem should address the need for research in this area. Applicants should discuss current gaps in data, research, and knowledge, including those for particular justice sectors, for certain populations, and to answer questions relevant to current policy and practice needs and public interests. It is not uncommon for multiple problems to exist simultaneously (for example, there may be a criminal justice problem affecting public safety, a current technical challenge/ need identified by forensic practitioners, as well as a scientific/technology gap between the current state of the art and a desired solution) and applicants should discuss each of these clearly and justify the importance of the separate issues. As part of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

2. Project Design and Implementation

Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation.
