Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) seeks applications for funding to conduct research and evaluation on correctional climate and culture. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks proposals for rigorous research and evaluation projects that inform our understanding of the impact of culture and climate on the ability of correctional agencies to achieve their missions, most fundamentally: to maintain a safe, humane, and secure environment for both staff and incarcerated individuals in the institutions that they manage; to recruit and retain staff; and to promote and sustain needed changes in their organizational cultures, operations, and programs to better achieve their missions.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review NIJ's data archiving guidance. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that

dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct the majority of the work proposed.

Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); Second Chance Act of 2007; Second Chance Reauthorization Act of 2018; Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4528); 28 U.S.C. 530C.

Specific Information

The purpose of this solicitation is to support research and evaluation projects that inform our understanding of the impact of correctional culture and climate across three areas: (1) the safety, health, and wellness of both correctional staff and incarcerated persons; (2) issues of correctional agency staffing, retention, and training as they pertain to correctional culture and the well-being of staff and incarcerated persons; and (3) strategies that promote and sustain needed change in the organizational cultural of corrections agencies. Proposals for research outside of these three topics will not be considered. NIJ is particularly interested in applications that propose research partnerships with departments of correction to launch and evaluate demonstration programs designed to transform correctional culture and climate. Proposed studies that are primarily descriptive in nature will not be considered responsive to the solicitation.

Although the definition of correctional culture may vary, at a minimum, it can be thought of as the relationships and interactions between incarcerated persons and correctional staff and the adaptations of these groups to the shared environment.[1] Climate can be defined as the "social, emotional, organizational and physical characteristics of a correctional institution as perceived by" incarcerated persons and correctional staff.[2] Applicants are encouraged to use the definitions offered here or work with their partnering corrections agency to develop and propose their own definitions for the research proposed in response to this solicitation.

Fundamentally, NIJ is interested in research examining how the culture and climate of a corrections agency can be transformed to yield a variety of outcomes, including, but not limited to: improving the nature and conditions of confinement for incarcerated individuals and staff; the safety, health, and wellness of both staff and incarcerated individuals; and the ability to ensure sufficient facility staffing, recruitment, training, and retention. NIJ recognizes that for many of these topic areas, there may exist a bidirectional relationship between culture and climate and the outcomes under study. Proposed research designs should be able to capture these complex relationships, if applicable. NIJ encourages

proposals that aim to increase the accountability and transparency of correctional agencies and institutions. NIJ is particularly interested in applications with evaluation designs that align with an action research approach, for which researchers: (1) engage with partnering agencies to define the problem through baseline data collection and analysis; (2) develop changes in programs, policies, or practices that are informed by these analyses; (3) document the implementation of resulting changes, providing information to correctional partners on implementation fidelity and areas in which it can be improved; and (4) assess the impact of the changes over time. Applicants may propose a phased implementation plan, which should describe how the research design and questions warrant a phased approach. Regardless of the topic addressed, all research projects should define and assess the culture and climate in the institutions participating in the study.

The Office of Justice Program's Bureau of Justice Assistance (BJA) has released a related <u>solicitation</u> for entities to provide training, technical assistance, and resources to correctional institutions in support of transforming prison cultures, climates, and space.

Well-being of Staff and Incarcerated Persons

NIJ is interested in research proposals that examine how culture and climate can be transformed to promote the safety, health, and wellness of correctional staff[3] and incarcerated individuals. Research has shown that correctional officers experience high stress levels, burnout, and a variety of other mental health-related consequences because of their jobs.[4] This includes stress resulting from maladaptive aspects of their organizational culture as well as stress resulting from the dangerous nature of their work. [5] Together, the negative physical and mental health outcomes for correctional officers can have harmful effects on the wider correctional institution. Staffing shortages and officers missing work create a dangerous cycle where low officer-to-incarcerated person ratios and high turnover in staffing threaten a correctional facility's ability to faithfully comply with security measures that ensure the safety of both staff and people in confinement. Moreover, research suggests that the stress that officers are under can negatively affect their interactions with incarcerated individuals. Specifically, NIJ requests proposals that examine ways in which culture and climate can impact:

- The safety, health, and wellness of agency staff including officers, civilian staff, and contractors.
- The safety, health, and wellness of incarcerated individuals.
- The conditions of confinement for incarcerated individuals, e.g., medical care, population density, privacy, education, freedom of movement, visitation, etc.
- Violence, disorder, and the threat of violence in the correctional facility.
- Self-harm and deaths in custody, including deaths by suicide, including among individuals in the custody of the federal prison system.[6]

Staff Recruitment and Retention

NIJ is interested in research proposals that examine ways in which changes in culture and climate can enhance the ability to recruit and retain correctional agency staff.

Ensuring a viable and qualified workforce is a top priority among corrections administrators.[7] Low staffing levels, for example, may lead to an overreliance on specific institutional practices such as institutional lockdowns and restrictive housing, which may prove harmful to incarcerated persons, restrict participation in programs and contact with loved ones, and further erode the institutional culture and climate. Research on how culture and climate effect — and can be altered to improve — recruitment and retention is critical in the current correctional operating environment. Many agencies are implementing strategies to enhance recruitment and retention, but it is unclear how culture and climate may enhance or mitigate the success of those strategies. NIJ requests proposals for research on:

- The effect of deliberate and measurable changes to culture and climate affect on staff retention rates, and the impact on both voluntary and involuntary separations on culture and climate and vice versa.
- The effectiveness of newly implemented recruitment and retention strategies and their impact on culture and climate.

Promoting and Sustaining Organizational Cultural Change

Research suggests that the organizational culture of the corrections agency has a major impact on its staff and their interactions with people in their custody and care. [8] NIJ is interested in research that provides practical and policy guidance to correctional practitioners as they strive to maintain a healthy agency organizational culture and implement positive cultural change over time. Implicit in this goal is an understanding of how culture and climate can facilitate or hinder the implementation of changes to policy and practice. Organizational culture and climate exert influence over many, if not all, aspects of the correctional organization, yet research is limited about how to measure correctional organizational culture and climate and assess what factors promote positive change. [9] Correctional practitioners have scant evidence-based guidance on how to maintain a healthy culture over time or how to implement cultural change when the culture has diverged from the mission of the agency. Therefore, NIJ is interested in proposals that:

- Examine agency strategies to measure congruence between an agency's organizational culture and its mission and vision.
 - This would include evaluations of changes to strategies that aim to promote a more positive organizational culture and climate.
- Research on perceptions of organizational culture and climate among all stakeholders, from correctional leadership to officers, staff, and incarcerated persons, and how these perceptions impact policy and practice implementation.
- Assessments of how culture and climate impact attitudes towards service delivery among staff and incarcerated persons.
- Assessments of the degree to which improvements in organizational culture impact access to, and the quality and effectiveness of, correctional programs.
 Assessments of the degree to which trauma-responsive practices and programming improve culture, climate, and related outcomes for all relevant stakeholders.

Proposals should clearly indicate which focus area(s) the research proposal will address.

Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish for further information on high-quality evaluation design elements.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to develop evidence to inform our understanding of the factors that contribute to correctional culture and climate, what works to improve correctional culture and climate, and the impacts of such efforts on outcomes related to the health and safety of correctional staff and incarcerated populations and the recruitment and retention of correctional staff.

Objectives

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

The primary objective of this solicitation is to award research grants to generate and

advance knowledge regarding efforts to measure and improve culture and climate and their impacts on: 1) the safety, health, and wellness of both correctional staff and incarcerated persons; (2) issues of correctional agency staffing, retention, and training as they pertain to correctional culture and the well-being of staff and incarcerated persons; and (3) strategies that promote and sustain needed change in the organizational cultural of corrections agencies.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial

equity **and** the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project (s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive at least 40% of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally* specific organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut). Asian Americans, Native Hawaiians, and/or Pacific Islanders.

2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

MSIs include:

- Historically Black Colleges and Universities (HBCU)
- Hispanic-serving Institutions (HSI)
- Tribal Colleges and Universities (TCU)
- Alaska Native-serving Institutions or Native Hawaiian-serving Institutions (ANNH)
- Predominantly Black Institutions (PBI)

3. Potential Impact

The **SF-424 and the SF-LLL** must be submitted in Grants.gov by 11:59 p.m. eastern time on August 07, 2023.

The **full application** must be submitted in JustGrants by 8:59 p.m. eastern time on August 21, 2023.

OJP urges applicants to submit their Grants.gov and JustGrants submissions prior to the due dates with sufficient time to correct any errors and resubmit by the submission deadlines if a rejection notification is received. To be considered timely, the **full application** must be submitted in JustGrants by the JustGrants application deadline. Failure to begin the SAM.gov, Grants.gov, or JustGrants registration process in sufficient time (i.e., waiting until the date identified in this solicitation) is not an acceptable reason for late submission.

Experiencing Unforeseen Technical Issues Preventing Submission of an Application

OJP will only consider requests to submit an application after the deadline when the applicant can document that a technical issue with a government system prevented application submission.

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline. - Demonstrated awareness of the state of current research.

Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of proposed project.
- Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- Feasibility of completing the deliverables noted in the solicitation.

Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (15%)

Potential Impact (20%)

- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.

Budget (5%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

Other Review Criteria/Factors

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.
