The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) is seeking an application for a sub-study that incorporates measures of delinquency and victimization at five sites of the Adolescent Brain Cognitive Development (ABCD) Study funded by the National Institute on Drug Abuse (NIDA). This program furthers the Department's strategic plan goals to keep our country safe by combating violent crime and protecting children from crime and exploitation.

# **Program Description**

#### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ, in partnership with Centers for Disease Control and Prevention (CDC), seeks to provide funding for a sub-study involving five of the 21 NIDA-funded ABCD Study sites to include measures of delinquency and victimization in their investigations.

**Statutory Authority:** Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202).

# **Specific Information**

The ABCD: SD Sub-study will address key questions on the interactions between substance use, brain development, delinquency, juvenile justice system involvement, and victimization. Continuation funding under this supplemental grant award will support a coordinating center and longitudinal collection of data at five sites. NIJ intends to fund subsequent waves of data collection via supplements to this award in order to follow the children into young adulthood. NIJ anticipates making yearly supplemental awards to support up to approximately 10 years beyond the initial start date of this study on January 1, 2018, depending on the duration of the main, NIDA-funded ABCD study.

# Goals, Objectives, and Deliverables

#### Goals

The goal of this solicitation is to fund a coordinating site to manage the multi-site ABCD: SD Sub-study. NIJ strives to provide objective and independent knowledge to keep our country safe by combating violent crime and protecting children from crime and exploitation.

### **Objectives**

The objective of this solicitation is to provide high-quality research on the nexus between substance use, participation in delinquency, victimization experiences, and brain development.
