Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) is seeking an application for funding to support the project—*Life Course and Intergenerational Effects of Criminal Justice Involvement: Identifying Risks, the Search for Resilience, and the Impact of Rise in Opioid Misuse and the COVID-19 Pandemic*. This project seeks to extend the existing data collection for the Rochester Youth Development Study (RYDS) and its intergenerational extension, the Rochester Intergenerational Study (RIGS). This program furthers the goals of DOJ's strategic plan to keep our country safe by combating violent crime and protecting children from crime and exploitation.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks to support the original goals of NIJ Fiscal Year (FY) 2020 competitive grant solicitation—Longitudinal Research on Delinquency and Crime. NIJ awarded Grant # 2020-MU-MU-0017 to the University of Texas at San Antonio (UTSA) to support the project *Life Course and Intergenerational Effects of Criminal Justice Involvement: Identifying Risks, the Search for Resilience, and the Impact of Rise in Opioid Misuse and the COVID-19 Pandemic*. This invitation is for an application to support the continued data collection under this project by the research team now led by Florida State University (FSU) along with its subrecipient partners Pennsylvania State University and Colorado State University.

Specific Information

This project seeks to extend the existing data collection for the Rochester Youth Development Study (RYDS) and its intergenerational extension, the Rochester Intergenerational Study (RIGS). RYDS was initiated by the Office of Juvenile Justice and Delinquency Prevention (OJJDP) as one of three prospective, longitudinal studies to investigate the causes and correlates of delinquency and drug use during childhood and adolescence utilizing a developmental approach to the study of crime. RYDS began in 1988 with the enrollment of 1,000 public middle school students Generation 2s (G2s) and their primary guardian (G1s). The researchers purposefully used a stratified sampling approach to over-represent those students who were considered to be at higher risk for serious delinquency and drug use by: (1) oversampling males, and (2) oversampling adolescents from areas of Rochester where high proportions of adult offenders lived. The initial RYDS sample was 73% male and predominantly African American (68% African American, 17% Hispanic, and 15% white).

The extension of RYDS would include two additional biannual interviews of the original youth sample and updating their criminal history record information. These data collection will allow the researchers to construct patterns of offending and criminal justice involvement from adolescence through middle adulthood, examine the correlates and consequences associated with these patterns of behavior, and examine whether these patterns of behavior moderate the impact of COVID-19 on social, economic, and health

outcomes.

The extension of RIGS would include: expanding the next generation (G3s) sample to all eligible first-born children of G2s; conducting two biannual interviews with a sample size of approximately 640 G3s born in 2003 or earlier (making them at least 18 years of age in 2022, the year of the next interview wave); and collecting criminal history record information for the G3 sample.

This inquiry will include the exploration of continuity and the search for patterns of resilience and escalation (as well as potential mediating factors) in order to identify malleable targets for prevention and intervention programming to prevent late-onset and/or escalation in offending and other risk behavior. The expansion of the data collection would include development and collection of content related to: COVID-19; the opioid epidemic; Adverse Childhood Experiences (ACEs) such as incarceration, suicidality, and homelessness; community disadvantage and risk factors; and patterns of residential mobility.

Goals, Objectives, and Deliverables

Goals

The major goals of this project are to extend the RYDS and its intergenerational extension, the RIGS, with two rounds of data collection for each component of the study.

Objectives

The objectives of this project are:

- Identify adolescent and early adulthood correlates and causes of patterns of offending and criminal justice involvement through middle adulthood.
- Investigate the social, economic, and health outcomes associated with patterns of offending and criminal justice involvement through middle adulthood.
- Investigate how patterns of offending and criminal justice system involvement moderate the impact of the COVID-19 pandemic on social, economic, and health outcomes in middle adulthood.
- Identify patterns of intergenerational continuity and discontinuity (resilience and escalation) in maladaptive and offending behavior in early adulthood.
- Investigate the relationship between individual-, familial-, school-, peer-, and community-level factors with escalation in offending and desistance/resilience in maladaptive behaviors and offending within and across generations.
- Investigate if COVID-19 moderates patterns of intergenerational (dis)continuity in maladaptive and offending behavior.

Deliverables

The grantee funded under this solicitation is required to produce several deliverables.

Final Research Report. The Final Research Report is a manuscript that summarizes study methodology, project activities, and key findings. This Report is intended for a public audience and will undergo review for public archive on the NCJRS Web site. How to Apply

Registration: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step

process via Grants.gov and JustGrants.

Step 1: After registering with SAM, the applicant must submit the **SF-424** and an **SF-LLL** in Grants.gov at <https://www.grants.gov/web/grants/register.html> by the Grants.gov deadline. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

Step 2: The applicant must then submit the **full application**, including attachments, in JustGrants at JustGrants.usdoj.gov by the JustGrants deadline.

Within 24 hours after receipt of confirmation emails from Grants.gov, the individual in Section 8F of the SF-424 will receive an email from DIAMD-NoReply@usdoj.gov with instructions on how to create a JustGrants account. Register the Entity Administrator and the Application Submitter with JustGrants as early as possible but no later than 48-72 hours before the JustGrants deadline. Once registered in JustGrants, the Application Submitter will receive an emailed link to complete the rest of the application in JustGrants. The Entity Administrator also will need to log into JustGrants to review and invite the applicant's Authorized Representative(s) before an application can be submitted.

Submit the complete application package in JustGrants at least 24 – 48 hours prior to the JustGrants deadline. Some of the application components will be entered directly into JustGrants, and others will require uploading attached documents. Therefore, applicants will need to allow ample time before the JustGrants deadline to prepare each component. Applicants may save their progress in the system and revise the application as needed prior to hitting the Submit button at the end of the application in JustGrants.

OJP urges applicants to submit their Grants.gov and JustGrants submissions prior to the due dates with sufficient time to correct any errors and resubmit by the submission deadlines if a rejection notification is received. To be considered timely, the full application must be submitted in JustGrants by the JustGrants application deadline. Failure to begin the SAM.gov, Grants.gov, or JustGrants registration process in sufficient time (i.e., waiting until the date identified in this solicitation) is not an acceptable reason

for late submission.

Experiencing Unforeseen Technical Issues Preventing Submission of an Application

OJP will only consider a request to submit an application after the deadline when the applicant can document that a technical issue with a government system prevented application submission.

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline.
