Synopsis

Program Description Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) is seeking an application for funding to support the project "Safe Transitions for Teens: Assessing the Impact of Intimate Partner Transitional Housing on Adolescent Residents." NIJ seeks an application for a study that will fill a gap in research on community-level interventions to reduce risk and increase protective factors for intimate partner violence-exposed teens. This project furthers the goals of DOJ's strategic plan to keep our country safe by combating violent crime and protecting children from crime and exploitation.

OJP is committed to advancing work that promotes civil rights and equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety, protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

Program Description

Program Description Overview

With this solicitation, NIJ seeks a proposal for rigorous research to support the development of objective and independent knowledge and validated tools to reduce violence against women and children, promote justice for victims of crime, and enhance criminal justice responses. For that reason, this solicitation seeks an application for grant funding to conduct research on a project titled "Safe Transitions for Teens: Assessing the Impact of Intimate Partner Transitional Housing on Adolescent Residents."

Statutory Authority

Pub. L. No. 117-103, 136 Stat 49, 121; 28 USC 530C.

Specific Information

The project is entitled "Safe Transitions for Teens: Assessing the Impact of Intimate Partner Transitional Housing on Adolescent Residents." Adolescents exposed to adult intimate partner violence (IPV) are at high risk for teen dating violence (TDV), bullying perpetration and victimization, peer violence, and juvenile justice system (JJS) involvement, creating the potential for polyvictimization experiences with consequences across the lifespan. Housing and homelessness are pressing issues for families exposed to IPV. However, there is a gap in research on community-level interventions to reduce risk and increase protective factors for exposed teens. IPV transitional housing (IPVTH) programs provide housing and support services to families who have experienced IPV but remain primarily untested— especially for the impact on adolescent residents. To address these gaps, the research team will use the structure of an Office on Violence Against Women (VAW)-funded study, "Safe Transitions," which examines the longitudinal effects of IPVTH among adult residents, to recruit an adolescent cohort of IPVTH residents and analyze the impact of supportive housing on adolescent violence. This project, "Safe Transitions for Teens," will develop knowledge on trajectories of risk behaviors for teens in IPVTH, parent-child relationship impacts, and the role of IPVTH in addressing risk and increasing protective factors for interpersonal violence victimization and perpetration in a high-risk group of adolescents.

The investigators will conduct semi-structured interviews with 40 adult parents enrolled in the "Safe Transitions" study, 40 of their adolescent children, and 30 IPVTH service providers. Using learning from qualitative analysis, the research team will recruit and longitudinally follow 250 adolescent IPVTH residents (aged 12-17) whose parents are enrolled in Safe Transitions. The study will employ a mixed-method, multi-generational, longitudinal approach to examine the prevalence of TDV, peer violence, bullying, and JJS involvement at five time points over two years among adolescent IPVTH residents. In addition, they will test the impact of IPVTH on adolescent and family risk and protective factors for adolescent violence. Repeated measures hierarchical linear modeling will be used to assess outcomes over time and differences in risk and protective factors for parent-adolescent dyads. Thematic analysis will be used for qualitative data.

Adolescents living with their parents in IPVTH will be recruited from existing Safe Transitions sites in five states – Florida, Indiana, Kentucky, Michigan, and Texas – and additional sites

being onboarded. An advisory board of subject matter experts, including the National Coalition Against Domestic Violence, will guide the study. Additions to the Safe Transitions website (i.e., https://ccie.ucf.edu/safe-transitions/) will facilitate real-time dissemination. Manuscripts, brief reports, webinars, and conference presentations will be produced for academic and practitioner outlets, participating agencies, and NIJ. In addition, the final research report and study data will be archived at the National Archive of Criminal Justice Data (NACJD).

Solicitation Goals and Objectives

Goals

The ultimate goal of this project is to gain an understanding of the role of IPV-specific transitional housing and supportive services in interrupting risk and increasing protective factors related to interpersonal violence victimization and perpetration in a high-risk group of teens exposed to IPV.

Objectives

This solicitation seeks to support a rigorous study that will result in independent knowledge and validated tools and disseminate them to stakeholders and policymakers to formulate strategies and practices to reduce VAWC. Using a mixed method, multi-generational, longitudinal approach, the research team will 1) examine the prevalence of sexual, physical, psychological, and cyber TDV, peer violence, bullying, and JJS involvement in a group of adolescents living in IPVTH and 2) test the impact of IPVTH intervention on teen and family risk and protective factors for teen violence, including parental safety from IPV.

Specific objectives are to:

- Assess prevalence rates and changes over time of TDV victimization and perpetration among adolescent 250 IPVTH residents recruited from parents enrolled in the current Safe Transitions study through longitudinal assessments spanning 24 months and semistructured interviews.
- Assess prevalence rates of peer violence, bullying, and JJS involvement among adolescent IPVTH residents.
- Examine intergenerational changes in risk and protective factors for IPV and TDV, including parental safety from IPV, through linked analysis of adolescent participants in Safe Transitions for Teens and adult participants in Safe Transitions.
- Examine IPVTH housing program efficacy to increase protective factors and decrease risk factors related to TDV, peer violence, bullying and JJS involvement through longitudinal survey assessments, interviews, and agency data review.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the

project's findings and/or to extend the scientific value of the data set through secondary analysis. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

Proposal Narrative

The Proposal Narrative should be submitted as an attachment in JustGrants. The attached document should be double-spaced, using a standard 12-point size font; have no less than 1-inch margins; and should not exceed 30 numbered pages. Program narrative tables, charts, and graphs should also comprise legible font (i.e., 12-point).

The Proposal Narrative must include the following sections:

a. Statement of the Problem

The statement of the problem should address the need for research on adolescents exposed to adult intimate partner and other violence (e.g., teen dating violence, bullying perpetration and victimization, peer violence, and juvenile justice system involvement) and the consequences across the lifespan. Specifically, the problem statement should discuss how adolescents' experiencing housing insecurity and homelessness is a pressing issue. Applicants should discuss current gaps in data, research, and knowledge. As part of this discussion, applicants should demonstrate thorough knowledge of the extant scientific literature in the field related to the(se) problem(s) using primary and secondary sources.

b. Project Design and Implementation

Applicants should also provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the programspecific information noted in the solicitation. Applicants should describe the research methods and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities. Applicants must address all sensitive human subjects' privacy, protection, and confidentiality issues.

c. Capabilities and Competencies

This section should describe the experience and capabilities of the applicant organization, all key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude.
