Program Description

Overview

The purpose of this solicitation is to provide funding for operation of the Secretariat of Subcommittee 37 (SC 37) under the Joint Technical Committee 1 (JTC 1) of the International Organization for Standardization/International Electrotechnical Commission (ISO/IEC).

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); the Homeland Security Act of 2002 (sections 231 – 233, 235); and 28 U.S.C. 530C.

Specific Information

One of NIJ's legislated duties is to promulgate standards and conformity assessment activities that benefit law enforcement and other criminal justice agencies. This includes development of minimum performance requirements and testing of biometric technologies such as facial-recognition software. To further that end, NIJ supports operation of the Secretariat of Subcommittee 37 (SC 37) under the Joint Technical Committee 1 (JTC 1) of the International Organization for Standardization (ISO). The scope of SC 37 is the standardization of generic biometric technologies pertaining to human beings to support interoperability and data interchange among applications and systems.

Goals, Objectives, Deliverables, and Timeline Goals

The major goals for this project are to provide to ISO/IEC JTC 1/SC 37 (Biometrics) and its Working Groups the reliable and competent leadership, management, and administration required to effectively complete its standards development and maintenance in accordance with the requirements specified in the ISO/IEC Directives, including the operation of ISO/IEC JTC 1/SC 37 meetings.

Objectives

The goals of the project are to be accomplished through the following objectives:

1) Convene international meetings of ISO/IEC JTC 1/SC 37 for the purpose of achieving consensus on the standards under development within ISO/IEC JTC 1/SC 37.

2) Oversee the management and progress of the program of work of each ISO/IEC JTC 1/SC 37 Working Group against established target dates.

3) Collaborate with the ISO/IEC JTC 1/SC 37 Chairman to prepare and circulate to all member countries all required reports following ISO/IEC JTC 1/SC 37 meetings.

4) Attend U.S. Technical Advisory Group (TAG) meetings for ISO/IEC JTC 1/SC 37 (INCITS M1) in order to provide U.S. participants on the U.S. TAG (INCITS M1) expert guidance on procedural issues.

Deliverables

Deliverables for this project include:

1) Semi-annual progress reports detailing the status of ISO/IEC JTC 1/SC 37 work items.

2) Meeting-related materials, such as agendas, minutes, presentation materials, and reports, as applicable.
