The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) is seeking applications for funding for research projects addressing the use of technologies such as texting, mobile applications, telecommunications networks, and social networking to bully, harass, stalk, or intimidate another person, including adolescents. Examples of technology-facilitated abuse include cyberstalking, sextortion, non-consensual pornography, doxing, or swatting. This program furthers the Department's mission by combating violent crime, promoting safe communities, and upholding the rights of victims of crime.

This solicitation incorporates the <u>OJP Grant Application Resource Guide</u> by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications for funding to OJP. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Eligibility (Who may apply)

In general, NIJ is authorized to make grants to, or enter into contracts or cooperative agreements with eligible entities as listed below:

- States (including territories);
- Units of local government;
- Federally recognized Indian tribal governments that perform law enforcement functions (as determined by the Secretary of the Interior);
- Nonprofit and for-profit organizations (including tribal nonprofit and for-profit organizations); and

• Institutions of higher education (including tribal institutions of higher education).

Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

NIJ will consider applications under which two-or-more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). The applicant must be the entity that would have primary responsibility for carrying out the award, including administering the funding and managing the entire project. Under this solicitation, any particular applicant entity may submit more than one application, as long as each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient ("subgrantee") in more than one application.

A. Program Description

Overview

With this solicitation, NIJ seeks proposals for research projects addressing the use of technologies such as texting, mobile applications, telecommunications networks, and social networking to bully, harass, stalk, or intimidate another person — including adolescents. Examples of technology-facilitated abuse include cyberstalking, sextortion, non-consensual pornography, doxing, or swatting. NIJ will support scientifically rigorous research projects that will advance understanding of these types of crime; and effective approaches for identifying, preventing, investigating, and prosecuting them. This solicitation supports the U.S. Department of Justice's strategic goals associated with reducing crime, supporting prosecutors, and reducing victimization.¹

Applications proposing research involving partnerships with criminal justice or other agencies are to include a strong letter of support, signed by an appropriate decision-making authority from each proposed partnering agency. A letter of support must include the partnering agency's acknowledgement that de-identified data provided through this project will be archived by the awardee in the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award (please see "Goals, Objectives, Deliverables, and Expected Scholarly Products," below). If selected for award, applicants will be expected to have a formal agreement in place with partnering agencies by January 1, 2021. That agreement must include provisions to meet the data archiving requirements of the award.

In rare circumstances — for example where law prohibits the archiving of agency data — NIJ may agree to a successful applicant creating and archiving an appropriate synthetic dataset. Those circumstances will be rare, decided by NIJ on a case-by-case basis, and will require extensive documentation and justification for exceptions to be made.

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202).

Project-Specific Information

Technology-facilitated abuse is the use of technologies such as texting, mobile applications, telecommunications networks, and social networks, to bully, harass, stalk, or intimidate another

person — including adolescents. In most cases, the perpetrator is usually someone the victim knows, and often in the context of intimate partner violence.²

Criminals seek to use computers, smart devices, other chip-enabled technologies and the networks that connect them, to victimize individuals. Perpetrators exploit the global reach, connectivity, and anonymity of information technology services to commit a wide range of cybercrimes targeting specific individuals. Some of these crimes are intended primarily to enrich the perpetrator. Others are intended primarily to harm the victim.

Many of the crimes intended to harm the individual represent reprehensible and sometimes dangerous violations of the victim's privacy rights, and can have a lasting, damaging impact. Criminals use online tactics to gain access to sensitive, often sexually-explicit information that they use to extort, harass, or stalk individuals, including vulnerable youths and young adults.³

With this solicitation, NIJ seeks applications for research and evaluation projects that will improve knowledge and practice related to identifying, preventing, investigating, prosecuting, and reducing technology-facilitated abuse, including sextortion, nonconsensual pornography (revenge porn), doxing, swatting, and cyberstalking. NIJ will support scientifically rigorous projects designed to produce highly practical findings that will inform program, policy, practice, and other efforts to address such crimes.

For the purposes of this solicitation, the following definitions apply:

- Sextortion Sexual exploitation in which offenders coerce or blackmail victims into providing sexually explicit images or videos of themselves.⁴ Offenders may use hacking, grooming, sexting within a romantic relationship, and scams to obtain the explicit images.⁵ In a recent study, five percent of adolescents reported being victims of sextortion, while three percent admitted to being a perpetrator of sextortion.⁶
- Nonconsensual pornography Also known as revenge porn, refers to the distribution
 of sexually graphic images of individuals without their consent.⁷ The images may be
 posted online, often with identifying information and links to social media profiles; or may
 be sent directly to the victim's co-workers, friends, and family.⁸
- "Doxing" Short for "dropping documents," is the practice of disclosing a person's identifying information (e.g., their home address) on the Internet to retaliate against and harass the "outed" person. This type of crime can turn data into a weapon, and personally identifiable information is readily available to criminals who engage in doxing through people-finder websites. According to the United States Attorney's Office, doxing

can expose the victim to harassers calling their phones, sending them email, and even appearing at the victim's home.¹⁰

- Swatting A false 911 call made to police in which a false report of a violent crime is made to elicit a police Special Weapons and Tactics squad ("SWAT") response to the physical address of a targeted individual, his or her family members, or place of employment.¹¹ Committed as a hoax, swatting has serious consequences. In 2017, Andrew Finch was inadvertently killed by a police SWAT team responding to a false report of a violent crime at his residence.¹²
- Cyberstalking Any unwanted contact between two people via email, social media, text
 messaging, GPS, and other online resources that directly or indirectly communicates a
 threat or places the victim in fear.¹³ Cyberstalking may include repeated, unwanted,
 intrusive, and frightening communications from the perpetrator by phone, email, or other
 forms of communication; harassment and threats communicated through the Internet,
 such as social media sites; and the posting of information or spreading rumors about the
 victim on the Internet.¹⁴

NIJ is particularly interested in projects addressing the following topics:

- Risk and protective factors associated with an individual falling victim to technologyfacilitated abuse, as well as how individuals or organizations become involved in these types of crimes.
- Studies of the costs and consequences of technology-facilitated abuse (financial and otherwise), as well as how Internet-enabled harassment may be related to other crime(s).
- Studies of the effectiveness of approaches in identifying, preventing, investigating, and prosecuting technology-facilitated abuse. (This may include consideration of legislation and/or training).

Funding may only be used to cover costs associated with evaluation or research activities. It may include reasonable costs such as those incurred by program personnel to support activities directly required for the execution of the project (e.g., manual extraction of administrative records) or those associated with serving on an advisory board to provide input on analyses or interpretation of findings.

Applications not proposing research and evaluation projects that will improve knowledge and practice related to identifying, preventing, investigating, prosecuting, and reducing technology-facilitated abuse will be rejected.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators. To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution; and
- Have completed a terminal degree or post-graduate clinical training within the ten (10) years prior to September 30, 2020; and
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows or Data Resources Program grantees.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that they are submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, Deliverables, and Expected Scholarly Products

The ultimate goal of this solicitation is to develop knowledge that will improve the ability to identify, prevent, and reduce cybercrime against individuals in the United States, and to hold those who perpetrate cybercrimes accountable.

<u>Draft Research Report Outline</u>. An annotated outline including preliminary findings with draft tables, figures, and other relevant graphics is required approximately sixty (60) days prior to the grant end date for NIJ to review.

<u>Briefing</u>. An NIJ briefing to be delivered in Washington, DC is required approximately thirty (30) days prior to the grant end date. Presentation materials including a handout and PowerPoint slides that summarize research methods and findings are due in draft form no later than ten (10) business days in advance of the briefing, for NIJ to review.

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement can be found on the <u>Research</u>, <u>Development</u>, <u>and Evaluation Grant Award Requirements</u> page on the NIJ website. The Final Research Report will undergo review for public archive on the <u>National Criminal Justice Reference Service</u> (NCJRS).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce

the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures described in <u>Section F. The Goals, Objectives, Deliverables, and Expected Scholarly Products are directly related to the performance measures that demonstrate the results of the work completed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that include evaluation research should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision making.

Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be taken into account when selecting an evaluation design. In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed.

This solicitation expressly modifies the OJP Grant Application Resource Guide by not incorporating the "Disclosure of Process Related to Executive Compensation" provisions in the "Application Attachments" section of the OJP Grant Application Resource Guide.

The following application elements MUST be included in the application submission for an application to meet the basic minimum requirements (BMR) to advance to peer review and receive consideration for funding: Program Narrative, Budget Detail Worksheet (including Budget Narrative), and resumes/curriculum vitae of key personnel. (For purposes of this solicitation, "key personnel" means the principal investigator, and any and all co-principal investigators.)

1. Application for Federal Assistance (Standard Form (SF)-424)

The SF-424 is a required standard form used as a cover sheet for submission of preapplications, applications, and related information. See the <u>OJP Grant Application Resource</u> <u>Guide</u> for additional information on completing the SF-424.

Intergovernmental Review: This solicitation ("funding opportunity") **is not** subject to <u>Executive Order 12372</u>. (In completing the SF-424, an applicant is to answer question 19 by selecting the response that the "Program is not covered by E.O. 12372.")

2. Project Abstract

The project abstract is a very important part of the application, and serves as an introduction to the proposed project. NIJ uses the project abstract for a number of purposes, including

assignment of the application to an appropriate review panel. If the application is funded, the project abstract typically will become public information and be used to describe the project.

Applications should include a high quality project abstract that summarizes the proposed project in no more than 400 words. Project abstracts should be:

- Written for a general public audience.
- Submitted as a separate attachment with "Project Abstract" as part of its file name.
- Single-spaced, using a standard 12-point Times New Roman font with 1-inch margins.

As a separate attachment, the project abstract will not count against the page limit for the program narrative.

Project abstracts should follow the detailed template (including the detailed instructions as to content) available on the NIJ webpage.

3. Program Narrative

The program narrative section of the application should not exceed *30* double-spaced pages in 12-point font with 1-inch margins. If included in the main body of the program narrative, tables, charts, figures, and other illustrations count toward the *30*-page limit for the narrative section. The project abstract, table of contents, appendices, and government forms do not count toward the *30*-page limit.

If the program narrative fails to comply with these length-related restrictions, NIJ may negatively consider such noncompliance in peer review and in final award decisions.

Program Narrative Guidelines:

a. Title Page (not counted against the-page program narrative limit)

The title page should include the title of the project, submission date, funding opportunity number, and the name and complete contact information (that is, address, telephone number, and email address) for both the applicant and the principal investigator.

b. Resubmit Response (if applicable) (not counted against the-page program narrative limit)

If an applicant is resubmitting an application presented previously to NIJ, but not funded, the applicant should indicate this. A statement should be provided, no more than two pages, addressing: (1) the title, submission date, and NIJ-assigned application number of the previous application, and (2) a brief summary of revisions to the application, including responses to previous feedback received from NIJ.

c. Table of Contents and Figures (not counted against the-page program narrative limit)

d. Main Body

The main body of the program narrative should describe the proposed project in depth. The following sections should be included as part of the program narrative:

Statement of the Problem and Research Questions. The statement of the problem should address the need for research in this area. Applicants should discuss current gaps in data, research, and knowledge, including those for particular justice sectors, for certain populations, and to answer questions relevant to current policy and practice needs and public interests. As part of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

This section should also identify the proposed research questions and discuss the purpose, goals, and objectives of the proposed project.

- Project Design and Implementation. Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted on page 5. Applicants should describe the research methodology in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.
- <u>Potential Impact</u>. Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States.

The discussion of impact should include a discussion of the deliverables, including planned scholarly products indicated in the project-specific information on page 8 and a plan for dissemination to appropriate audiences. Applicants should identify plans to produce or make available to broader interested practitioners and policy makers in a form that is designed to be readily accessible and useful to them.

- Capabilities/Competencies. This section should describe the experience and capability of the applicant organization, key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude. Applicants should address:
 - Experience and capacity to work with the proposed data sources in the conduct of similar research efforts.
 - Experience and capacity to design and implement rigorous research and data analysis projects.
 - Experience producing and disseminating meaningful deliverables.

Applicants should also outline the management plan and organization that connects to the goals and objectives of the project.

- e. Appendices (not counted against the-page program narrative limit) include:
 - Bibliography/references.
 - Any tools/instruments, questionnaires, tables/charts/graphs, or maps pertaining to the proposed project that are supplemental to such items included in the main body of the parrative.
 - Curriculum vitae or resume of the principal investigator and any and all co-principal
 investigators. In addition, curriculum vitae, resume, or biographical sketches of all
 other individuals (regardless of "investigator" status) who will be significantly involved
 in substantive aspects of the proposed project (including, for example, individuals
 such as statisticians used to conduct proposed data analysis).
 - To assist OJP in assessing actual or apparent conflicts of interest (including such conflicts on the part of prospective reviewers of the application, a complete list of the individuals named or otherwise identified anywhere in the application (including in the budget or in any other attachment) who will or may work (or advise or consult) on the proposed research, development, or evaluation project. This applies to all such individuals, including, for example, individuals who are or would be employees of the applicant or employees of any proposed subrecipient entity, any individuals who themselves may be a subrecipient, and individuals who may (or will) work without compensation (such as advisory board members). This appendix to the program narrative is to include, for each listed individual: name, title, employer, any other potentially-pertinent organizational affiliation(s), and the individual's proposed roles and responsibilities in carrying out the proposed project. If the application identifies any specific entities or organizations (other than the applicant) that will or may work (or advise or consult) on the proposed project, without also naming any associated individuals, the name of each such organization also should be included on this list.

Applicants should use the "Proposed Project Staff, Affiliation, and Roles" form available on the NIJ webpage to prepare this list.

If the application (including the budget) identifies any proposed non-competitive agreements that are or may be considered procurement "contracts" (rather than subawards) for purposes of federal grants administrative requirements the applicant also must list the entities with which the applicant proposes to contract. Applicants should provide this list as a separate sheet entitled "Proposed non-competitive procurement contracts."

For information on distinctions — for purposes of federal grants administrative requirements — between subawards and procurement contracts under awards, see "Budget Information and Associated Documentation," below.

- Applicants proposing to use incentives or stipends payments as part of their research project design, must submit an incentive or stipend approval request, as a separate document, according to the requirements set forth at https://nij.ojp.gov/funding/participant-support-costs-and-incentives-social-science-research.
- Data archiving plan. Applicants should anticipate that NIJ will require (through special award conditions, that data sets resulting in whole or in part from projects funded under this solicitation be submitted for archiving with the NACJD. Applications should include as an appendix a brief plan — labeled "Data Archiving Plan" — to comply with data archiving requirements. Applications that meet basic minimum requirements will be evaluated by peer reviewers using the following review criteria.

Statement of the Problem and Research Questions (Understanding of the problem, research questions, and their importance) -5%

- 1. Demonstrated understanding of the problem.
- 2. Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- 3. Demonstrated awareness of the state of current research.

Project Design and Implementation (Quality and technical merit) – 50%

- 1. Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- 2. Feasibility of proposed project.
- 3. Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- 4. Feasibility of completing the deliverables noted in the solicitation.

Potential Impact – 20%

Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States, such as:

 Potential for significantly improved understanding of the stated criminal/juvenile justice problem. Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.

Capabilities/Competencies (Capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) – 10%

- 1. Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- 2. Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- 3. Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Plan for Dissemination to Broader Audiences (if applicable to the proposed project) – 15% (Note that item 2 below applies only to applications where a technology-related solution is proposed).

- 1. Strength and feasibility of the proposed plan (if any) to produce or to make available to broader interested audiences, such as criminal/juvenile justice practitioners or policymakers, summary information from the planned scholarly products of the project.
- Strength and feasibility of the proposed plan (if any) to make tool or technology available to state and local criminal justice practitioners through commercialization, distribution, or open-source availability of the proposed tool or technology.

Budget

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- 1. Total cost of the project relative to the perceived benefit (cost effectiveness).
- 2. Appropriateness of the budget relative to the level of effort.
- 3. Use of existing resources to conserve costs.
- 4. Alignment of the proposed budget with proposed project activities.

Review Process

OJP is committed to ensuring a fair and open process for making awards. NIJ reviews the application to make sure that the information presented is reasonable, understandable, measurable, achievable, and consistent with the solicitation.

The following five paragraphs in this solicitation expressly modify the "Application Review Information" provisions in the OJP Grant Application Resource Guide. An applicant is to follow

the guidance in these five paragraphs instead of the guidance stated under the "Application Review Information" heading in the Guide.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether an application meets basic minimum requirements and should proceed to further consideration, OJP screens applications for compliance with those requirements. Although specific requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP programs:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.
- The application, if submitted by an applicant that is a DOJ High-Risk Grantee,¹⁷ or is designated "high-risk" by a federal grant-making agency outside of DOJ, must not have been determined by the Director to pose a substantial risk of program implementation failure, based on 1) the applicant's lack of sufficient progress in addressing required corrective actions necessary for removal of the DOJ High-Risk Grantee (or non-DOJ high-risk) designation, 2) the nature and severity of the issues leading to or accompanying the DOJ High-Risk Grantee (or non-DOJ high-risk) designation, and/or 3) the applicant's expected ability to manage grant funds and achieve grant goals and objectives.

For a list of the application elements that MUST be included in the application submission in order for an application to meet the basic minimum requirements, see "What an Application Should Include" under Section D. Application and Submission Information.

Peer review panels will evaluate, score, and rate applications that meet basic minimum requirements. NIJ may use internal peer reviewers, external peer reviewers, or a combination, to assess applications on technical merit using the solicitation's review criteria. An internal reviewer is a current DOJ employee who is well-versed or has expertise in the subject matter of this solicitation. An external peer reviewer is an expert in the subject matter of a given solicitation who is not a current DOJ employee. Peer reviewers' ratings and any resulting recommendations are advisory only, but are considered carefully.

Other important considerations for NIJ include geographic diversity, strategic priorities, available funding, the planned scholarly products, and the extent to which the Budget Detail Worksheet and Budget Narrative accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant. Among other things to

help assess whether an applicant that has one or more prior federal awards has a satisfactory record with respect to performance, integrity, and business ethics, OJP checks whether the applicant is listed in SAM as excluded from receiving a federal award.

In addition, if OJP anticipates that an award will exceed \$250,000 in federal funds, OJP also must review and consider any information above the applicant that appears in the non-public segment of the integrity and performance system accessible through SAM (currently, the Federal Awardee Performance Integrity Information System, FAPIIS).

Important note on FAPIIS: An applicant, at its option, may review and comment on any information about itself that currently appears in FAPIIS and was entered by a federal awarding agency. OJP will consider any such comments by the applicant, in addition to the other information in FAPIIS, in its assessment of the risk posed by the applicant.

All final award decisions will be made by Director of the National Institute of Justice, who may take into account not only peer review ratings and NIJ recommendations, but also other factors as indicated in this section.
