NIJ continues to strongly encourage prospective applicants to submit executed agreements necessary to carrying out the work proposed with applications if they can be obtained, but with an understanding of the circumstances surrounding the pandemic, NIJ will accept applications without them.

Applicants selected for award will be required to submit completed agreements by January 1, 2021. Funds will be withheld until such agreements have been received.

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) is seeking applications for research into immigration and crime. With this solicitation, NIJ seeks proposals for research projects that increase understanding of the relationships between immigration and crime. This program furthers the Department's mission by sponsoring research to provide objective, independent, evidence-based knowledge to reduce crime and promote safe communities.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit applications for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Eligibility (Who may apply)

In general, NIJ is authorized to make grants to, or enter into contracts or cooperative agreements with eligible entities as listed below:

- States (including territories);
- Units of local government;
- Federally recognized Indian tribal governments that perform law enforcement functions (as determined by the Secretary of the Interior);
- Nonprofit and for-profit organizations (including tribal nonprofit and for-profit organizations); and
- Institutions of higher education (including tribal institutions of higher education).

Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

NIJ will consider applications under which two-or-more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). The applicant must be the entity that would have primary responsibility for carrying out the award, including administering the funding and managing the entire project. Under this solicitation, any particular applicant entity may submit more than one application, as long as each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (“subgrantee”) in more than one application.

Research into Immigration and Crime, Fiscal Year 2020

CFDA No. 16.560

A. Program Description

Overview

With this solicitation, NIJ seeks proposals for research projects that increase the understanding of the relationship between immigration — both legal and illegal — and crime. Applicants should propose research projects that have clear implications for criminal justice policy and practice in the United States. NIJ encourages applicants to submit proposals for innovative approaches to advance the field's rigor and methodology in understanding the relationship between immigration and crime.

This solicitation supports **DOJ Strategic Objective 3.1**: Combat violent crime, promote safe communities, and uphold the rights of victims of crime.

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); Department of Justice Appropriations Act, 2020 (Public Law 116-93).

Project-Specific Information

Applications proposing research involving partnerships with criminal justice or other agencies must include a strong letter of support, signed by an appropriate decision-making authority from each proposed partnering agency. A letter of support must include the partnering agency's acknowledgement that de-identified data provided through this project will be archived by the awardee in the [National Archive of Criminal Justice Data](#) (NACJD) at the conclusion of the award (please see "[Goals, Objectives, Deliverables, and Expected Scholarly Products](#)," below). If selected for an award, applicants will be expected to have a formal agreement in place with partnering agencies by January 1, 2021. That agreement must include provisions to meet the data-archiving requirements of the award.

In rare circumstances — for example, where a law prohibits the archiving of agency data — NIJ may agree to a successful applicant creating and archiving an appropriate synthetic dataset. Those circumstances will be rare, decided by NIJ on a case-by-case basis, and will require extensive documentation and justification for an exception to be made.

Definitions

For this solicitation, NIJ will use the following definitions.

- **Legal residents** — Legal residents include all immigrants who were granted lawful permanent residence; granted asylum; or were admitted as refugees, and nonimmigrants admitted under classes of admission associated with residence (e.g. students and temporary workers, as opposed to tourists) and not required to leave the country.

- **Illegal residents** — Illegal residents are defined as all foreign-born non-citizens who are not legal residents. Most illegal residents either entered the U.S. without inspection, or were admitted temporarily and remained past the date they were required to depart.
- **Native-born citizens** — Native-born citizens are those who are automatically granted citizenship based on their birth in the United States (including the territories of Puerto Rico, the Marianas, Guam, and the U.S. Virgin Islands). This also applies to children born elsewhere in the world to U.S. citizens (with certain exceptions).

These definitions follow those adopted by the U.S. Department of Homeland Security¹ (DHS) except in that rather than “illegal residents,” DHS uses the term “unauthorized residents.”

Discussion

In FY 2019, NIJ issued a solicitation for research into immigration and crime. A list of the projects funded under that solicitation can be found here:

The estimated number of illegal residents in the United States more than tripled between 1990 and 2015, from 3.5 million to 12 million.² This growth has contributed to questions about the relationship between immigration and crime among policymakers, criminal justice practitioners, and researchers. These questions are complicated by two factors related to illegal residents. First, the actual population of illegal residents in the U.S. is unknown. Second, the level of criminality and victimization in this population is not well understood. This occurs for two reasons. Illegal residents may not report their own victimization to law enforcement because of their legal status.³ Additionally, immigration status is not consistently recorded by most official criminal justice data sources (though there are some exceptions).

There have been several meta-analyses and systematic reviews on the relationship between immigration and crime. In a recent meta-analysis of 51 studies published between 1994 and 2014, Ousey and Kubrin identified four study design features that may impact our understanding of the relationship between immigration and crime.⁴ First, most studies tend to operationalize immigration as a foreign born/native-born dichotomy, and thus treat immigrants as a homogeneous group. This fails to account for the variation across immigration types, such as the racial and ethnic composition, country of origin, legal versus illegal status, etc. Second, researchers differ in their operationalization of

crime, and whether they examine all possible crime outcomes, including violent, drug, and property crimes, or a subset of crimes. In their meta-analysis, the immigration-crime effect size varied by how researchers measured crime. Ousey and Kubrin⁵ examined whether trends in immigration were related to changes in the nature of homicide in U.S. cities between 1980 and 2010. They found that the effects of changes in immigration vary for some homicide types and not others. This emphasizes the importance of examining subtypes of offending — for example, disaggregating homicide rates by race/ethnicity, and motive-related homicides (e.g. a homicide in the course of a robbery) versus intimate partner homicides). Third, immigration and crime studies vary in choice of geographic units of analysis. These variations range from comparisons of block groups and neighborhoods to comparisons of major U.S. cities. The choice of geographic unit of analysis affected estimates of the immigration-crime relationship. Finally, immigration and crime studies vary in whether they used cross-sectional or longitudinal approaches. Ousey and Kubrin's meta-analysis revealed evidence of differing effect-size estimates based on a study's use of cross-sectional or longitudinal designs. There is significant variation in findings across studies examining the relationship between immigration and crime due to researchers' choices in the study design features described above.

With this solicitation, NIJ seeks proposals for funding rigorous research projects that provide meaningful insights into the relationship between immigration and crime. Proposed studies should be properly situated within the existing literature regarding immigration and crime, and should describe clearly how they will build upon, or enhance, existing research.

NIJ strongly encourages applicants to propose the most rigorous possible methods for isolating the effects of immigration status on criminality, offending, and victimization; and how those effects may vary based on subtypes of crimes and subtypes of offenders and victims. These may include the use of new and novel data sources, unique operationalizations of key concepts, or innovative analytic methods to examine existing data sets or data sources.

Applicants must describe in detail the sources of data that will be used in the project, the methodology, and analytic plan used to analyze the data, and the limitations of the proposed study. In particular, applications should address the challenges associated with collecting data from illegal residents and how their methodology will account for those challenges.

NIJ is particularly, but not exclusively, interested in funding research on the following topics:

- Comparative studies of criminal activity and victimization between four groups: legal residents; illegal residents who were admitted temporarily and remained past the date they were required to depart; illegal residents who entered the country without inspection; and native-born citizens — NIJ is interested in supporting research on the relationship between immigration and crime that allow distinctions to be made among these four groups. Current immigration and crime research operationalizes immigration using the percent of the foreign-born population. This operationalization conflates legal residents and illegal residents. These comparative studies may also examine:

- Comparisons of immigration and crime data at a more granular level than state- and county-level data; and may include, but should not be limited to, self-reported offending data.
- How criminal activity and victimization may vary based on subtypes of crimes (e.g., types of homicide) and subtypes of offenders and victims (e.g., such as the racial and ethnic composition, country of origin [including native-born], legal status, etc.).
- How geographical changes in immigration patterns of settlement (e.g., traditional immigration destinations and new immigration destinations) may impact criminal activity and victimization, and the utilization of criminal justice system resources over time. NIJ is particularly interested in examining the relationship between immigration and crime in rural areas.
- Comparative studies examining how case processing decisions (e.g., deportation and/or prosecution; civil case processing vs. criminal case processing) regarding illegal residents who come into contact with the criminal justice system may impact criminal activity and victimization — NIJ is interested in studies examining these impacts, at the national, regional, state, or local levels. Among other topics, NIJ is interested in understanding how changes in local, state, and federal policy and practice may affect such impacts over time. NIJ is also interested in studies that would further the understanding of the impact of 8 U.S.C. 1326 (Reentry of removed illegal residents) in deterring illegal re-entry, and the effectiveness of 8 U.S.C. 1325 (Improper entry by illegal residents) in deterring illegal entry.
- Studies of the impact of criminal justice policies and programs used for immigration enforcement on criminal activity and victimization — This includes both local, state, and federal programs (e.g., the Fast Track Program,⁶ the Secure Communities Program,⁷ or the Department of Homeland Security's 287(g) Program⁸). Among other potential research, NIJ would be interested in comparative studies of the effectiveness of state-level programs implemented along the U.S. border.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution; and
- Have completed a terminal degree or post-graduate clinical training within the ten (10) years prior to September 30, 2020; and
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows or Data Resources Program grantees.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that they are submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, Deliverables, and Expected Scholarly Products

The goal of this solicitation is to increase understanding of the relationship between immigration and crime in order to better inform relevant criminal justice policy, practice, and programs.

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement can be found on the [Research, Development, and Evaluation Grant Award Requirements](#) page on the NIJ website. The Final Research Report will undergo review for public archive on the [National Criminal Justice Reference Service](#) (NCJRS).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis. For more information, see Program Narrative in [Section D. Application and Submission Information](#).

In addition to these deliverables (and the required reports and data on performance measures described in [Section F. Federal Award Administration Information](#)), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products.

NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences through articles in trade publications, the development of training manuals, policy briefs, conferences, webinars, and articles for newspapers or magazines.

The Goals, Objectives, Deliverables, and Expected Scholarly Products are directly related to the performance measures that demonstrate the results of the work completed.

Performance Measures

OJP will require each successful applicant to submit regular performance data that demonstrate the results of the work carried out under the award (see “[General Information about Post-Federal Award Reporting Requirements](#)” in [Section F. Federal Award Administration Information](#)).

Applicants should visit OJP’s performance measurement page at www.ojp.gov/performance for an overview of performance measurement activities at OJP.

The application should demonstrate the applicant’s understanding of the performance data reporting requirements for this grant program and detail how the applicant will gather the required data should it receive funding.

Please note that applicants are **not** required to submit performance data with the application. Performance measures information is included as an alert that successful applicants will be required to submit performance data as part of the reporting requirements under an award.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of

participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that include evaluation research should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision making.

Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be taken into account when selecting an evaluation design. In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed.

OJP Priority Areas

Applications proposing activities in the following areas may be given priority consideration:

- Addresses the specific challenges that rural communities face.
- Encouraging program investments in economically distressed communities (Qualified Opportunity Zones).

To receive priority consideration under the rural priority, applicants must describe what makes the geographic service area rural (using U.S. Census or other appropriate government data), how isolated the area is from needed services, and how they will address specific public safety challenges in rural communities.

To receive priority consideration under the Qualified Opportunity Zones priority, applicants must include information that specifies how the project will enhance public safety in the specified QOZs. To allow time for (among other things) any necessary post-award review and financial clearance by OJP of the proposed budget and for any associated responses or other action(s) that may be required of the recipient, applicants should propose an award start date of January 1, 2021.

If the applicant is proposing a project that reasonably could be conducted in discrete phases, with each phase resulting in completion of one or more significant, defined milestones, then NIJ strongly recommends that the applicant structure the application — specifically including the narrative, expected scholarly products, timelines/milestones, and budget detail worksheet and budget narrative — to clearly define each phase. (This is particularly the case if the applicant proposes a project that will exceed — in cost or the length of the period of performance — the amount or length of time anticipated for an individual award (or awards) under this solicitation.) Given limitations on the availability to NIJ of funds for awards for research, development, and evaluation, this information will assist NIJ in considering whether partial funding of applications would be productive. (If, in FY 2020, NIJ elects to fund only certain phases of a proposed project, the expected scholarly products from the partial-funding award may, in some cases, vary from those described above.)

NIJ may, in certain cases, provide additional funding in future years to awards made under this solicitation, through continuation awards. OJP will consider, among other factors, OJP's strategic priorities, a recipient's overall management of the award, and progress of award funded work, when making continuation award decisions.

Under this solicitation, any particular applicant entity may submit more than one application, as long as each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (“subgrantee”) in more than one application.

NIJ may elect to fund applications submitted under this FY 2020 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and on the availability of appropriations.

All awards are subject to the availability of appropriated funds and to any modifications or additional requirements that may be imposed by law.

Type of Award

2. Project Abstract

The project abstract is a very important part of the application, and serves as an introduction to the proposed project. Applications should include a high quality project abstract that summarizes the proposed project in no more than 400 words. Project abstracts should be:

- Written for a general public audience.
- Submitted as a separate attachment with “Project Abstract” as part of its file name.
- Single-spaced, using a standard 12-point Times New Roman font with 1-inch margins.

As a separate attachment, the project abstract will not count against the page limit for the program narrative.

3. Program Narrative

The program narrative section of the application should not exceed 30 double-spaced pages in 12-point font with 1-inch margins. If included in the main body of the program narrative, tables, charts, figures, and other illustrations count toward the 30-page limit for the narrative section. The project abstract, table of contents, appendices, and government forms do not count toward the 30-page limit.

If the program narrative fails to comply with these length-related restrictions, NIJ may negatively consider such noncompliance in peer review and in final award decisions.

The following sections should be included as part of the program narrative.¹⁰

Program Narrative Guidelines:

a. Title Page (not counted against the 30-page program narrative limit)

The title page should include the title of the project, submission date, funding opportunity number, and the name and complete contact information (that is, address, telephone number, and e-mail address) for both the applicant and the principal investigator.

The main body of the program narrative should describe the proposed project in depth. The following sections should be included as part of the program narrative:

- **Statement of the Problem and Research Questions.** The statement of the problem should address the need for research in this area. Applicants should discuss current gaps in data, research, and knowledge, including those for particular justice sectors, for certain populations, and to answer questions relevant to current policy and practice needs and public interests. As part of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

This section should also identify the proposed research questions and discuss the purpose, goals, and objectives of the proposed project.

- **Project Design and Implementation.** Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted on page 5. Applicants should describe the research methodology in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.
- **Potential Impact.** Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States.

The discussion of impact should include a discussion of the deliverables, including planned scholarly products indicated in the project-specific information on page 9 and a plan for dissemination to appropriate audiences. Applicants should identify plans to produce or make available to broader interested practitioners and policy makers in a form that is designed to be readily accessible and useful to them.

- **Capabilities/Competencies.** This section should describe the experience and capability of the applicant organization, key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude. Applicants should address:

- Experience and capacity to work with the proposed data sources in the conduct of similar research efforts.
- Experience and capacity to design and implement rigorous research and data analysis projects.
- Experience producing and disseminating meaningful deliverables.

Applicants should also outline the management plan and organization that connects to the goals and objectives of the project.

e. **Appendices** not counted against the 30-page program narrative limit) include:

- Bibliography/references.
- Any tools/instruments, questionnaires, tables/charts/graphs, or maps pertaining to the proposed project that are supplemental to such items included in the main body of the narrative.
- Curriculum vitae or resume of the principal investigator and any and all co-principal investigators. In addition, curriculum vitae, resume, or biographical sketches of all other individuals (regardless of “investigator” status) who will be significantly involved in substantive aspects of the proposed project (including, for example, individuals such as statisticians used to conduct proposed data analysis).
- To assist OJP in assessing actual or apparent conflicts of interest (including such conflicts on the part of prospective reviewers of the application, a complete list of the individuals named or otherwise identified anywhere in the application (including in the budget or in any other attachment) who will or may work (or advise or consult) on the proposed research, development, or evaluation project. This applies to all such individuals, including, for example, individuals who are or would be employees of the applicant or employees of any proposed subrecipient entity, any individuals who themselves may be a subrecipient, and individuals who may (or will) work without compensation (such as advisory board members). 1. Demonstrated understanding of the problem.
2. Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
3. Demonstrated awareness of the state of current research.

Project Design and Implementation (Quality and technical merit) – 50%

1. Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
2. Feasibility of proposed project.
3. Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
4. Feasibility of completing the deliverables noted in the solicitation.

Potential Impact – 15%

Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States, such as:

- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.

Capabilities/Competencies (Capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) – 20%

1. Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of “investigator” status) who will be significantly involved in substantive aspects of the proposed project).

2. Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
3. Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Plan for Dissemination to Broader Audiences (if applicable to the proposed project)

Peer reviewers may comment — in the context of scientific and technical merit — on strength and feasibility the proposed plan (if any) to produce or to make available to broader interested audiences, such as criminal/juvenile justice practitioners or policymakers, summary information from the planned scholarly products of the project.

Budget

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

1. Total cost of the project relative to the perceived benefit (cost effectiveness).
2. Appropriateness of the budget relative to the level of effort.
3. Use of existing resources to conserve costs.
4. Alignment of the proposed budget with proposed project activities.

Review Process

OJP is committed to ensuring a fair and open process for making awards. NIJ reviews the application to make sure that the information presented is reasonable, understandable, measurable, achievable, and consistent with the solicitation. See

The following five paragraphs in this solicitation expressly modify the “Application Review Information” provisions in the OJP Grant Application Resource Guide. An applicant is to follow the guidance in these five paragraphs instead of the guidance stated under the “Application Review Information” heading in the Guide.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether an application meets basic minimum requirements and should proceed to further consideration, OJP screens applications for compliance with those requirements. Although specific requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP programs:
