The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) is seeking applications for funding for research related to the abuse, neglect, and exploitation of elderly individuals. Research proposed may be focused at the federal, state, local, or tribal justice policy and/or practice level. This program furthers the Department's mission by encouraging and supporting research, development, and evaluation to improve criminal justice policy and practice in the United States.

This solicitation incorporates the <u>OJP Grant Application Resource Guide</u> by reference. The OJP Grant Application Resource Guide provides guidance to applicants on how to prepare and submit to OJP of applications for funding to OJP. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Eligibility (Who may apply)

In general, NIJ is authorized to make grants to, or enter into contracts or cooperative agreements with eligible entities as listed below:

- States (including territories);
- Units of local government;
- Federally recognized Indian tribal governments that perform law enforcement functions (as determined by the Secretary of the Interior);
- Nonprofit and for-profit organizations (including tribal nonprofit and for-profit organizations); and

Institutions of higher education (including tribal institutions of higher education).

Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

NIJ will consider applications under which two-or-more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). The applicant must be the entity that would have primary responsibility for carrying out the award, including administering the funding and managing the entire project. Research on the Abuse, Neglect, and Exploitation of Elderly Individuals, Fiscal Year 2020

CFDA No. 16.560

A. Program Description

Overview

NIJ is seeking applications for funding for research and evaluation projects related to the abuse, neglect, and exploitation of elderly individuals. As the elderly population grows, crimes against this population are expected to increase. NIJ has identified the following three priority areas:

- 1. Research on perpetrators of elder abuse that directly involves the offender;
- 2. Elder abuse reporting pathways, facilitators, barriers, and outcomes; and
- 3. Forensic research involving the development of elder abuse radiographic evidence and bioinformatic approaches for use by physicians.

This solicitation supports **DOJ Strategic Objective 3.1**: Combat violent crime, promote safe communities, and uphold the rights of victims of crime.

Statutory Authority: Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); 28 U.S.C. 530C.

Project-Specific Information

In 2009, the results of the NIJ-funded National Elder Mistreatment Study indicated that 11 percent of elders reported experiencing at least one form of mistreatment — emotional, physical, sexual, or potential neglect — in the prior year. Financial exploitation by a family member was reported by five percent of elders. An eight-year follow-up with the same individuals in the National Elder Mistreatment Study found a strong relationship between reports of elder mistreatment in the first study, and negative emotional and physical health eight years later. However, receiving social support helped to protect elders who had experienced mistreatment from the most negative outcomes. The Government Accountability Office has repeatedly described the growing concern among Americans about the abuse and neglect of persons living in residential care facilities. Current demographic trends show that our society is aging rapidly, and the number of people living in residential care facilities continues to rise. As such, crimes against these populations are expected to increase.

Since 2005, NIJ has made grant awards examining diverse elder mistreatment issues, including:

- Identification of victimization risk factors.
- Measurement of incidence and prevalence of abuse, including resident-on-resident abuse.
- Exploration of residential care systems' mechanisms for responding to abuse.
- Exploration of the factors that contribute to, or are associated with, the financial abuse of the elderly; as well as the factors that promote reporting, and facilitate investigation of such abuse.
- Production of screening and assessment tools for financial exploitation and abuse of the elderly.

Findings from early research investments can be found at the National Criminal Justice Reference Service (NCJRS) and in academic journals. Some examples include:

- Exploring Elder Financial Exploitation Victimization: Identify Unique Risk Profiles and Factors to Enhance Detection, Prevention, and Intervention (2017).
- The Role of Social Support in Elder Financial Exploitation Using a Community Sample (2017).
- <u>The National Elder Mistreatment Study: An 8-year Longitudinal Study of Outcomes</u> (2017).
- Forensic Markers of Physical Elder Abuse: Establishing a Medical Characterization and Identifying the Criminal Justice Approach to Investigation and Prosecution (2019).

Many of the priorities identified in prior NIJ solicitations for research on elder mistreatment have come from the National Research Council's 2003 landmark publication, *Elder Mistreatment: Abuse, Neglect, and Exploitation in an Aging America*³ and subsequent interdisciplinary meetings with researchers and practitioners in the field. The NIJ "Elder Abuse Workshop" from 2008,⁴ and the National Institute of Aging "Meeting on Research Issues in Elder Mistreatment and Abuse and Financial Fraud" held in 2010⁵ were particularly influential in shaping NIJ's research agenda over the past several years.

Although there are many other areas where research is needed to address gaps in our knowledge regarding prevention, detection, and responses to abuse, neglect, and exploitation of elderly individuals, NIJ is seeking proposals that address one the following three priority areas.

1. Research on Perpetrators. There is increasing recognition of the need for a greater understanding of both elder abuse perpetrators and the perpetrator-victim dyad. There

has been some recent growth in our understanding of perpetrators of elder abuse. Findings from a recent analysis of victim reports substantiated by Illinois Adult Protective Services (APS) caseworkers suggest that perpetrators can be characterized according to four different perpetrator subtypes based on the types of abuse they inflict and the characteristics of their victims. The literature on perpetrators of elder abuse remains sparse, fails to include perpetrators directly in the research, and often relies on clinical samples. Our understanding of offenders across types of abuse — and at the same time understanding the characteristics of their victims — must become more sophisticated and nuanced. There is a requisite need to match perpetrator motivations with formal responses that address causative issues. At the same time, there is a need to understand victims' vulnerabilities as they relate to specific categories of perpetrators and types of abuse.

- 2. Elder Abuse Reporting Pathways, Facilitators, Barriers, and Outcomes. The recognition of a lack of vigorous and consistent public response to elder abuse at the state-level provided an important impetus for the passage of the Elder Justice Act of 2010. Despite improved awareness and strategies employed since the passage of the Act, resolution of elder abuse complaints continues to be less than robust. While state-level dynamics vary and influence the diversity of reporting pathways, the identification, investigation, and prosecution of elder abuse remains largely with but not the exclusive domain of state-level adult protective services (APS). Depending upon a variety of factors, including but not limited to the range of mandatory reporters within a jurisdiction, and the elements of the abuse perpetrated, there are a number of pathways by which elder abuse comes to the fore and results in a public response. Not only is there a paucity of research on state-level elder abuse systems response maps, but there is a dearth of information on pathway-specific facilitators, barriers, and outcomes. This knowledge is essential to expanding and improving the public response and outcomes for elders who have been abused.
- 3. Forensic Research. The field of elder abuse detection has benefitted in recent years from research on the bruising patterns in older adults that are likely indicators of physical abuse. There have also been advances in research that permit physicians to distinguish different indicia of intentional mistreatment from accidental injury, illness, and malnutrition. This type of population-specific forensic knowledge is invaluable for both physicians and prosecutors. Medical doctors with this expertise are better able to parse a perpetrator's account of an elder's medical condition. In addition, it provides health professionals with a means of data-driven analysis to determine whether alerting authorities of suspected abuse is warranted. Successful prosecutions also use expert testimony that is a product of reliable principles and methods. Forensic research in this arena would be further buttressed by the development of radiographic evidence and bioinformatic approaches for use by physicians.

Applications proposing research involving partnerships with criminal justice or other agencies must include a strong letter of support, signed by an appropriate decision-making authority from each proposed partnering agency. A letter of support must include the partnering agency's acknowledgement that de-identified data provided through this project will be archived by the awardee in the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award (please see "Goals, Objectives, Deliverables, and Expected Scholarly Products," below).

If selected for an award, applicants will be expected to have a formal agreement in place with partnering agencies by January 1, 2021. That agreement must include provisions to meet the data archiving requirements of the award.

In rare circumstances — for example, where law prohibits the archiving of agency data — NIJ may agree to a successful applicant creating and archiving an appropriate synthetic dataset. Those circumstances will be rare, decided by NIJ on a case-by-case basis, and will require extensive documentation and justification for exceptions to be made.

Goals, Objectives, Deliverables, and Expected Scholarly Products

The goals of this solicitation are to improve knowledge and understanding of elder abuse, neglect, and exploitation. NIJ strives to provide objective and independent knowledge and validated tools to reduce violence against elderly individuals, and promote healing and justice for victims. The objectives of this solicitation are to fund high-quality research projects in the area of elder abuse, neglect, and exploitation.

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement can be found on the <u>Research</u>, <u>Development</u>, <u>and Evaluation Grant Award Requirements</u> page on the NIJ website. The Final Research Report will undergo review for public archive on the <u>National Criminal Justice Reference Service</u> (NCJRS).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis. For more information, see Program Narrative in Section D. Application and Submission Information.

In addition to these deliverables (and the required reports and data on performance measures described in <u>Section F. Federal Award Administration Information</u>), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products.

<u>Technology Prototype</u>: NIJ is seeking applications for funding research, development, and evaluation projects related to the abuse, neglect, and exploitation of elderly individuals. An exemplar of any algorithm, method, software development kit, and training data set resulting from research and development activities funded under this solicitation will be delivered to NIJ at the end of the award for third-party evaluation, along with detailed implementation instructions. Documentation must include descriptions of algorithmic development and approaches to data collection.

NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences through articles in trade publications, the development of training manuals, policy briefs, conferences, webinars, and articles for newspapers or magazines.

The Goals, Objectives, Deliverables, and Expected Scholarly Products are directly related to the performance measures that demonstrate the results of the work completed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that include evaluation research should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision making.

Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be taken into account when selecting an evaluation design. In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed.

The SF-424 is a required standard form used as a cover sheet for submission of preapplications, applications, and related information. See the <u>OJP Grant Application Resource</u> <u>Guide</u> for additional information on completing the SF-424.

Intergovernmental Review: This solicitation ("funding opportunity") is not subject to <u>Executive Order 12372</u>. (In completing the SF-424, an applicant is to answer question 19 by selecting the response that the "Program is not covered by E.O. 12372.")

2. Project Abstract

The project abstract is a very important part of the application, and serves as an introduction to the proposed project. NIJ uses the project abstract for a number of purposes, including assignment of the application to an appropriate review panel. If the application is funded, the project abstract typically will become public information and be used to describe the project.

Applications should include a high quality project abstract that summarizes the proposed project in no more than 400 words. Project abstracts should be:

- Written for a general public audience.
- Submitted as a separate attachment with "Project Abstract" as part of its file name.
- Single-spaced, using a standard 12-point Times New Roman font with 1-inch margins.

As a separate attachment, the project abstract will not count against the page limit for the program narrative.

Project abstracts should follow the detailed template (including the detailed instructions as to content) available on the NIJ webpage.

3. Program Narrative

The program narrative section of the application should not exceed 30 double-spaced pages in 12-point font with 1-inch margins. If included in the main body of the program narrative, tables, charts, figures, and other illustrations count toward the 30-page limit for the narrative section. The project abstract, table of contents, appendices, and government forms do not count toward the 30-page limit.

If the program narrative fails to comply with these length-related restrictions, NIJ may negatively consider such noncompliance in peer review and in final award decisions.

The following sections should be included as part of the program narrative.8

Program Narrative Guidelines:

a. Title Page (not counted against the 30-page program narrative limit)

The title page should include the title of the project, submission date, funding opportunity number, and the name and complete contact information (that is, address, telephone number, and e-mail address) for both the applicant and the principal investigator.

b. Resubmit Response (if applicable) (not counted against the 30-page program narrative limit)

If an applicant is resubmitting an application presented previously to NIJ, but not funded, the applicant should indicate this. A statement should be provided, no more than two pages, addressing: (1) the title, submission date, and NIJ-assigned application number of the previous application, and (2) a brief summary of revisions to the application, including responses to previous feedback received from NIJ.

c. Table of Contents and Figures (not counted against the 30-page program narrative limit)

d. Main Body

The main body of the program narrative should describe the proposed project in depth. The following sections should be included as part of the program narrative

• Statement of the Problem and Research Questions. The statement of the problem should address the need for research in this area. Applicants should discuss current gaps in data, research, and knowledge, including those for particular justice sectors,

⁸ As noted earlier, if the proposed program or project reasonably could be conducted in discrete phases, with each phase resulting in completion of one or more significant, defined milestones, then NIJ strongly recommends that the applicant structure the application – specifically including the narrative, expected scholarly products, timelines/milestones, and budget detail worksheet and budget narrative – to set out each phase clearly. (In appropriate cases, the expected scholarly product(s) from a particular phase may vary from those described above.) for certain populations, and to answer questions relevant to current policy and practice needs and public interests. As part of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

This section should also identify the proposed research questions and discuss the purpose, goals, and objectives of the proposed project.

- Project Design and Implementation. Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted on page 5. Applicants should describe the research methodology in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.
- <u>Potential Impact</u>. Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States.

The discussion of impact should include a discussion of the deliverables, including planned scholarly products indicated in the project-specific information on page 8 and a plan for dissemination to appropriate audiences. Applicants should identify plans to produce or make available to broader interested practitioners and policy makers in a form that is designed to be readily accessible and useful to them.

- <u>Capabilities/Competencies</u>. This section should describe the experience and capability of the applicant organization, key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude. Applicants should address:
 - Experience and capacity to work with the proposed data sources in the conduct of similar research efforts.
 - Experience and capacity to design and implement rigorous research and data analysis projects.
 - Experience producing and disseminating meaningful deliverables.

Applicants should also outline the management plan and organization that connects to the goals and objectives of the project.

- **e. Appendices** (not counted against the 30-page program narrative limit) include:
 - Bibliography/references.
 - Any tools/instruments, questionnaires, tables/charts/graphs, or maps pertaining to the proposed project that are supplemental to such items included in the main body of the narrative.
 - Curriculum vitae or resume of the principal investigator and any and all co-principal
 investigators. In addition, curriculum vitae, resume, or biographical sketches of all
 other individuals (regardless of "investigator" status) who will be significantly involved
 in substantive aspects of the proposed project (including, for example, individuals
 such as statisticians used to conduct proposed data analysis).
 - To assist OJP in assessing actual or apparent conflicts of interest (including such conflicts on the part of prospective reviewers of the application, a complete list of the individuals named or otherwise identified anywhere in the application (including in the budget or in any other attachment) who will or may work (or advise or consult) on the proposed research, development, or evaluation project. This applies to all such individuals, including, for example, individuals who are or would be employees of the applicant or employees of any proposed subrecipient entity, any individuals who themselves may be a subrecipient, and individuals who may (or will) work without compensation (such as advisory board members). This appendix to the program narrative is to include, for each listed individual: name, title, employer, any other potentially-pertinent organizational affiliation(s), and the individual's proposed roles and responsibilities in carrying out the proposed project. If the application identifies any specific entities or organizations (other than the applicant) that will or may work (or advise or consult) on the proposed project, without also naming any associated individuals, the name of each such organization also should be included on this list.

Applicants should use the "Proposed Project Staff, Affiliation, and Roles" form available on the NIJ webpage to prepare this list.

If the application (including the budget) identifies any proposed non-competitive agreements that are or may be considered procurement "contracts" (rather than subawards) for purposes of federal grants administrative requirements the applicant also must list the entities with which the applicant proposes to contract. Applicants should provide this list as a separate sheet entitled "Proposed non-competitive procurement contracts."

For information on distinctions — for purposes of federal grants administrative requirements — between subawards and procurement contracts under awards, see "Budget Information and Associated Documentation," below.

- Proposed project timeline and expected milestones.
- Human Subjects Protection paperwork (documentation and forms related to Institutional Review Board [IRB] review). See https://nij.ojp.gov/funding/human-subjects-and-privacy-protection. Note: Final IRB approval is not required at the time an application is submitted.

- Privacy Certificate (for further guidance go to https://nij.ojp.gov/funding/confidentiality-and-privacy-protections and https://nij.ojp.gov/funding/model-privacy-certificate).
- List of any previous and current NIJ awards to the applicant and investigator(s), including the NIJ-assigned award numbers and a brief description of any scholarly products that resulted in whole or in part from work funded under the NIJ award(s). (See "Goals, Objectives, Deliverables, and Expected Scholarly Products" under "Project-Specific Information," above, for definition of "scholarly products.")
- List of other agencies, organizations, or funding sources to which this application has been submitted (if applicable).
- Applicants proposing to use incentives or stipends payments as part of their research project design, must submit an incentive or stipend approval request, as a separate document, according to the requirements set forth at https://nij.ojp.gov/funding/participant-support-costs-and-incentives-social-science-research.
- Data archiving plan. Applicants should anticipate that NIJ will require (through special award conditions, that data sets resulting in whole or in part from projects funded under this solicitation be submitted for archiving with the NACJD. See https://nij.ojp.gov/funding/data-archiving-plans-nij-funding-applicants.

Applications should include as an appendix a brief plan — labeled "Data Archiving Plan" — to comply with data archiving requirements. E. Application Review Information

Review Criteria

Applications that meet basic minimum requirements will be evaluated by peer reviewers using the following review criteria.

Statement of the Problem and Research Questions (Understanding of the problem, research questions, and their importance) -10%

- 1. Demonstrated understanding of the problem.
- 2. Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- 3. Demonstrated awareness of the state of current research.

Project Design and Implementation (Quality and technical merit) – 55%

- 1. Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- 2. Feasibility of proposed project.
- 3. Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- 4. Feasibility of completing the deliverables noted in the solicitation.

Potential Impact – 15%

Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States, such as:

- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.

Capabilities/Competencies (Capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) – 20%

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- 2. Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Plan for Dissemination to Broader Audiences (if applicable to the proposed project)

Peer reviewers may comment — in the context of scientific and technical merit — on strength and feasibility the proposed plan (if any) to produce or to make available to broader interested audiences, such as criminal/juvenile justice practitioners or policymakers, summary information from the planned scholarly products of the project.

Budget

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- 1. Total cost of the project relative to the perceived benefit (cost effectiveness).
- 2. Appropriateness of the budget relative to the level of effort.
- 3. Use of existing resources to conserve costs.
- 4. Alignment of the proposed budget with proposed project activities.

Review Process

OJP is committed to ensuring a fair and open process for making awards. NIJ reviews the application to make sure that the information presented is reasonable, understandable, measurable, achievable, and consistent with the solicitation.

The following five paragraphs in this solicitation expressly modify the "Application Review Information" provisions in the OJP Grant Application Resource Guide. An applicant is to follow the guidance in these five paragraphs instead of the guidance stated under the "Application Review Information" heading in the Guide.

Peer reviewers will review the applications submitted under this solicitation that meet basic minimum requirements. For purposes of assessing whether an application meets basic minimum requirements and should proceed to further consideration, OJP screens applications for compliance with those requirements. Although specific requirements may vary, the following are common requirements applicable to all solicitations for funding under OJP programs:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.
- The application, if submitted by an applicant that is a DOJ High Risk Grantee, ¹⁰ or is designated "high risk" by a federal grant-making agency outside of DOJ, must not have been determined by the Director to pose a substantial risk of program implementation failure, based on 1) the applicant's lack of sufficient progress in addressing required corrective actions necessary for removal of the DOJ High Risk Grantee (or non-DOJ high risk) designation, 2) the nature and severity of the issues leading to or accompanying the DOJ High Risk Grantee (or non-DOJ high risk) designation, and/or 3) the applicant's expected ability to manage grant funds and achieve grant goals and objectives.

For a list of the application elements that MUST be included in the application submission in order for an application to meet the basic minimum requirements, see "What an Application Should Include" under Section D. Application and Submission Information.

Peer review panels will evaluate, score, and rate applications that meet basic minimum requirements. NIJ may use internal peer reviewers, external peer reviewers, or a combination, to assess applications on technical merit using the solicitation's review criteria. An internal reviewer is a current DOJ employee who is well-versed or has expertise in the subject matter of this solicitation. An external peer reviewer is an expert in the subject matter of a given solicitation who is not a current DOJ employee. Peer reviewers' ratings and any resulting recommendations are advisory only, but are considered carefully.

Other important considerations for NIJ include geographic diversity, strategic priorities, available funding, the planned scholarly products, and the extent to which the Budget Detail Worksheet and Budget Narrative accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant. Among other things to help assess whether an applicant that has one or more prior federal awards has a satisfactory record with respect to performance, integrity, and business ethics, OJP checks whether the applicant is listed in SAM as excluded from receiving a federal award.

In addition, if OJP anticipates that an award will exceed \$250,000 in federal funds, OJP also must review and consider any information above the applicant that appears in the non-public segment of the integrity and performance system accessible through SAM (currently, the Federal Awardee Performance Integrity Information System, FAPIIS).
