#### Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) seeks applications for funding of research and program evaluation projects that inform efforts to prevent and reduce intentional, interpersonal firearm violence and mass shootings in the United States. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

# Program Description

# Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks applications for funding of research and program evaluation projects that inform efforts to prevent and reduce intentional, interpersonal firearm violence and mass shootings in the United States in two categories: (1) research or evaluation of Extreme Risk Protection Order (ERPO) laws, otherwise known as "Red Flag Laws;" and (2) research on the sources of the firearm used in the commission of a crime and the relationship of those sources to shootings and qun-related violence.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study; including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review NIJ's data archiving guidance. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of the study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

# Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4533; Bipartisan Safer Communities Supplemental Appropriations Act, 2022 (Pub. L. No. 117-159, 136 Stat. 1313, 1339); 28 U.S.C. 530C.

#### Specific Information

With this solicitation, NIJ seeks applications for funding of research and program evaluation projects that inform efforts to prevent and reduce intentional, interpersonal firearm violence and mass shootings in the United States.

Applicants have leaway to generate their ideas and center their studies within their field of social science or in conjunction with other areas of interest and expertise, within the context of the purposes of this solicitation. Proposals for research and program evaluation topics other than those solicitated in this solicitation will not be considered.

Where appropriate, NIJ encourages applicants to secure partnerships involving researchers and practitioners to facilitate access to data, design analysis strategies, interpret findings, and disseminate results. NIJ will only consider proposals with a strong potential to produce findings with practical implications for developing firearm-related crime

prevention and reduction strategies.

# Category 1: Research or Evaluation of Extreme Risk Protection Order (ERPO) Laws, Otherwise Known as "Red Flag Laws." with a focus on Firearm Violence and/or Mass Shootings

The recently enacted Bipartisan Safer Communities Act (<u>Public Law No: 117-159</u>) aims to reduce gun violence and save lives, and to make progress toward keeping guns out of dangerous hands. The Act allows for the implementation of programs and initiatives, including those related to ERPO laws,[1] otherwise known as "Red Flag Laws" (Tritle II, Section 12003). An ERPO empowers "family members, health care providers, school officials, or law enforcement officers to petition a court to temporarily prevent a person from accessing firearms if they are found to be a danger to themselves or others." [2] Although an increasing number of states have passed ERPO laws in the past decade, research on and evaluation of ERPOs is limited and still in its nascency. Thus, NIJ is interested in research or evaluation proposals aiming to study ERPOs.

The proposals may include basic research projects or projects involving ERPO implementation and process assessment and evaluations that measure outcomes and effectiveness of these civil orders in preventing firearm violence and/or mass shootings. Issues related to lack of data standardization must be accounted for in the proposals, as well as other limitations related to potential confounders, such as equity in administration across a diverse population, due process, [3] and differing policy provisions across various states. These potential confounders are also areas of interest to NJI for focused research.

Note: ERPOs are issued by a court to temporarily prevent a person in crisis from accessing firearms and may include persons who pose a threat to harm others OR themselves. [4] NUJ-sponsored studies on mass shootings found that most people who commit mass shootings are in a state of personal crisis, are often suicidal, and have access to firearms, whether via lawful or unlawful acquisition. [5] Studies on femicide also found that suicidality is a risk factor among those perpetrating such crimes. [6] To align this priority topic with the purpose of this solicitation, NIJ will consider proposals focusing on cases in which a person poses a threat to harm others. Studies focusing exclusively on suicide cases will not be considered. Proposals may incorporate an aspect of suicidality only in tandem with the commission of intentional, interpersonal firearm violence and/or mass shooting (i.e., the perpetrator poses a threat to harm others AND themselves).

# Category 2: Research on Illegal Possession and Sources of Firearms Used in the Commission of Crime and the Relationship of Those Sources to Shootings and Gun-related Violence

NIJ research in a limited number of study sites suggests that a disproportionately high rate of firearm-related crimes, including murder and assault, as well as other forms of violent crime, are committed by persons prohibited from legally possessing a firearm or who obtained their firearms from illegal sources.[7] Study findings are mixed on whether there is a relationship between increased crime rates and levels of legally purchased firearms[8] (The variation in findings may be, in part, due to the localized nature of the problem and differences in policies, such as regulation around gun sales and transfers, that affect the source of firearms used in crimes.) NIJ-sponsored research also indicates that most individuals who commit mass shootings in schools obtain firearms by stealing them from family members, while those who commit mass shootings in other places typically purchase them lawfully.[9] Such nuances present challenges for building evidence to inform the development of sound solutions aimed at reducing firearm violence. Thus, NIJ seeks applications that propose rigorous studies to improve scientific knowledge and understanding of how firearms used in the commission of a crime are acquired, both legally and illegally, to inform the development of intervention and prevention strategies. Specifically, more research on the relationship between the illegal possession of firearms used in the commission of a crime, conducted across a larger number of sites, is needed. NIJ is also interested in studies designed to determine what sources (both legal and illegal) of firearms used in the commission of a crime are associated with and/or have an impact on firearm-related crime rates.

NIJ encourages proposals that use secondary (e.g., firearm trace and individual-level record data), and/or primary (e.g., survey, interview) data. [10] Where applicable, applicants are encouraged to partner with local law enforcement agencies, prosecutorial offices, or other pertinent entities to secure access to data that capture whether the firearm used in crime was in possession of a prohibited person and/or the source of firearm possessed by an individual who committed a firearm-related crime. The data sources may include a record management system, incident and investigative reports, and court records. The crimes may include, but are not limited to: murder; aggravated robberies; other aggravated street crimes, such as drive-by-shootings; and mass shootings.

## Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of

any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

# **Evaluation Research**

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <a href="https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish">https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish</a> for further information on high-quality evaluation design elements.

# New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must, at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project, with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

# Goals, Objectives, and Deliverables

With this solicitation, NIJ seeks applications for funding of research and program evaluation projects that inform

efforts to prevent and reduce intentional, interpersonal firearm violence and mass shootings in the United States,

#### Goals

The goal of this program is to inform efforts in preventing and reducing intentional, interpersonal firearm violence and mass shootings in the United States.

#### Objectives

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives. Deliverables, and Timeline web-based form.

The primary objective of this solicitation is to generate and advance knowledge related to ERPO laws and illegal possession and sources of firearms used in the commission of a crime.

#### Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's webpage.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result, in whole or in part, from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

# **Priority Areas**

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity <u>and</u> the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project (s) are enhanced because they (or at least one proposed subrecipient that will receive at least 40% of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

# 2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

# 2. Project Design and Implementation

Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will address issues related to racial equity <u>and</u> the removal of barriers to access and opportunity, and/or contribute to greater access to services, for communities that have been historically underserved, marginalized, and adversely affected by inequality, and should also identify how the project design and implementation will specifically incorporate the input or participation of these communities.

# 3. Potential Impact

Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States. The applicant should include a discussion of the proposed dissemination plan to produce scholarly products and to make information available to broader interested audiences, such as criminal justice practitioners or policymakers.

The full application must be submitted in JustGrants by 8:59 p.m. eastern time on May 04, 2023.

OJP urges applicants to submit their Grants.gov and JustGrants submissions prior to the due dates with sufficient time to correct any errors and resubmit by the submission deadlines if a rejection notification is received. To be considered timely, the **full application** must be submitted in JustGrants by the JustGrants application deadline. Failure to begin the SAM.gov, Grants.gov, or JustGrants registration process in sufficient time (i.e., waiting until the date identified in this solicitation) is not an acceptable reason for late submission.

# Experiencing Unforeseen Technical Issues Preventing Submission of an Application

#### Other Review Criteria/Factors

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

# **Review Process**

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- . The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.
