Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) seeks applications for funding to support the development of objective and independent knowledge and validated tools to reduce violence against women, promote justice for victims of crime, and enhance criminal justice responses. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

City or township governments, County governments, For profit organizations other than small businesses, Native American tribal governments (Federally recognized), Native American tribal organizations (other than Federally recognized tribal governments), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Private institutions of higher education, Public and State controlled institutions of higher education, Small businesses, Special district governments, State governments, Unrestricted (open to any type of entity above), subject to any clarification in text field entitled as Additional Information on Eligibility

An applicant entity may submit more than one application, if each application proposes a different project in response to the solicitation. Also, an entity may be proposed as a subrecipient (subgrantee) in more than one application.

NIJ will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Submission Information

Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Step 1: The applicant must submit by the Grants.gov deadline the required **Application for Federal Assistance standard form (SF-424)** and a **Disclosure of Lobbying Activities (SF-LLL)** form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

NIJ strives to support the development of objective and independent knowledge and validated tools to reduce violence against women (VAW), promote justice for victims of crime, and enhance criminal justice responses. For that reason, this solicitation seeks applications for grant funding to conduct research and evaluation projects examining a broad range of topics, including the crimes of domestic (DV) and family violence (FV), homicide and other forms of violent death, intimate partner violence (IPV), rape, sex trafficking, sexual assault, stalking, and teen dating violence (TDV), also known as adolescent relationship abuse (ARA), along with the associated criminal justice system response, procedures, and policies.

Letter of Intent: Applicants are encouraged to submit a letter of intent to apply to [NIJsVAW-FVResearch@ojp.usdoj.gov](mailto:FVResearch@ojp.usdoj.gov) by March 28, 2023. The letter should be addressed to the NIJ Director using the following address: National Institute of Justice, 810 Seventh Street, NW, Washington, DC 20531. Submitting a letter of intent will not obligate a potential applicant to apply. Applicants who do not provide a letter of intent can still apply.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review [NIJ's data archiving guidance](#). If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

Statutory Authority

Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4542-4543); 28 U.S.C. 530C.

Specific Information

NIJ's [Violence Against Women and Family Violence Research and Evaluation Program](#) seeks to promote women and family members' safety and increase the efficiency and effectiveness of the criminal justice system's response to violence against women and family violence. The program's key objectives include estimating the scope of the problem, identifying correlates, causes and consequences, evaluating promising prevention and intervention programs, compiling and disseminating research findings, and partnering to promote and facilitate collaboration, coordination, and cooperation among a wide variety of disciplines. A broad range of topics is covered under this program that touches on various public health and safety topics and criminal justice challenges, including the availability of legal and victim support services, the effectiveness of prevention and intervention programs, and the impact of such crimes over time. NIJ is particularly interested in studies involving longitudinal research, surveys, instrumentation, measurement, and scale validation; advanced statistical modeling; applied policy analysis; interdisciplinary research teams and researcher-practitioner partnerships. In addition to welcoming original research, NIJ has a particular interest in supporting replication studies of seminal studies in the field. Replication studies are vital for building scientific evidence about what works. An important contribution to the field would be to subject one or more of the programs in the NIJ-sponsored [CrimeSolutions](#) repository of scientific evaluations that are rated as "promising" or "effective" based on less-rigorous quasi-experimental research designs to a more rigorous randomized control trial (RCT) to examine if the program still produces the intended effects.

In Fiscal Year (FY) 2023, NIJ seeks rigorous and inclusive^[1] research and evaluation proposals. NIJ will give special consideration to proposals with methods that include meaningful engagement with the people closest to the subject of study, including practitioners and community members representing crime victims, people under criminal justice supervision, and members of high-crime communities. Studies applying a racial equity lens will be given higher consideration, as will applicants who propose interdisciplinary approaches and teams.

Applicants can offer studies on any VAW subject matter; however, NIJ highlights some topical areas of interest below, including specific populations and research methods. Select priority areas come directly from the "Violence Against Women Act Reauthorization Act of 2022" ([Pub. L. No. 117-103, div. W, 136 Stat 840-962](#)) to include how gender-based violence impacts diverse populations (e.g., citizenship, ethnicity, gender identity, race, sexual orientation).

Campus Climate and Sexual Violence Experiences of Students Attending Minority Serving Institutions (MSIs)^[2]

Under this topic, NIJ has several interests. First, studies employing the most rigorous methods that align with a tested framework grounded in cultural competence and participatory principles for conducting research with historically marginalized groups are preferred. Second, NIJ seeks studies using surveys that identify risk or protective factors (structural, institutional, culturally relevant) for sexual violence for students attending these campuses and barriers to disclosure, reporting, and accessing services. Third, there is an interest in MSIs' responses to incidents of sexual violence. Finally, studies should identify the unique challenges and opportunities that MSIs and the student population contend with, and the strategies employed to address them.

Case Processing

NIJ is interested in the reporting, investigation, and prosecution of cases involving DV, FV, IPV, sexual violence, stalking, and TDV. Areas of interest include but are not limited to case flow and attrition, decision-making, training, caseload and workload management, closure rates, and characteristics.

Evaluation Research on Violence Against Women (VAW) Programs^[3]

NIJ is soliciting proposals under this category for high-quality evaluations focused on testing programs or interventions aimed at enhancing law enforcement, prosecutorial, and judicial responses to DV, FV, IPV, sexual violence, stalking, and TDV and programs or interventions aimed at improving victim engagement with

the criminal justice system in the United States. NIJ will give evaluations of trauma-informed or culturally specific programs priority consideration.^[4] The goal is to build credible evidence about improving outcomes and the number of rigorously tested interventions. NIJ is specifically interested in programs widely adopted in practice but lacking rigorous evaluation, or are growing in use and on track to become widely adopted but lack thorough evaluation.

Because RCT studies are a powerful, much-needed tool for building scientific evidence about what works, NIJ will give studies employing rigorous RCT methods to assess the effectiveness of programs and practices priority consideration. A robust RCT design should include a sufficiently large sample, as shown through a power analysis and other elements needed to generate credible evidence about the intervention's impact on one or more targeted outcomes. Proposals should specify the study's primary outcome(s) of interest, how they will measure the outcome(s) and over what length of time, and when the randomization occurs (i.e., after individuals agree to participate in the experiment or at the point of intervention or service delivery). Applicants must describe how they will assess implementation fidelity (i.e., the degree to which an intervention or program is delivered as intended, such as adherence to the intervention, exposure or dose, quality of delivery, participant responsiveness, and program differentiation). In addition, RCT designs should include measures to ensure low sample attrition, sufficient sample size, close adherence to random assignment, valid outcome measures, and statistical analyses.

NIJ may consider rigorous quasi-experimental designs under this category when random assignment is not feasible or ethical. However, the applicant must present a resounding case that an RCT is impossible and demonstrate that the proposed study will result in valid quasi-experimental findings.

Evaluations that measure these interventions' impact at different levels of the socio-ecological model (individual, interpersonal, community, society) are encouraged to include the cost-effectiveness of the various components of these interventions. Cost-effectiveness studies will enable policymakers to determine what, if any, part of these programs can affordably be taken to scale and still effect the desired changes.

Under this effort, NIJ's goal is to build credible evidence about valid and effective measures that improve criminal justice outcomes, reduce violence against women, and promote justice for all victims of crime. Accordingly, applicants should provide detailed information on how they will accomplish all tasks, including a multidisciplinary evaluation team, if applicable, and demonstrate clear support from related partners.

Homicide and Violent Death

NIJ seeks proposals examining the frequency, nature, and causes of homicide and violent deaths of women and girls. NIJ encourages applicants to focus on in-depth contextual characteristics of female homicide cases (e.g., type of homicide [gender-related, intimate partner homicide, femicide, firearm^[5]], demographic information about the individuals involved, incident characteristics, and situational contexts associated with these cases). Of particular importance are analyses that provide the distribution on a demographic and geographic basis (e.g., national, state, regional, county, reservation/non-reservation). NIJ will give applicants studying homicide and violent deaths of American Indian and Alaska Native women and girls higher priority consideration.^[6]

Sex Trafficking of Indigenous^[7] Women and Girls in the U.S.

Trafficking of Indigenous peoples is an understudied issue that suffers from a lack of scientifically rigorous research. Under this solicitation, NIJ is interested in proposals focused on examining the specific sex trafficking experiences of Native women (i.e., American Indian, Alaska Native, and Native Hawaiian), and studies on jurisdictional and legal systems responses and barriers to successful enforcement, apprehension, and prosecution of traffickers. Applicants wishing to evaluate culturally appropriate responses to trafficking and culturally specific intervention services for these populations should apply to *NIJ's FY 2023 Research and Evaluation on Trafficking in Persons*.

Stalking

NIJ is interested in risk and protective factors for victimization and perpetration, help-seeking, and outcomes of stalking. NIJ is particularly interested in how a survivor's identity impacts disclosure and help-seeking

behavior. Evaluations focused on culturally specific programs designed to improve informal (i.e., friends and family) and formal assistance (e.g., police, prosecutors, judges, Title IX, counseling centers, victim services) will be given greater consideration.

Teen Dating Violence (TDV), also known as Adolescent Relationship Abuse

Of particular interest to NIJ is TDV research that examines the chronicity, severity, and trajectories of exposure to multiple forms of violence (and factors related to violence) across childhood and early- to mid-adolescence. NIJ also seeks studies examining a range of potential moderators and mediators linking TDV to long-term outcomes. In addition, NIJ is interested in risk and protective factors for TDV, particularly protective factors that cut across multiple socio-ecological domains (e.g., school, neighborhood, community). Finally, studies with underrepresented populations, such as LGBTQ+ or nonbinary youth, are highly encouraged.

Technology Research & Development

NIJ is interested in the use of technology to protect or deliver services to victims of DV, FV, IPV, rape, sexual assault, and stalking. NIJ's specific interests are location-based technologies, artificial intelligence, machine learning techniques, and the application of big data^[8] to understand patterns and trends across large populations or time periods. Other interests include using technology for investigative and forensic purposes, caseload and workload management, and evidence tracking. NIJ strongly encourages research and technology development proposals to incorporate a strong implementation science component.

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Underserved and Historically Marginalized Communities

NIJ is interested in studies examining the prevalence and barriers to seeking and receiving help among LGBTQ+ and nonbinary individuals (youth and adults) and other underserved communities (e.g., people/ persons with disabilities; Indigenous peoples; cultural, racial, or religious minorities, etc.) who have experienced IPV, TDV, sex trafficking, sexual violence, and stalking. Areas of interest include violence prevention and intervention for these populations.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors or equivalent full-time staff scientist positions in a research institution or organization, who propose research on topics relevant to NIJ. To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must, at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Never previously received NIJ funding as a PI on a research award, except for Graduate Research Fellows or Data Resources Program grantees.

If seeking to be considered for this designation, the applicant should identify that they are submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this solicitation is to inform the formulation of strategies and practices to reduce VAW.

Objectives

This solicitation seeks to support the rigorous development of objective and independent knowledge and validated tools, and to disseminate them to stakeholders and policymakers to formulate strategies and practices to reduce VAW.

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables, and Timeline web-based form.

Deliverables

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity **and** the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of

the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization(s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latinx people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and Pacific Islanders.

2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

MSIs include:

- Historically Black Colleges and Universities (HBCU)
- Hispanic-serving Institutions (HSI)
- Tribal Colleges and Universities (TCU)
- Alaska Native-serving Institutions or Native Hawaiian-serving Institutions (ANNH)
- Predominantly Black Institutions (PBI)
- Asian American and Native American Pacific Islander-serving Institutions (AANAPISI)
- Native American-serving Non-Tribal Institutions (NASNTI)

Whether an institution is an MSI is based on the original purpose of its establishment or its current enrollment thresholds and is designated as such by the federal government for various purposes under specific statutes. For more information, please see the U.S. Department of Education's [definitions](#) and [lists of institutions](#). It is not uncommon for multiple problems to exist simultaneously (for example, there may be a criminal justice problem affecting public safety, a current technical challenge/need identified by forensic practitioners, as well as a scientific/technology gap between the current state of the art and a desired solution) and applicants should discuss each of these clearly and justify the importance of the separate issues. As part of this discussion, applicants should demonstrate thorough knowledge of the extant scientific literature in the field related to the(se) problem(s) using primary and secondary sources.

2. Project Design and Implementation

Applicants should present a valid theoretical framework to justify the importance and significance of the proposed work, followed by research questions and hypotheses. Applicants should also provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities. Applicants must address all sensitive human subjects' privacy, protection, and confidentiality issues.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will address issues related to racial equity **and** the removal of barriers to access and opportunity, and/or contribute to greater access to services, for communities that have been historically underserved, marginalized, and adversely affected by inequality, and should also identify how the project design and implementation will specifically incorporate the input or participation of these communities.

3. Potential Impact

Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States. The applicant should include a discussion of the proposed dissemination plan to produce scholarly products and to make information available to broader interested audiences, such as criminal justice practitioners or policymakers.

4. Capabilities and Competencies

Registration: Before submitting an application, all applicants must register with the System for Award Management (SAM). You must renew and validate your registration every 12 months. If you do not renew your SAM registration, it will expire. An expired registration can delay or prevent application submission in Grants.gov and JustGrants. Registration and renewal can take up to 10 business days to complete.

Submission: Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

Step 1: After registering with SAM, the applicant must submit the **SF-424** and **SF-LLL** in Grants.gov at <https://www.grants.gov/web/grants/register.html> by the Grants.gov deadline. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

Step 2: The applicant must then submit the **full application**, including attachments, in JustGrants at [JustGrants.usdoj.gov](https://www.justgrants.usdoj.gov) by the JustGrants deadline.

Within 24 hours after receipt of confirmation emails from Grants.gov, the individual in Section 8F of the SF-424 will receive an email from DIAMD-NoReply@usdoj.gov with instructions on how to create a JustGrants account. Register the Entity Administrator and the Application Submitter with JustGrants as early as possible but no later than 48-72 hours before the JustGrants deadline. Once registered in JustGrants, the Application Submitter will receive an emailed link to complete the rest of the application in JustGrants. The Entity Administrator also will need to log into JustGrants to review and invite the applicant's Authorized Representative(s) before an application can be submitted.

Submit the complete application package in JustGrants at least 24 – 48 hours prior to the JustGrants deadline. Some of the application components will be entered directly into JustGrants, and others will require uploading attached documents. Therefore, applicants will need to allow ample time before the JustGrants deadline to prepare each component. Applicants may save their progress in the system and revise the application as needed prior to hitting the Submit button at the end of the application in JustGrants.

Submission Dates and Time

The **SF-424 and the SF-LLL** must be submitted in Grants.gov by 11:59 p.m. eastern time on April 26, 2023.

OJP urges applicants to submit their Grants.gov and JustGrants submissions prior to the due dates with sufficient time to correct any errors and resubmit by the submission deadlines if a rejection notification is received. To be considered timely, the **full application** must be submitted in JustGrants by the JustGrants application deadline. Failure to begin the SAM.gov, Grants.gov, or JustGrants registration process in sufficient time (i.e., waiting until the date identified in this solicitation) is not an acceptable reason for late submission.

Experiencing Unforeseen Technical Issues Preventing Submission of an Application

OJP will only consider requests to submit an application after the deadline when the applicant can document that a technical issue with a government system prevented application submission.

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline. However, the waiver request will not be considered unless it includes a tracking number generated when the applicant contacts the applicable service desks to report technical difficulties. - Demonstrated understanding of the problem(s).
- Presentation of a valid theoretical framework justifying the study.
- Documented importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- Illustrated awareness of the state of current research.
- Exhibited comprehension of the population and region under investigation.
- Responsiveness to the solicitation.

Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of the proposed project.
- Soundness of methods and analytic and technical approaches to address the proposed project's stated aim(s).
- Responsiveness to sensitive human subjects' privacy, protection, and confidentiality issues.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and mitigate them.
- Likelihood of completing the deliverables noted in the solicitation and proposal.

Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (20%)

- Detailed listing of the qualifications, expertise, and experience of proposed project staff (i.e., all investigators, regardless of status, senior staff, and other staff [or organization] with 50% or more project commitment) who will be significantly involved in substantive aspects of the proposed project. This includes documenting the relationship between the capabilities/competencies of the proposed project staff (including the applicant organization[s]) and the scope and strategies of the proposed project.
- Thorough management plan showing the roles and responsibilities of proposed staff, including how tasks will be subdivided and supervised.
- Illustrative documentation of the applicant organization's capabilities and strategies to manage and support the effort.
- Documented history of translating scientific knowledge successfully into effective and sustainable practices, systems, and policies.
- Executed letters^[9] of agreement, support, or commitment that detail terms of collaboration, level of responsibility, and type of support or resources to be provided.

Potential Impact (10%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter[s] or book[s] in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.
- Capability of project findings translating into actionable information to promote change in the field.

Budget (5%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

Other Review Criteria/Factors

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant entity. [3] Under this priority area, the term “program” encompasses models, practices, and programs in the victim services and criminal justice arena. Applicants may propose evaluation research of specific victim service organizations, victim service delivery models, and victim service interventions.
