Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) seeks applications for funding to advance knowledge regarding the interpersonal violence (IV) experiences of young adults. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, the National Institute of Justice (NIJ) seeks proposals for a nationally representative, longitudinal study examining long-term trajectories of risk for, experiences with, and recovery after experiencing interpersonal violence (IV, victimization and perpetration) among young adults who do and do not attend college. NIJ is interested in a range of IV committed by partners, family members, acquaintances, and strangers, including nonconsensual sexual contact, intimate partner violence, and stalking. Applicants are strongly encouraged to refer to and familiarize themselves with the recommended study design outlined in the final report for the *National Study of Young Adults, Longitudinal Cohort Pilot Study* (see https://www.ojp.gov/pdffiles1/nij/grants/300704.pdf) and the relevant study data and materials at the Inter-University Consortium for Political and Social Research's (ICPSR) National Archive of Criminal Justice Data or NACJD (ICPSR 37914,

https://www.icpsr.umich.edu/web/NACJD/studies/37914). However, applicants are not limited to these previous recommendations and study materials. Applicants who demonstrate that they will augment the study design to reflect present day contexts and conditions, and/or offer newer and innovative methods, modes, and approaches that enhance efficiency and effectiveness, will be given greater consideration.

NIJ expects that this effort will be funded incrementally, subject to the availability of funds. Applicants are expected to develop their project design in phases with discrete deliverables at the end of each phase, and to budget accordingly. The funds provided with this solicitation in FY 2023 are intended to support only the initial phase(s) of this multi-year effort. The SF-424 and JustGrants budget submitted with the application should reflect the initial phase(s) to be supported by funding available under this solicitation. The applicant's proposed deliverables for the initial phase(s) must include, at a minimum, the deliverables identified under "Interim Project Deliverables" (see below under "Deliverables"). The applicant is also expected to provide, as a separate attachment, a budget for the **full** multi-year study using the budget template available at https://www.ojp.gov/funding/apply/forms/ojp-budget-detail-worksheet.

It is anticipated that upon successful completion of the initial phase(s), subsequent years of the project will be funded as a supplement, subject to the availability of funds.

NIJ will give special consideration to proposals with methods that include meaningful

engagement with the people with lived experience of the subject of the study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review NIJ's data archiving guidance. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

Statutory Authority

Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4542-4543); 28 U.S.C. 530C.

Specific Information

Interpersonal violence (IV) is a broad term that includes violence committed by partners, family members, acquaintances, and strangers, including nonconsensual sexual contact, intimate partner violence, and stalking.[1] [2] The prevalence, nature, and outcomes of IV among young adults have been widely studied.[3] [4] Nonetheless, studies have primarily

focused on college students, and there is limited information about how these IV (victimization and perpetration) experiences, associated risks, and consequences may differ among young adults who attend college as compared to those who do not. These differences are important to consider, as aspects of the college setting and environment may influence and shape IV experiences of students. For example, campus alcohol policies, events and parties hosted by fraternities and other social groups, and other campus variables such as campus size and percentage of students who live on campus have been shown to be associated with sexual violence. [5] However, a recent study supported by NIJ indicates that young adults who attend college may be at significantly less risk for experiencing certain types of dating violence or sexual assault. [6] Thus, more comprehensive research is needed to better understand the context of college and non-college experiences that may contribute to or protect against IV in young adulthood.

In FY 2016, NIJ funded the initial planning phase of a nationally representative, longitudinal study of IV among college-aged individuals (for a copy of the solicitation, see https://nij.ojp.gov/funding/opportunities/nij-2016-9032). In FY 2018, NIJ made a supplemental award to conduct a robust, comprehensive pilot test of key study elements to provide important information and direction for the larger longitudinal study, especially around sampling, recruitment, and retention of study participants; measurement of IV; and the mode of survey delivery (for additional details see https://nij.ojp.gov/funding/awards/2016-mu-mu-k074). The pilot effort resulted in a plan that included multiple considerations for the successful implementation of a national longitudinal study, which is detailed in the final report (see https://www.ojp.gov/pdffiles1/nij/grants/300704.pdf). The study data and supporting materials are available at the National Archive of Criminal Justice Data (NACJD ICPSR 37914, https://www.icpsr.umich.edu/web/NACJD/studies/37914).

With this solicitation, NIJ seeks proposals for a nationally representative, longitudinal study examining the long-term trajectories of risk for, experiences with, and recovery after experiencing IV (victimization and perpetration) among young adults (ages 18 to 24) who do and do not attend college. NIJ expects that this effort will be funded incrementally, dependent upon the availability of funds. Applicants are expected to develop their project design in phases with discrete deliverables at the end of each phase, and to budget accordingly.

Applicants' proposed analysis plans must include students attending colleges and universities and a comparison group of individuals not attending colleges and universities. Although comparisons among those who attend college (including two-year versus four-year college) and those who do not attend college are of primary interest for NIJ, applicants are expected to propose other analyses to address major research gaps in the field, including subgroup analyses (e.g., examining differences across victimization types; demographic characteristics of victims and individuals who use violence, as well as differences between those who attend two- year versus four-year colleges).

Applicants should describe the proposed sampling design and frame to include a power analysis showing the calculation used to demonstrate the required sample size to produce reliable estimates and to conduct statistical tests for group comparisons. Applicants must provide proposed survey content sources and validation for each instrument offered. Applicants should describe plans for instrument development,

evaluation, and testing. In addition, applicants should outline recruitment and retention strategies (including how they will track participants over time and achieve target response rates), relevant mitigation plans, and an incentive scheme. Applicants should describe the anticipated survey operations and protocols to include the development of interviewer materials and quality control procedures. Applicants must describe their plan for data processing procedures, including data edits, non-response adjustments, and data documentation. Finally, applicants should describe the expected survey estimation methods and analysis plan to produce accurate incidence rates and relevant subgroup comparisons. The final approved study design must include a comprehensive plan to conduct the study in five waves over six years, including how the study will address threats to validity such as participant attrition and missing data.

The research team should be interdisciplinary and comprised of individuals with demonstrated expertise covering the following areas:

- Large-scale, longitudinal survey data collection efforts.
- Victimization and perpetration among teen and young adult populations.
- Interpersonal and family violence.
- Large-scale survey sampling methods, statistics, weighting, and estimation.
- Instrument design/development, testing, and validation.
- Survey measurement and constructs.
- Translation and implementation science.

Staffing plans should be clearly delineated and justified and include education, all relevant subject matter expertise, and years of demonstrated experience. It is recommended that applicants propose multi-agency or multi-institution collaborations to meet the goals of this solicitation. Proposals should also include a detailed management strategy for communicating with NIJ throughout the course of the project.

The funds provided with this solicitation in FY 2023 are intended to support only the initial phase(s) of this multi-year effort to include, at a minimum: (1) securing institutional review board(s) review(s) and approval(s) of the proposed research; (2) completing all Office of Management and Budget (OMB) Paperwork Reduction Act Information Collection Review requirements; (3) securing all necessary legal documents, agreements, and commitments; (4) reviewing, revising, and finalizing the survey instrument and other study materials; (6) reviewing, revising, and finalizing study protocols and training materials; (7) developing, testing, and finalizing the plan for survey operations and data collection mode(s); and (8) drafting and finalizing a comprehensive survey estimation and analysis plan, to include non-response adjustment strategies and non-response bias studies.

The SF-424 and JustGrants budget submitted with the application should reflect the initial phase(s) to be supported by funding available under this solicitation. The applicant is also expected to provide, as a separate attachment, a budget for the **full** multi-year study using the budget template available at https://www.ojp.gov/funding/apply/forms/ojp-budget-detail-worksheet.

This project will be awarded in the form of a cooperative agreement. Applicants should anticipate starting work no earlier than January 1, 2024. It is anticipated that upon

successful completion of the initial phase(s), subsequent years of the project will be funded as a supplement, dependant upon the availability of funds. The applicant's proposed deliverables for the initial phase(s) must include, at a minimum, the deliverables identified under "Interim Project Deliverables" (see below under "Deliverables").

Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution. To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as project team members. To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application. Furthermore, the project management plan should specify how the experienced principal investigators (PIs) will mentor new investigator/early career researchers.

Goals, Objectives, and Deliverables

Goals

The goal of this solicitation is to advance knowledge regarding the interpersonal violence (IV) experiences of young adults, because they have an increased risk of victimization and involvement in perpetration. Of particular interest is the collection of data that will support analyses comparing IV experiences among young adults who attend college versus those who do not.

Objectives

An applicant should address all the objectives listed below in the Goals, Objectives, Deliverables and Timeline web-based form.

This solicitation seeks to support a research project that provides a comprehensive plan to conduct a nationally representative, longitudinal study examining risk for, experiences with, and recovery after experiencing IV (victimization and perpetration) among young adults who do and do not attend college.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report, which should include the interim project deliverables as described below. Additional information about the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

Interim Project Deliverables. The applicant's proposed deliverables for the initial phase(s) supported by funding from this solicitation must include, at a minimum, the following: conceptual framework; research questions; study design including sampling plan(s), survey instrumentation, human subjects and other ethical procedures and protocols (e.g., graduated consent, distress procedures); engagement and recruitment strategies/materials (and mitigation plan for issues with recruitment and retention); incentive structure or plan; training materials; source code and programming details for data collection, processing, and edits; a comprehensive survey estimation and analysis plan; proposed statistical tabulations and table shells; and a timeline and cost estimates for study implementation.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in

the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity <u>and</u> the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40%** of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific* organization.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North

America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

MSIs include:

- Historically Black Colleges and Universities (HBCU)
- Hispanic-serving Institutions (HSI)
- Tribal Colleges and Universities (TCU)
- Alaska Native-serving Institutions or Native Hawaiian-serving Institutions (ANNH)
- Predominantly Black Institutions (PBI)
- Asian American and Native American Pacific Islander-serving Institutions (AANAPISI)
- Native American-serving Non-Tribal Institutions (NASNTI)

Whether an institution is an MSI is based on the original purpose of its establishment or its current enrollment thresholds and is designated as such by the federal government for various purposes under specific statutes. For more information, please see the U.S. Department of Education's <u>definitions</u> and <u>lists of institutions</u>. (The lists are provided for reference purposes only; MSI status is not an eligibility criterion for this solicitation.)

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline. However, the waiver request will not be considered unless it includes a tracking number generated when the applicant contacts the applicable service desks to report technical difficulties. Statement of the Problem (understanding of the problem) (20%)

- Demonstrated understanding of the problem.
- Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- Demonstrated awareness of the state of current research.

Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of proposed project.
- Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- Feasibility of completing the deliverables noted in the solicitation.

Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (20%)

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Potential Impact (10%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly
 products (such as published, peer-reviewed, scientific journal articles, book chapter
 (s) or book(s) in the academic press, technological prototypes, patented inventions,
 databases, standards or similar scientific products) as well as make summary
 information available to broader interested audiences, such as criminal justice
 practitioners or policymakers.

Budget (5%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

Other Review Criteria/Factors

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant entity. Among other things to help assess whether an applicant with one or more prior federal awards has a satisfactory record of performance, integrity, and business ethics, OJP checks whether the applicant entity is listed in SAM as excluded from receiving a federal award.
