Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National</u> <u>Institute of Justice</u> (NIJ) seeks applications for funding to develop evidence to better inform efforts to prevent and combat hate crimes and their effects. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the <u>OJP Grant Application Resource</u> <u>Guide</u> which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks proposals for rigorous research and evaluation projects that inform efforts to prevent and combat hate crimes and their effects. Specifically, this solicitation seeks proposals to advance knowledge and understanding in the following two categories: (1) preventing and addressing hate crimes; and (2) school-based hate crimes. Within the first category, preventing and addressing hate crimes, NIJ is particularly interested in funding research and evaluations to: (1) improve hate crime prevention efforts; (2) improve reporting of hate crimes and hate incidents; and (3) understand and address the needs of victims and their communities.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study, including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgment that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review <u>NIJ's data archiving guidance</u>. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices

Page 7 of 41 O-NIJ-2023-171634 related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct the a majority of the work proposed.

Statutory Authority

Department of Justice Appropriations Act, 2023 (Pub. L. No. 117-328, 136 Stat. 4459, 4533); Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act (Pub. L. No. 111-84, div. E, sec. 4704); 28 U.S.C. 530C.

Specific Information

On May 27, 2021, the Attorney General of the United States issued a memorandum emphasizing the Department of Justice's commitment to combatting hate crimes and outlining steps that the Department would take to combat hate crimes and other-bias related incidents toward the objectives of: "deterring hate crimes and bias-related incidents, addressing them when they occur, supporting those victimized by them, and reducing the pernicious effects these incidents have on our society."[1]

The purpose of this solicitation is to invite applicants to propose research on hate crimes addressing one of the two categories described below. NIJ particularly encourages applications for research that informs efforts to prevent and address anti-Asian and anti-transgender hate crimes and hate incidents — two areas that are understudied. Under this solicitation, applicants will be limited to focusing on hate crimes within the United States.

Category 1: Research and Evaluation on Preventing and Addressing Hate Crimes

Although applicants may propose a range of topics related to preventing and addressing hate crimes, NIJ is particularly interested in research in the following three topics:

1. Research to improve hate crime prevention efforts.

NIJ seeks applications for research to evaluate efforts to prevent hate crimes. Evaluations of programs, policies, and practices that seek to prevent hate crimes, including community-based, school-based, or online prevention programs and adaptations of existing programs to address bias-motivated behaviors are of

particular interest.

NIJ is also interested in research that informs strategies to prevent hate crime. This may include studies to identify risk and protective factors of hate crime perpetration and studies on the role of social media or online forums in the development of bias beliefs or as tools to recruit or radicalize individuals to participate in hate groups or commit hate crimes. Proposals must clearly demonstrate the relevance of the research questions to prevention efforts.

In proposing research projects, applicants must address First Amendment considerations and should be aware that NIJ has serious concerns about intentionally exposing research participants to extremist materials and propaganda. NIJ will not award funding to applications that introduce, expose, or disseminate extremist materials and propaganda to study participants.

2. Research to improve reporting of hate crimes and hate incidents.

NIJ seeks proposals for research to inform or evaluate strategies that improve the reporting of hate crimes and bias incidents. NIJ encourages proposals that work with local communities to understand barriers to hate crime reporting and/or examine innovative, non-law enforcement strategies to improve reporting.

3. Research to understand and address the needs of hate crime victims and their communities.

NIJ is interested in research to help understand and address the needs of victims of hate crimes and targeted communities. Evaluations of fully developed interventions for victims of hate crime and impacted communities are of particular interest. Hate crimes are recognized as having a broader impact than other types of crime because they affect not only the immediate target but others belonging to the targeted group. NIJ encourages applicants to broadly conceptualize victims to include impacted groups when proposing research to understand victim's needs. Applicants should consider and address language access challenges where applicable.

Definitions and scope: Hate crimes, also known as "bias crimes," are criminal offenses motivated, in part or in whole, by prejudice or bias against a group of people with specific characteristics. Victims of bias crimes are targeted because of their (perceived) group affiliation. Hate crimes are recognized as a distinct category of crimes that have a broader effect than most other kinds of crimes because the victims are not only the crime's immediate target but also others in the targeted group. The terms "hate crime" and "bias crime" first became part of the criminal justice research and practice lexicon in the 1980s. Over the past 35 years, hate crimes have become widely recognized and codified through state and federal laws. Although no uniform definition exists across the United States, the FBI defines a hate crime for statistical purposes as "a criminal offense

Page 9 of 41 O-NIJ-2023-171634 against a person or property motivated in whole or in part by an offender's bias against race, religion, disability, sexual orientation, ethnicity, gender, or gender identity." Hate or bias incidents are acts of prejudice that are not crimes and do not involve violence, threats, or property damage.[2]

Applicants are permitted to propose studies that include bias incidents; however, applicants must explain the relevance to understanding or addressing hate crimes, justify the inclusion of both, and explain whether and how bias incidents and hate crimes will be distinguished. Applicants proposing research on bias-motivated domestic terrorism or mass shootings should review NIJ solicitations *NIJ FY23 Research and Evaluation on Domestic Radicalization and Violent Extremism* or *NIJ FY23 Research and Evaluation on Firearms Violence and Mass Shootings* and consider the relevance of the goals and objectives of those solicitations to the proposed research to determine which solicitation is the best fit. NIJ will not consider applications to this solicitation that propose research that is not aligned with its goals and objectives.

Category 2: Research on School-Based Hate Crimes

In school year (SY) 2017-2018, approximately 1.4 million public school students (3%) were enrolled at a school in which a hate crime occurred.[3] In SY 2018-2019, one in four public and private school students between ages 12 to 18 saw hate words or symbols written in their schools, one in five students were bullied annually and, of those, one in four students experienced bullying related to race, national origin, religion, disability, gender, or sexual orientation.[4] During the same school year, 7% of students reported being called hate-related words.[5] Bias victimization can have serious negative consequences for youth,[6] and school-based incidents can expose other students who may witness or learn about the incident afterwards.[7]

NIJ seeks applications from accredited research universities to conduct a study on hate crimes in the K-12 education system to understand the scope, characteristics, and outcomes of these incidents.

<u>Definitions and Scope:</u> For the purposes of Category 2, school-based hate crimes must include bias-motivated incidents that do not constitute criminal offenses, such as bias-motivated harassment, identity-based bullying, and incidents of hate words or symbols written in schools. Applicants must clearly define what incidents will be included in their operationalization of school-based hate crimes. Additionally, school-based hate crimes may include incidents that occurred outside of the school setting (e.g., online incidents); however, applicants must demonstrate the relevance of the incidents to a school setting (e.g., campus climate).

Proposed research designs must include incidents that do not come to the attention of

Page 10 of 41 O-NIJ-2023-171634 law enforcement. Schools have discretion over reporting crimes to law enforcement and thus may underreport hate crimes. For instance, in SY 2019-2020, 77.2% of public schools recorded one or more incidents of crime while 46.6% reported incidents of crime to sworn law enforcement.[8] Additionally, non-criminal bias incidents would not be reported to law enforcement.

Applicants are encouraged to include studying victims (e.g., protected status and other demographics), those perpetrating events (e.g., demographics, disciplinary histories), and school-based victim resources (e.g., reporting avenues, victim support) in their proposal.

Applications to inform or evaluate school-based prevention efforts, improve the reporting of school-based hate crimes, or understand or address the needs victims of school-based hate crimes should apply under Category 1.

Only **accredited research universities** are eligible to apply to Category 2 of this solicitation; all other entities must apply under Category 1. Entities other than accredited research universities applying to this category will not be considered.

Additional Information

For this solicitation, proposals to study content on social media or online forums must be theoretically grounded with analytical methods that are justified within the theoretical context. Applications that propose exploratory data mining or other atheoretical AI approaches to analyze big data will not be funded. Additionally, NIJ will not fund applications that propose to use social media data to identify individuals.

Applicants should discuss potential risks and harms to individuals or groups associated with the use and misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to

Page 11 of 41 O-NIJ-2023-171634 experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <u>https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish</u> for further information on high-quality evaluation design elements.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

• Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.

- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this program is to develop evidence to better inform efforts to prevent and combat hate crimes and their effects.

Objectives

An applicant should address the objectives that are relevant to their proposed program/ project in the Goals, Objectives, Deliverables, and Timeline web-based form.

The primary objective of this solicitation is to generate and advance knowledge to improve hate crime reporting and prevention, to better address the needs of the victims of hate crimes and their communities, and to better understand the scope, characteristics, and outcomes of hate crime incidents in K-12 schools.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

<u>Required Data Sets and Associated Files and Documentation</u>. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity <u>and</u> the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B.
