Overview

The <u>U.S. Department of Justice</u> (DOJ), <u>Office of Justice Programs</u> (OJP), <u>National Institute of Justice</u> (NIJ) seeks applications for funding to support rigorous research and evaluation projects that inform juvenile justice policy and practice in the following three categories: (1) research and evaluation of legislative and administrative policy changes affecting youth involved in the justice system on specified topics of (a) community-based alternatives to youth incarceration, (b) sealing and expungement of juvenile justice records, and (c) reducing racial and ethnic disparities; (2) research to assess dual system youth data capacity and service delivery across juvenile justice and child welfare systems; and (3) analysis on the use of the valid court order exception. Applicants must propose to address one of the specified categories in order to receive funding consideration. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the OJP Grant Application Resource Guide which provides additional information for applicants to prepare and submit applications to OJP for funding. If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.

NIJ may elect to fund applications submitted under this FY 2023 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

<u>Step 1</u>: The applicant must submit by the Grants.gov deadline the required **Application** for Federal Assistance standard form (SF-424) and a Disclosure of Lobbying Activities (SF-LLL) form when they register in Grants.gov at https://www.grants.gov/web/grants/register.html. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ, in collaboration with the Office of Juvenile Justice and Delinquency Prevention (OJJDP), seeks proposals for rigorous research and evaluation projects that inform policy and practice in the field of juvenile justice. Specifically, this solicitation seeks proposals for studies that advance knowledge and understanding in the following three categories:

- 1. Research and evaluation of legislative and administrative policy changes affecting youth involved in the justice system. Applicants must address one or more of the following three specified juvenile justice issues:
 - Providing community-based alternatives to youth incarceration, with a focus on very high need/risk youth who have traditionally been held securely.
 - Sealing and expungement of juvenile justice records.
 - Reducing racial and ethnic disparities in the juvenile justice system.
- 2. Research to assess dual system youth data capacity and service delivery across juvenile justice and child welfare systems.
- 3. Analysis on the use of the valid court order exception.

In FY 2023, applications proposing research outside of these three specified categories will not be considered. Applicants may submit proposals to more than one of these categories but each proposal must be in a separate application. Applicants are expected to identify the category to which a proposal is submitted on the title page of the Proposal Narrative.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study; including, but not limited to, justice practitioners, community members, crime victims, service providers, and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion,

and sexual orientation, as applicable.

Applications proposing research involving partnerships with juvenile justice, criminal justice, child welfare, or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review NIJ's data archiving guidance. If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

Statutory Authority

Juvenile Justice and Delinquency Prevention Act of 1974 (section 221); Department of Justice Appropriations Act, 2023, Public Law 117-328, 136 Stat. 4459, 4538-4539; 28 U.S.C. § 530C.

Specific Information

NIJ works closely with OJJDP to support high-quality, rigorous research, independent evaluations, and statistical analyses related to juvenile justice, juvenile delinquency, and child victimization. Applicants should familiarize themselves with prior NIJ-funded research and include knowledge of relevant research, not limited to NIJ-funded research, in their literature review.[1] The purpose of this solicitation is to invite applicants to propose research addressing one of three categories described below. Under each category, applicants should propose to conduct scientifically rigorous research and/or evaluation studies with an emphasis on informing policy and practice. Applicants should clearly articulate the research questions to be addressed and may propose a broad range of research methodologies to address these questions, including mixed qualitative

and quantitative methods.

Category 1: Research and Evaluations of Legislative and Administrative Policy Changes Affecting Youth Involved in the Justice System

Increasingly, states and localities are incorporating the lessons from research on adolescent development and the effects of intervention strategies into their reforms of juvenile justice policy and practice. [2] To advance understanding of these reforms and their impacts on youth (e.g., youth development outcomes, public safety, collateral penalties) and/or the juvenile justice system (e.g., cost effectiveness), NIJ seeks applications to conduct rigorous research or evaluations of legislative and administrative policy changes under one or more of the following three specified juvenile justice policy areas:

- Providing community-based alternatives to youth incarceration, with a focus on very high need/risk youth who have traditionally been held securely.
- Sealing and expungement of juvenile justice records.
- Reducing racial and ethnic disparities.

Applicants may propose single or multisite research efforts. NIJ is particularly interested in supporting the development of evidence that is broadly generalizable.

Category 2: Research to Assess Dual System Youth Data Capacity and Service Delivery across Juvenile Justice and Child Welfare Systems

Dual system youth are a subset of "crossover youth" — juveniles who have been both victims of maltreatment and engaged in delinquent acts. The dual system youth population consists of crossover youth who have entered, at some point, both the child welfare and juvenile justice systems. For example, a recent study of dual system youth found that at least half of youth involved in the juvenile justice system in selected study sites have touched the child welfare system at some point in their lives.[3]

Under Category 2, NIJ expects to award a single national study to assess the current status and inform future development of functional, linked administrative data capacity and services to better address the needs of dual system youth. Effectively addressing the needs of dual system youth requires: timely, systematic identification; collaborative service delivery across the child welfare and juvenile justice systems; meaningful case management and assessment of service delivery; and evaluation of the impact of integrated service delivery on key life outcomes. Cross- system data integration is crucial for advancement of practices by both the child welfare and juvenile justice systems.[4] Functional linked administrative data is an underlying prerequisite for timely identification of and collaborative service delivery to those youth who have entered (at some point in their lives) both the child welfare and juvenile justice systems.[5]

Under Category 2, NIJ seeks applications to conduct an in-depth national assessment of

dual system youth data capacity and service delivery at the jurisdictional level to advance research, practice, and policy. NIJ is particularly interested in receiving rigorous, mixed-method research proposals that move beyond convenience sampling and reliance on single data collection methods. In proposing research methods, applicants should clearly describe plans for maximizing the scientific rigor of quantitative and qualitative research methods and analysis strategies. Applicants should indicate the strengths and limitations of the proposed project design with detailed discussion of issues related to sample selection, generalizability, and validity.

NIJ encourages researchers to approach this research creatively in order to maximize the utility of the findings in terms of assessing the current status and also informing the future development of functional, linked administrative data capacity and services to better address the needs of dual system youth nationwide. NIJ expects that an interdisciplinary approach will be required to effectively carry out the work envisioned in this solicitation.

Category 3: Analysis on the Use of the Valid Court Order Exception

As originally enacted by Congress in 1974, the Juvenile Justice and Delinquency Prevention Act (JJDPA) prohibited placing youth charged with only status offenses in secure detention or locked confinement. This prohibition is known as the deinstitutionalization of status offenders (DSO) and is one of the core compliance requirements for the participation of states and U.S. territories in the OJJDP Formula Grants Program. [6] "Status offenses" refer to a broad range of offenses that would not be criminal if committed by an adult, such as truancy, curfew violation, failure to abide by parent's rules, underage tobacco and alcohol use, and running away. Under the 1980 and 2018 reauthorizations of the JJDPA, Congress provided an exception to the DSO requirement for a youth who is charged with or has committed a violation of a valid court order (VCO) issued for committing a status offense, such as a probation order requiring a youth to attend school or observe a curfew. A "valid court order" is a court order given by a juvenile court judge to a juvenile who was brought before the court and made subject to such order under proper procedures.[7]

In FY 2021, NIJ issued a solicitation for research to better understand how to effectively comply with the DSO requirements, a under which it funded one project. Additional rigorous research is needed on the VCO exception. While some information on states and territories usage of the VCO exception is collected by OJJDP through its compliance monitoring function (i.e., state's plans to use the VCO exception), research is needed to better understand the impact of the VCO exception on juvenile justice systems, policies, and practices.

NIJ seeks proposals for rigorous research on the use of the VCO exception. Research on service or support alternatives implemented as a result of the VCO exception and their impacts is of particular interest.

Additional Information

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be considered when selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish for further information on high-quality evaluation design elements.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2023.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, and Deliverables

Goals

The goal of this solicitation is to generate and advance knowledge, with meaningful implications for juvenile justice policy and practice.

Objectives

An applicant should address the objectives that are relevant to their proposed program/project in the Goals, Objectives, Deliverables, and Timeline web-based form.

The primary objectives of this solicitation are to support projects that address one of the following three categories: 1) research and independent evaluations of legislative and administrative policy changes affecting youth involved in the justice system, 2) research to assess dual system youth data capacity and service delivery across juvenile justice

and child welfare systems, and 3) analysis on the use of the valid court order exception.

Deliverables

<u>Final Research Report</u>. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's <u>webpage</u>.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, Advancing Racial Equity and Support for Underserved Communities Through the Federal Government

In support of Executive Order 13985, OJP will give priority consideration to:

A. Applications that propose research project(s) that are designed to promote racial equity <u>and</u> the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s)

will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants that demonstrate that their capabilities and competencies for implementing their proposed project(s) are enhanced because they (or at least one proposed subrecipient that will receive **at least 40**% of the requested award funding, as demonstrated in the Budget Web-Based Form) identify as a *culturally specific organization*.

To receive this additional priority consideration, applicants must describe how being a culturally specific organization (or funding the culturally specific subrecipient organization (s)) will enhance their ability to implement the proposed project(s) and should also specify which populations are intended or expected to be served or to have their needs addressed under the proposed project(s).

Culturally specific organizations are defined for the purposes of this solicitation as private nonprofit or tribal organizations whose primary purpose as a whole is to provide culturally specific services to racial and ethnic groups, including, among others, Black people, Hispanic and Latino people, Native American and other Indigenous peoples of North America (including Alaska Native, Eskimo, and Aleut), Asian Americans, Native Hawaiians, and/or Pacific Islanders.

2. Minority Serving Institutions

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

MSIs include:

- Historically Black Colleges and Universities (HBCU)
- Hispanic-serving Institutions (HSI)
- Tribal Colleges and Universities (TCU)
- Alaska Native-serving Institutions or Native Hawaiian-serving Institutions (ANNH)
- Predominantly Black Institutions (PBI)
- Asian American and Native American Pacific Islander-serving Institutions (AANAPISI)
- Native American-serving Non-Tribal Institutions (NASNTI)

Whether an institution is an MSI is based on the original purpose of its establishment or its current enrollment thresholds and is designated as such by the federal government for various purposes under specific statutes. For more information, please see the U.S. Department of Education's <u>definitions</u> and <u>lists of institutions</u>. (The lists are provided for reference purposes only; MSI status is not an eligibility criterion for this solicitation.)

Note: Addressing these priority areas is one of many factors that NIJ considers in making

3. Potential Impact

Applicants may save their progress in the system and revise the application as needed prior to hitting the Submit button at the end of the application in JustGrants.

Submission Dates and Time

The **SF-424 and the SF-LLL** must be submitted in Grants.gov by 11:59 p.m. eastern time on May 29, 2023.

The **full application** must be submitted in JustGrants by 8:59 p.m. eastern time on June 12, 2023.

OJP urges applicants to submit their Grants.gov and JustGrants submissions prior to the due dates with sufficient time to correct any errors and resubmit by the submission deadlines if a rejection notification is received. To be considered timely, the **full application** must be submitted in JustGrants by the JustGrants application deadline. Failure to begin the SAM.gov, Grants.gov, or JustGrants registration process in sufficient time (i.e., waiting until the date identified in this solicitation) is not an acceptable reason for late submission.

Experiencing Unforeseen Technical Issues Preventing Submission of an Application

OJP will only consider requests to submit an application after the deadline when the applicant can document that a technical issue with a government system prevented application submission.

If an applicant misses a deadline due to unforeseen technical issues with SAM.gov, Grants.gov, or JustGrants, the applicant may request a waiver to submit an application after the deadline. However, the waiver request will not be considered unless it includes a tracking number generated when the applicant contacts the applicable service desks to report technical difficulties. Tracking numbers are generated automatically when an applicant emails the applicable service desks; and for this reason applicants are encouraged to email the appropriate service desk, even if they also intend to call the service desk for phone support. Demonstrated understanding of the problem.

- Demonstrated awareness of the state of current research.

Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of proposed project.
- Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- Feasibility of completing the deliverables noted in the solicitation.

Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (20%)

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Potential Impact (15%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/ juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.

Budget (5%)

In addition, peer reviewers will consider and may comment on the following

additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

Other Review Criteria/Factors

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant entity. Among other things to help assess whether an applicant with one or more prior federal awards has a satisfactory record of performance, integrity, and business ethics, OJP checks whether the applicant entity is listed in SAM as excluded from receiving a federal award.
