### Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ) seeks applications for funding of investigator-initiated research examining how observed racial and ethnic disparities in the justice system might be reduced through public policy interventions at any point during the administration of justice for juveniles and/or adults. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States through fundamental research.

This solicitation incorporates guidance provided in the [OJP Grant Application Resource Guide](#) which provides additional information for applicants to prepare and submit applications to OJP for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

**Submission:** Applications must be submitted to DOJ electronically through a two-step process via Grants.gov and JustGrants.

**Step 1:** The applicant must submit by the Grants.gov deadline the required **Application for Federal Assistance standard form (SF-424)** and a **Disclosure of Lobbying Activities (SF-LLL)** form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>. **Submit the SF-424 and SF-LLL as early as possible, but no later than 48 hours before the Grants.gov deadline.** If an applicant fails to submit in Grants.gov, they will be unable to apply in JustGrants.

## Program Description

### Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ seeks applications for funding for investigator-initiated research examining how observed racial and ethnic disparities in the justice system might be reduced through public policy interventions at any point during the administration of justice from two categories of researchers:

1. Category 1: W.E.B. Du Bois Scholars – Researchers who are advanced in their careers (awarded a terminal degree at least seven years prior to December 31, 2022) may apply for grants for research, evaluation, and mentoring of less-experienced researchers.
2. Category 2: W.E.B. Du Bois Fellows – Researchers who are early in their careers (awarded a terminal degree within seven years of December 31, 2022) may apply for grants for research and evaluation.

NIJ will give special consideration to proposals with methods that include meaningful engagement with the people with lived experience of the subject of study; including, but not limited to, justice practitioners, community members, crime victims, service providers and individuals who have experienced justice system involvement.

Applicants are encouraged to propose multidisciplinary research teams to build on the complementary strengths of different methods and areas of subject matter expertise. NIJ also seeks proposals that include consideration and measurement of issues of diversity, discrimination, and bias across age, gender and gender identity, race, ethnicity, religion, and sexual orientation, as applicable.

Applications proposing research involving partnerships with criminal justice or other agencies, should include a letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through an award funded by NIJ will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review [NIJ's data archiving guidance](#). If selected for an award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2024. That formal agreement must include a provision to meet the data archiving requirements of the award.

NIJ seeks proposals that include robust, creative, and multi-pronged dissemination strategies that include strategic partnerships with organizations and associations that are best equipped to ensure that research findings lead to changes in policies and practices related to the subjects of study. Special consideration will be given to proposals that dedicate at least 15% of the requested project award funding toward implementing such strategies, as demonstrated in the Budget Worksheet and Budget Narrative.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients. The applicant is expected to conduct a majority of the work proposed.

### Statutory Authority

Title I of the Omnibus Crime Control and Safe Streets Act of 1968 (sections 201 and 202); 28 U.S.C. 530C.

## Specific Information

W.E.B. Du Bois (1868-1963) was an American sociologist, historian, writer, and editor. As a social scientist, Du Bois used objective scientific methods to promote social change. *The Philadelphia Negro: A Social Study*,<sup>[1]</sup> published by Du Bois in 1899, was a groundbreaking sociological study of the city's African American community. It was one of the first research projects to combine urban ethnography (the study of city life) with social history and descriptive statistics.

From FY 2000 to 2018, NIJ supported the W.E.B. Du Bois Program (Program) to advance the field of research on race and crime in the United States, with funding for fellows who are early in their careers. In FY 2016, NIJ expanded the Program to include a funding category with support for more extensive research projects led by experienced principal investigators (PIs) who could mentor early career researchers. NIJ reinstated the W.E.B. Du Bois Program in FY 2021, focusing on research on public policy interventions that can reduce racial and ethnic disparities in the justice system. We continue this focus in FY 2023.

Racial and ethnic disparities in the justice system have been well-documented in the research literature.<sup>[2]</sup> For example, Black Americans, Latinos, and Native Americans are disproportionately represented in arrest, prosecution, conviction, and incarceration rates.<sup>[3]</sup> In addition, communities of color often experience high levels of crime and victimization.<sup>[4]</sup>

Since President Johnson's Commission on Law Enforcement and Administration of Justice 55 years ago, substantial empirical attention has been devoted to uncovering factors that contribute to racial and ethnic disparities in the justice system, and, to a lesser extent, programs, policies, and practices that might lessen such disparities.<sup>[5]</sup> Studies have examined disparity at all stages of the justice process, from police discretion to arrest, to incarceration, and to application of the death penalty. In addition, special issues of journals have focused on strategies aimed at reducing this disparity.<sup>[6]</sup> Although the call for reform to address racial and ethnic disparities within the justice system is not new, it became more urgent in 2020 with the deaths of George Floyd and Breonna Taylor, which led to massive protests against racial injustice within the U.S. and abroad.<sup>[7]</sup>

NIJ has a long history of funding research on race, culture, gender, and crime and their intersections with the administration of justice, particularly, but not exclusively, through the W.E.B. Du Bois Program. Potential applicants should look at the NIJ website to review projects NIJ has previously funded under this Program.<sup>[8]</sup>

With this solicitation, NIJ seeks proposals for rigorous research projects examining the existing body of evidence to identify policy interventions that have the potential to reduce observed racial and ethnic disparities in the justice system (which may involve primary and/or secondary data collection). NIJ expects the findings and recommendations derived from this research to guide future research and the testing of promising interventions.

NIJ is interested in policy interventions that have the potential to reduce disparities at any point during the administration of justice for juveniles and/or adults. These interventions could include policing practices, access to defense resources, access to justice, pre-trial release practices, charging decisions, sanctions imposed, access to treatment services, post-release programming, or any other point at which disparity is evident. NIJ is particularly interested in identifying those interventions that have the greatest potential to positively intervene in an individual's progress out of the justice system.

NIJ seeks applications for funding from two categories of researchers:

### **Category 1: W.E.B. Du Bois Scholars**

A primary goal of the W.E.B. Du Bois Scholars Program is to grow the field of well-trained researchers

examining the intersections of race, crime, violence, and the administration of justice within the United States. Therefore, Scholars (researchers who have been awarded a terminal degree at least seven years prior to December 31, 2022) must propose a mentorship component to the study that goes beyond hiring graduate and undergraduate students as project staff.

Applications must include a general mentorship plan, with details on how the proposed research will contribute to the mentoring and training of junior researchers, graduate students, and/or undergraduate students by the Scholar and research partners. **This general mentorship plan must be provided as an appendix to the application.**

For mentorship plan approval as part of the grant award process, NIJ will require:

- The curriculum vitae/resume of the individual(s) to be mentored.
- A career development plan for the mentee(s).
- A description of the use of resources for the mentoring enterprise, such as research workspace and equipment, statistical software, and other research support.
- A description of the availability of activities (including classes, seminars, and informal opportunities) for interaction with other scientists or researchers.
- Training in career skills, such as grant-writing and effective presentations.
- A statement that at least one peer-reviewed journal article from the project will be first authored by the mentee(s).

Nominally, a W.E.B. Du Bois Scholars grant project is expected to take 36 months or more to complete and have a minimum value of \$500,000. However, the actual period of performance proposed and funding request will be determined by the research requirements, up to the full 5-years allowed, and the total funding amount anticipated to be available to support this solicitation.

#### **Category 2: W.E.B. Du Bois Fellows**

Prospective Fellows from all social and behavioral sciences, technology, engineering, and mathematics are welcome to apply. Applicants must:

- Possess a terminal degree in their respective field.
- Not have been awarded tenure by December 31, 2022.

NIJ is soliciting proposals for Fellowships from researchers early in their careers to conduct qualitative and/or quantitative research, including secondary data analysis. This category offers talented researchers an opportunity to elevate independently generated research and ideas to the level of national discussion. In this funding category, first-time grant recipients are encouraged to apply. Fellowship applicants should indicate on the cover page of the program narrative that they are applying to the Fellows category of this solicitation.

Nominally, a W.E.B. Du Bois Fellows grant project is expected to take 24 months or more to complete and have a minimum value of \$250,000. However, the actual period of performance proposed and funding request will be determined by the research requirements, up to the full 5-years allowed, and the total funding amount anticipated to be available to support this solicitation.

Applicants under both categories must provide, as applicable:

- A complete description of the data to be used in the study. This narrative should include the number



of cases, complete variable descriptions, data collection method, data format, data source, and the cost of accessing data.

- A description of the justice phenomena that currently results in unwarranted disparity in the treatment of, or outcomes for, racial or ethnic categories.
- A disparity analysis (using existing data) showing evidence of racial or ethnic disparity surrounding the justice phenomena or event to be studied. NIJ is interested in proposals documenting evidence of disparity in the population to be studied and surrounding the specific activity under study.
- A detailed description of the modification or intervention expected to resolve unwarranted disparity and a summary of the literature that the proposed intervention will effectively reduce unwarranted disparity.
- A description of the analytic techniques to be employed and methods of determining success/failure must be provided if the method relies on statistical modeling of the intervention/modification.
- An explicit statement discussing how the proposed research follows the W.E.B. Du Bois Program's tradition of multidisciplinary scientific inquiry and how it will propel the justice research field forward.

### **Additional Information**

Applicants should discuss potential risks and harms to individuals or groups associated with the use and/or misuse of any practice or technology proposed as a part of the research and evaluation, as well as any ethical considerations that may factor into its use. In addition, applicants should be aware of all relevant statutes, regulations, and/or governing judicial decisions (e.g., established case law, prevailing court rulings) related to the practice or technology's proposed use. Any limitations that may impede the lawful use or implementation of any practice or technology proposed should be described, and a realistic approach to mitigate such limitations in the context of the proposed research should be discussed.

### **Evaluation Research**

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that propose evaluation research should also include an implementation evaluation component to ensure that implementation fidelity metrics are collected and analyzed. Applicants are encouraged to propose research methods that enable interim feedback on implementation fidelity to enable program providers to make ongoing improvements in program delivery.

If an application proposes research (including research and development) and/or evaluation, the applicant must demonstrate research/evaluation independence and integrity through discussion of potential risks (if any) to independence and integrity, and appropriate safeguards, as required.

NIJ also encourages applicants to consider the feasibility of including a cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that helps with decision-making. Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention setting, strategies, other contextual factors, and resources should be considered when

selecting an evaluation design.

In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. Applicants are encouraged to review evidence-rating criteria at <https://crimesolutions.ojp.gov/about/how-we-review-and-rate-program-start-finish> for further information on high-quality evaluation design elements.

## **Goals, Objectives, and Deliverables**

### **Goals**

The primary goal of this solicitation is to promote the fair administration of justice. Findings from this research program will assist state, local, and tribal jurisdictions in promoting fairer justice systems and increase the legitimacy of those systems, thus enhancing racial and ethnic communities' trust in public safety. Secondary goals include advancing research methods and growing the field of well-trained researchers.

### **Objectives**

This solicitation aims to: 1) identify policy interventions that have the potential to reduce racial and ethnic disparities in the justice system and guide future research and testing of promising interventions; 2) translate and disseminate research findings to diverse stakeholder audiences to improve practice and policy through science; and 3) build an enhanced capability to conduct rigorous justice research and evaluation projects through the mentoring of junior researchers by scholars advanced in their careers.

### **Deliverables**

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#).

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products. NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The goals, objectives, and deliverables are directly related to the performance measures that show the completed work's results, as discussed in the "Application and Submission Information" section.

### **Priority Areas**

NIJ will give special consideration in award decisions to proposals from Minority Serving Institutions (MSIs).

MSIs include:

- Historically Black Colleges and Universities (HBCU).
- Hispanic-serving Institutions (HSI).

- Tribal Colleges and Universities (TCU).
- Alaska Native-serving Institutions or Native Hawaiian-serving Institutions (ANNH).
- Predominantly Black Institutions (PBI).
- Asian American and Native American Pacific Islander-serving Institutions (AANAPISI).
- Native American-serving Non-Tribal Institutions (NASNTI).

Whether an institution is an MSI is based on the original purpose of its establishment or its current enrollment thresholds and is designated as such by the federal government for various purposes under specific statutes. (The lists are provided for reference purposes only; MSI status is not an eligibility criterion for this solicitation.)

As part of this discussion, applicants should present a review of previous literature and discuss previous research related to these problems.

2. Project Design and Implementation

Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project's goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.

### 3. Potential Impact

Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States. The applicant should include a discussion of the proposed dissemination plan to produce scholarly products and to make information available to broader interested audiences, such as criminal justice practitioners or policymakers.

### 4. Capabilities and Competencies

This section should describe the experience and capability of the applicant organization, key staff, and any proposed subgrantees (including consultants) that the applicant will use to implement and manage this effort and the federal funds under this award, highlighting any previous experience implementing projects of similar scope, design, and magnitude. Applicants should address:

- Experience and capacity to work with the proposed data sources in the conduct of similar research efforts.
- Experience and capacity to design and implement rigorous research and data analysis projects.
- Experience producing and disseminating meaningful deliverables.

Applicants should also outline the management plan and organization that connects to the goals and objectives of the project. Among other factors, that plan should include a description of the anticipated level of effort of key personnel.

OJP will review each waiver request and the required supporting documentation and notify the applicant whether the request for late submission has been approved or denied. An applicant who does not provide documentation of a technical issue or who does not submit a waiver request within the required time period will be denied.

Statement of the Problem (understanding of the problem) (15%)

- Demonstrated understanding of the problem.
- Demonstrated importance of research questions, goals and objectives, including alignment with the aims of the solicitation.
- Demonstrated awareness of the state of current research.

Project Design and Implementation (quality and technical merit) (45%)

- Feasibility of proposed project.
- Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
- Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
- Feasibility of completing the deliverables noted in the solicitation.

Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (20%)

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of "investigator" status) who will be significantly involved in substantive aspects of the proposed project).
- Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

Potential Impact (15%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/ juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.

Budget (5%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

#### **Other Review Criteria/Factors**

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those priority areas already mentioned, if applicable), available funding, past performance, and the extent to which the Budget Web-Based Form accurately explains project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

## Review Process

Applications submitted under this solicitation that meet the basic minimum requirements will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

Pursuant to the Part 200 Uniform Requirements, before award decisions are made, OJP also reviews information related to the degree of risk posed by the applicant entity. Among other things to help assess whether an applicant with one or more prior federal awards has a satisfactory record of performance, integrity, and business ethics, OJP checks whether the applicant entity is listed in SAM as excluded from receiving a federal award.
